2 **Sec. 1. 17-A MRSA §1111-B, sub-§1, ¶A,** as enacted by PL 2021, c. 724, §1, is
3 amended by amending subparagraph (20) to read:

4 (20) Criminal attempt as described in section 152 to commit a crime listed in
5 subparagraphs (1) to (18); ~~and~~

7 amended by amending subparagraph (21) to read:

8 (21) Criminal solicitation as described in section 153 to commit a crime listed in

20 **SUMMARY**

21 This bill amends Maine's Good Samaritan laws concerning drug-related medical
22 assistance by adding possession of a firearm by a prohibited person, unlawful trafficking
23 in scheduled drugs and unlawfully furnishing scheduled drugs to the list of crimes that do
24 not qualify for immunity under those laws.
