13 This amendment, which is the majority report of the committee, replaces the resolve. The amendment increases most reimbursement rates by January 1, 2019 for home health 14 services under the Department of Health and Human Services rule Chapter 101: 15 MaineCare Benefits Manual, Chapter III, Section 40 to 80% of the federal Medicare rates 16 17 for these services. The rates for occupational therapy assistants, physical therapy assistants and speech and language assistants are increased by the same percentage 18 increase as the respective specialists. The rates for clinical social work are increased by 19 30% over current rates. The resolve requires an increase of 30% over current rates. 20 21 FISCAL NOTE REQUIRED
