1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 20-A MRSA c. 114-B** is enacted to read:

3 **CHAPTER 114-B**

4 **INNOVATIVE LEARNING FUND**

5 **§2661. Innovative Learning Fund**

6 **1. Innovative Learning Fund.** The Innovative Learning Fund, referred to in this  
7 section as "the fund," is established in the department as a nonlapsing fund to provide grants  
8 to promote innovative learning strategies to address student achievement gaps.

9 **2. Grants.** The department shall establish criteria to award grants to school  
10 administrative units from the fund. In awarding grants, the department shall give special  
11 consideration to school administrative units that demonstrate instructional partnerships  
12 with professional organizations or companies and partnerships with institutions of higher  
13 education and that provide specific data on closing the achievement gap for economically  
14 disadvantaged students, racial and ethnic populations and students whose learning  
15 achievements were negatively affected due to restrictions during the pandemic related to  
16 coronavirus disease 2019, referred to as COVID-19.

17 **3. Rulemaking.** The department shall adopt rules to implement this section, including  
18 but not limited to rules governing procedures, criteria and priorities for awarding grants.  
19 The criteria for awarding grants must include demonstration that the school administrative  
20 unit is able to implement strategies that use interdisciplinary, project-based and accelerated  
21 learning approaches. Rules adopted pursuant to this subsection are routine technical rules  
22 as defined in Title 5, chapter 375, subchapter 2-A.

23 **Sec. 2. Appropriations and allocations.** The following appropriations and  
24 allocations are made.

26 **Innovative Learning Fund N434**

27 Initiative: Provides one-time funds for grants to school administrative units to promote  
28 innovative learning strategies to address student achievement gaps.

33 **SUMMARY**

34 This bill creates the Innovative Learning Fund and directs the Department of Education  
35 to provide grants to school administrative units to promote innovative learning strategies  
36 to address student achievement gaps. In awarding grants, the department must give special  
37 consideration to school administrative units that demonstrate instructional partnerships  
38 with professional organizations or companies and partnerships with institutions of higher

1 education and that provide specific data on closing the achievement gap for economically  
2 disadvantaged students, racial and ethnic populations and students whose learning  
3 achievements were negatively affected due to COVID-19 pandemic restrictions. The bill  
4 appropriates \$2,000,000 in fiscal years 2023-24 and 2024-25 to provide such grants.
