## An Act Regarding the State Employee Health Commission

Sec. 1. 5 MRSA §285, sub-§1-A, ¶D, as enacted by PL 1997, c. 652, §2 and affected by §4 and amended by PL 2007, c. 58, §3, is further amended to read:

4 D. If terminating employment but not retiring at that time, have 25 years of creditable 5 service under chapter 423, subchapter IV 4 and remain a member of the Maine Public Employees Retirement System, make a one-time election to continue coverage from 6 the date of termination until retirement and pay the cost of the coverage plus the cost 7 8 incurred by the Division Office of State Employee Health Insurance and Wellness in 9 administering coverage under the plan. If a terminated employee who elects coverage under this paragraph fails to pay the cost of coverage and any administrative costs in 10 the amount and manner determined by the division office, the coverage may be 11 cancelled in accordance with the requirements of Title 24 and Title 24-A. Regardless 12 13 of election of coverage or cancellation of coverage under this paragraph, an employee terminating employment as provided in this paragraph may elect coverage upon 14 retirement under paragraph E; or 15

Establishment. The State Employee Health Commission is established to serve as
 trustee of the group health plan in this subchapter and to advise provide counsel to the
 Executive Director of Employee Health Insurance and Wellness and the Director of the
 Bureau of Human Resources on health and dental insurance issues, the state living
 resources program and the Director of the Bureau of Human Resources on other issues
 concerning employee health and wellness and the State Employee Assistance Program.

cast by management. The votes must be cast by the labor cochair who must be chosen by
the labor members, and the vote must represent the majority opinion of the labor members
of the commission, and by the management cochair who is the Director of the Bureau of
Human Resources or the director's designee. Votes of the commission must be unanimous
for action to be taken.

The Commissioner of Administrative and Financial Services has responsibility for the state employee health insurance program through the Division Office of State Employee Health Insurance and Wellness that is established as part of the organization of the Bureau of Human Resources. The division office is headed by the Executive Director of Employee Health Insurance and Wellness. The executive director has responsibility for the daily operation of this program and for the development and maintenance of programs that promote the health and safety of the state employees. Program services must be administered through offices, systems, consultants and staff necessary to provide cost effective, accessible and responsive services to eligible employees and retirees.
 Administration of the program must be consistent with rules adopted actions taken and
 <u>counsel provided</u> by the State Employee Health Commission. The executive director and
 the staff of the state employee health insurance program are appointed in accordance with
 the Civil Service Law.

A reserve fund, administered by the Executive Director of Employee Health Insurance and Wellness and the Director of the Bureau of Human Resources with approval of the Commissioner of Administrative and Financial Services, is created to protect the program from unexpected losses and self-insured losses and related expenses incurred in the provision of health and dental benefits for the eligible participants. The fund is a continuing fund and may not lapse. The Treasurer of State shall invest the fund. All proceeds of these investments accrue to the fund.

The increase in the 24 25 State's total cost for retired teachers' health insurance premiums for fiscal years ending after June 30, 2015 is budgeted at no more than any percentage increase in the Consumer Price 26 Index as defined in Title 5, section 17001, subsection 9 plus 3%. A provider of a health 27 insurance benefit plan for retired teachers must make available data related to the provider's 28 29 premium costs and any related data as requested by the Executive Director of Employee 30 Health Insurance and Wellness within the Department of Administrative and Financial 31 Services.

This bill makes the following changes to the laws governing the State Employee Health
 Commission and the state employee health insurance program.

It changes the name of the Department of Administrative and Financial Services,
 Division of State Employee Health Insurance to the Office of Employee Health and
 Wellness and changes the name of the office head from the Executive Director of Health
 Insurance to the Executive Director of Employee Health and Wellness.

- It states that the duties of the State Employee Health Commission include providing
   counsel to the Executive Director of Employee Health and Wellness and the Director of

the Bureau of Human Resources on dental insurance and the state living resources program.

- 3. It provides that votes of the State Employee Health Commission must be unanimous
   for action to be taken.
- 4. It provides that administration of the state employee health insurance program must
  be consistent with actions taken and counsel provided by the State Employee Health
  Commission.
