Resolve, Directing the Department of Education and Department of Health and Human Services to Study Placing Child Care Facilities in Secondary Schools

Sec. 1. Department of Education and Department of Health and Human Services to study placing child care facilities in secondary schools. Resolved: That the Department of Education and the Department of Health and Human Services shall jointly study placing child care facilities in secondary schools.

- Sec. 2. Purposes of child care facilities in secondary schools. Resolved: That the purposes of a child care facility in the study under this resolve include:
 - A. Providing an on-site training center for secondary school students in child development and child care courses involving the developmental stages of infants, toddlers and preschool children;
 - B. Providing nurturing quality child care and age-appropriate learning experiences in a safe and secure environment for infants, toddlers and preschool children;
 - C. Providing quality child care for secondary school staff and employees during employment hours;
 - D. Creating a source of early childhood educators and caregivers to help reduce the shortage of child care workers in the State; and
 - E. Being organized for and focusing on the needs of children and parents receiving the services and the students, staff and employees of the secondary school.
- Sec. 3. Characteristics of child care facilities in secondary schools. Resolved: That the study under this resolve must study potential characteristics for child care facilities in secondary schools, including:
 - A. Serving children of secondary school staff and employees who are infants, toddlers and preschool children;
 - B. Being staffed by a qualified child care educator who is hired by the school administrative unit of the secondary school and receives full state benefits as an employee of the secondary school;
 - C. Serving as a classroom to provide hands-on experience as part of an early childhood education and development course or curriculum for students in grades 11 and 12, with a certificate awarded at graduation to a student who has completed 2 years of study in the course, including an adult education student under paragraph H;
 - D. Providing child care to children of students and others in the community if space is available once all children under paragraph A have been served;
 - E. Providing child care to children in the community whose family's household income is at or below the federal poverty level;
 - F. Charging a fee for child care, which may be adjusted based upon the income of the parent or guardian of the child, based upon recommendations of the Department of Education, the Department of Health and Human Services and other child care service providers, and accepting a child care voucher or other child care assistance;
 - G. Providing child care for free or at a discount to a secondary school staff member or employee as an employment incentive or benefit;
- H. Operating from 7 a.m. to 5 p.m. on school days, coordinated with the school year, or year-round and on holidays or weekend days or operating in conjunction with adult education students who may receive a certificate under paragraph C; and

I. Determining adequate space, staffing and resources to provide a quality child care service.

Sec. 4. Report. Resolved: That, no later than December 6, 2023, the Department of Education and the Department of Health and Human Services shall submit a report on the study under this resolve, along with any recommended legislation, to the Joint Standing Committee on Education and Cultural Affairs. The committee may report out legislation based upon the report to the Second Regular Session of the 131st Legislature.

SUMMARY

This resolve directs the Department of Education and the Department of Health and Human Services to jointly study placing child care facilities in secondary schools to serve infants, toddlers and preschool children of secondary school staff and employees, and children of students and families in the community if space is available, including families with household incomes at or below the federal poverty level. The study is required to consider the purposes of such a child care facility including serving as a classroom for secondary and adult education students taking child care education and development courses, with a certificate provided for completing 2 years of course work, and characteristics of the child care facilities including charging a fee with a sliding scale for children whose family household income is at or below the federal poverty level, accepting child care vouchers or other child care assistance or providing the child care for free or at a discount to secondary school staff members and employees as an employment incentive or benefit.
