The amendment provides that, beginning in fiscal year 2024-25 and each 4 fiscal year thereafter, the Legislature must increase the percentage of the Maine Maritime 5 Academy's total state appropriation as a share of its total operating costs by 5% until the percentage of the Maine Maritime Academy's total state appropriation as a share of the 6 7 academy's total operating costs equals at least the lesser of the percentages of the University 8 of Maine System's and the Maine Community College System's total state appropriation as 9 a share of each respective system's total operating costs.
