We are writing to provide the recommendations of the Joint Standing Committee on Marine Resources on the initiatives under the committee's policy jurisdiction included in the Governor's Supplemental Budget Bill (LD 2214). These items were considered at a public hearing held on March 1, 2024 and again at a work session held on March 14, 2024. The 8 members<sup>1</sup> of the committee present and voting at the March 14<sup>th</sup> work session unanimously voted in all of the initiatives that fall under the committee's jurisdiction. We have attached the budget worksheet provided by the Office of Fiscal and Program Review, showing members' votes on all initiatives.

Present and voting members also unanimously voted to recommend the inclusion of 4 additional initiatives, to support 4 positions within the Department of Marine Resources (DMR). While the committee would like to see all of these initiatives included, they are ranked below in the order of importance.

#### **Additional Recommendations for New Initiatives**

- 1. Funding for a new Marine Resources Management Coordinator position;
- 2. Funding for a DMR fisheries pathologist position (currently self-funded);
- 3. Funding for a new Marine Scientist I position; and
- 4. Funding for a new Management Analyst position.

We are attaching a memorandum from the Department which includes fiscal information for the above initiatives along with an explanation of why each position is needed. Please let us know if we can provide any additional information or assistance.

#### Justification:

The Department of Marine Resources (DMR) is requesting one-time capital funding to renovate the interior space of the barn, owned by the Department of Agriculture, Conservation and Forestry (DACF), that houses Maine Marine Patrol's Division II offices. This facility requires a substantial renovation, both interior and exterior. DACF is assuming all A&E costs, as well as construction costs for the exterior and structural renovations, and DMR has responsibility for all interior costs. The estimate generated by the A&E work is that the interior work will cost approximately \$280,000. Per your request on how to possibly expedite the application process, I have put together the following list of priority positions. As discussed, aquaculture lease applications move through a "pipeline" and there are opportunities to expand capacity at each stage which would result in improved ability to process lease applications and monitor leases for ongoing compliance.

The process of obtaining an aquaculture lease begins with a pre-application meeting, the submission of a draft application, and a scoping session for the proposal within the community. This phase of the process requires planning and review by DMR staff for accuracy and completeness. DMR does not have dedicated staff for this entry point into the process currently, which is delaying applicants applying for a lease and moving to the next step. A new Marine Resources Management Coordinator would be assigned to foster this initial phase with applicants and help start the process on a strong footing, making later steps in the lease application process more efficient.

**NEW** Marine Resource Management Coordinator position (pre-app, scoping, hearings facilitation) 04-30 PS \$117,952 AO \$10,990

The next step in the Aquaculture Leasing process is the site review conducted by DMR scientists. Currently there are three staff members in the aquaculture science group who are primarily dedicated to conducting site reviews and writing the site reports which are submitted as evidence. They are also required to respond to other scientific inquiries from the public, researchers, and aquaculturists. In 2022, DMR received over 90 aquaculture lease applications, up from about 20 received five years earlier. The existing staff cannot keep up with the demand for site visits and a new MR Scientist I position would enable DMR to better meet this increasing demand and remove a bottleneck at this step in the process.

**NEW** MR Scientist I position (AQ compliance program) PS \$91,207 AO \$10,990

Once applications move through the hearing process there is an enormous amount of administrative work that must be accomplished to fully execute the lease, secure bonds, and receive payment. With an increased volume of applications and other efficiencies created earlier in the pipeline, a new Management Analyst position is necessary to support administrative functions and bring new leases (as well as lease expansions, renewals and amendments) through the final step.

Once leases are granted, compliance becomes a critical ongoing need. The state of Maine currently has 123 standard leases, 32 experimental leases and 715 Limited Purpose Aquaculture Licensed sites. According to state regulation and to remain in compliance with the National Shellfish Sanitation Program which is audited by the US FDA annually, DMR must inspect each aquaculture site at least once a year. Currently, DMR has one staff member to accomplish this work along with responding to numerous public complaints and tracking compliance with payments, lease conditions, and bonding. A new MR Scientist I position is necessary to accomplish this work along with the Senior Aquaculture Inspector position and ensure the legitimacy of the aquaculture program.

Finally, in order for the aquaculture industry to be successful, businesses need to have access to brood stock and juveniles, which often is accomplished through imports and transfers. These activities require special consideration due to possible disease transfer and evaluation of genetic composition. Climate change is also increasing the likelihood of novel diseases in the Gulf of Maine, potentially impacting the existing aquaculture operations and other marine resources. Supporting the existing fisheries pathologist position created in the last biennial budget, with general fund, will ensure the department has the expertise to support the responsible growth of the aquaculture industry and respond to disease issues in wild populations.
