**Public Access Assessment**

The Law and Legislative Reference Library successfully completed its latest Public Access Assessment, a review by the Federal Depository Library Program (FDLP). The Law Library is the only federal depository library currently in the state capital region and maintains a selective collection of Federal legal and other documents provided through the depository program.

During the assessment process, FDLP staff reviewed the accessibility of the Law Library's depository holdings. Topics ranged from how the collection is cataloged and inventoried to whether there are any physical barriers that would keep patrons from accessing the print materials to whether our patrons have access to online Federal resources through our computers. The reviewer found the Law Library "in full compliance" with depository library program requirements and commended the Law Library for maintaining exceptionally high standards for access and service to all of our patrons.
