# **Improved Access To Law Review & Journal Indexes**

The Law Library is replacing the printed *Current Law Index* and electronic *Index* to *Legal Periodicals* with one electronic resource called *LegalTrac*®. *LegalTrac*® provides indexing for more than 1,400 titles including major law reviews, legal newspapers, and bar association journals. It also contains law-related articles from over 1,000 additional business and general interest titles. Some articles are full-text. *LegalTrac*® will be available at all the public computers within the Law Library.

# Full-text access to our recent clippings collection

The digitization of previous years of our newspaper clippings is still ongoing. The full-text database is searchable at our public network. Just select *Search Our Newspaper Clippings* from the list of resources folder displayed on each computer desktop. Coverage includes articles we have in our 2004 and 2005 folders and we are 3/4 of the way through 2006. This allows you to search the full text or author of an article—you no longer have to know what year or what subject heading we have assigned to a clipping, or even what year it was—you can search all the files at once if you wish.

#### A new compiled legislative history

The Law Library staff have compiled a legislative history of the Maine School Regionalization Law of 2007, P.L. 2007, c. 240, part XXXX. The history includes the text of LD 499, its enacted amendments, the Education Committee's proposed amendments, the text of competing bills, as well as any accompanying floor debate, testimony from the public hearings, and Dept. of Education materials presented in support of the regionalization measure. Have you ever looked for credible full-text articles on the web only to find what you need—but they want to charge you for it? *Marvel!* is a state-funded database free to all Maine residents. It includes searchable databases of abstracts and full-text of major Maine newspapers, national and world newspapers, news magazines, and general and academic journals. #### **Group instruction**

The Law Library conducts classes twice a year, in conjunction with the Maine Attorney General's Consumer Mediation division, on Maine legal research and the materials available for the volunteer mediators.

A course on "How to Do a Legislative History" was given for the Maine State Board of Nursing. Attendees were shown how to trace the history of their agency back to its enactment in 1915 and identify any available pieces of information.
