### iResearch Services

The Law Library has a staff of specially trained librarians with many years of experience in researching legal and legislative information. We will work with you to identify and retrieve resources appropriate for your needs. ### The Law Library's Collection

Our holdings include the most current treatises as well as historical works, materials written for the legal practitioner as well as those designed for the layperson. We have legal encyclopedias and dictionaries, all 50 state codes, the Federal document depository collection, and Law Court cases and briefs. Many of our resources are more conveniently accessed electronically than in print, and the librarians can help you choose and navigate the database options on our patron computer network. Most of our materials are cataloged in the University System's URSUS catalog (http://ursus.maine.edu), where our holdings are marked as LEG in the Location field.

### Legislative and Statutory History

Legislative history reveals changes through bill drafts and amendments, debate, and committee testimony indicating matters brought to the legislators' attention during consideration of the bill. Statutory history traces the changes in a particular statute over time, and the legislative



history behind each particular change.

The Law Library has unique resources for investigating legislative and statutory history. We have complete collections of the Laws of Maine back to 1820, legislative documents back to 1868 and earlier, floor debate from 1897 forward, and committee testimony as far back as 1983. Furthermore, our extensive collection of newspaper clippings often provides context for legislative developments.

If the history of a bill or statute is not already covered in one of the more than 50 compiled legislative histories that we maintain, the reference librarians can produce a legislative history tailored to your needs. Please contact the Reference Desk if you wish to know more about legislative and statutory histories.

## Digitized Legislative Record

#### **Historical Legislative Record**

Since 1897, proceedings and debate of the Legislature have been published in the *Legislative Record.* The Records for the House and Senate are prepared and distributed by the offices of the Clerk of the House and the Secretary of the Senate, respectively. Now the Law Library has digitized earlier sessions of the *Legislative Record* and has added the complete historical collection of more than 168,000 pages, including appendixes and indexes, to our website. The contents are arranged by chamber and session day and can be browsed easily by session.
