REPORTS FROM EXECUTIVE DIRECTOR AND COUNCIL OFFICES

Executive Director's Report

Grant Pennoyer, Executive Director, gave the following report.

1. MELD Replacement Project

Despite best efforts by our contractor, the Revisor's Office and Legislative Information Technology, the implementation of the new bill production system has been delayed by some system bugs that need to be resolved before the Revisor's Office is able to fully transitioning to the new system to produce bills and amendments. In the meantime, they have been producing bills and amendments using MELD, the old bill production system. We are still hopeful that the remaining system bugs will be worked out soon so that we may fully transition to the new system and convert those bills and amendments that were developed in MELD into the new system so that we may take full advantage of the features of the new system that includes a more efficient and accurate statute update process that was used to update the statutes after the 1st Regular Session.

2. Benefits Fair

Representatives from Employee Health & Benefits, Maine Public Employees Retirement System, WellStarME (Health Screening), and representatives of the Deferred Compensation Plans will be in the Hall of Flags on the morning of Tuesday, February 4, for a Benefits Fair. The WellStarME staff will also be scheduling appointments for Health Screenings to help meet the requirements of the 2020 Health Credit Premium Program.

Fiscal Report

In the absence of Mr. Nolan, the Speaker directed members to the Fiscal Report included in the packet. Mr. Pennoyer noted that the next meeting of the Consensus Economic Forecasting Commission will meet on January 30, 2020 to begin the mid-session revenue forecast. The Revenue Forecasting Committee has a March 1st deadline for the final revenue forecast, so that the final forecast will be available to the Legislature as it wraps up the session.

General Fund revenue was over budget by \$4.9 million (1.7%) for the month of December and by \$5.8 million (0.3%) for the fiscal year to date. These positive variances now reflect the December 2019 revenue forecast, which increased budgeted General Fund revenue by \$52.7 million for FY 2020.

Individual income tax revenue was under budget by \$4.9 million for the month and by \$4.9 million for the fiscal year to date. Individual income tax withholdings were under budget by \$10.3 million while refunds were over budget (less refunded than budgeted) for the month by \$4.4 million. The withholding tax revenue may be a timing variance between December and January which will be reviewed in more detail next month. Corporate income tax revenue was over budget by \$0.3 million for the month and by \$0.3 million for the fiscal year to date. Sales and use tax revenue (November sales) was over budget for the month by \$5.5 million and by \$1.2 million for the fiscal year to date.

Highway Fund revenue was over budget by \$1.1 million (4.6%) for the month of December and by \$0.9 million (0.5%) for the fiscal year to date. These positive variances now reflect the December 2019 revenue forecast, which increased budgeted Highway Fund revenue by \$3.1 million for FY 2020.

Fuel taxes were under budget by \$0.3 million for the month while motor vehicle registrations and fees were over budget by \$1.2 million.

3. Cash Balances Update

The average balance in the cash pool for December was \$1,571.6 million, a decrease from November's average of \$1,616.1 million but above both last December's average balance and the ten-year average for the month. The average Highway Fund balance of -\$9.7 million in November was down from November's average of \$0.9 million. The negative average balance in the Highway Fund for December was the result of increased expenditures for construction season spending and delays in the availability of federal reimbursements. The balance is now positive and expected to continue to improve with the release of federal funds.

Studies Report

Marion Hylan Barr, Director, Office of Policy and Legal Analysis, submitted the written studies report found in the agenda packet. She also stated that she has posted the last report by OPLA on the website and that the Council should be seeing proposed recommendations from committees in the near future.

Ms. Little provided the committee an update about recent annual training for supervisors, staff and lobbyists. Ms. Little will continue to provide the committee with updates as training for the 2nd regular session continues.

3. Maine Leadership Development Program for Staff Supervisors

Ms. Little and Mr. Pennoyer presented a proposal from the National Conference of State Legislatures to provide a leadership development program for staff supervisors at the Maine Legislature. The committee voted unanimously to recommend that this proposal be presented to the full Legislative Council for their consideration. This item appears on your agenda today and will be discussed momentarily.

4. Merit Increases for the Secretary of the Senate and the Clerk of the House

The committee voted to approve step increases of one-step for both the Secretary of the Senate and the Clerk of the House.

5. Step Increases for Constitutional Officers

The committee reviewed and approved step increases for the two eligible Constitutional Officers.

6. Performance Evaluation and Step Increase – Grant Pennoyer, Executive Director

The committee reviewed the performance of Grant Pennoyer, Executive Director and voted unanimously to approve a step increase for him.

7. Performance Evaluation and Step Increase – Marion Hylan Barr, Director, OPLA

The committee reviewed the performance of Marion Hylan Barr, Director of the Office of Policy and Legal Analysis and voted unanimously to approve a step increase for her.

8. Performance Evaluation and Step Increase – Chris Nolan, Director, OFPR

The committee reviewed the performance of Chris Nolan, Director of the Office of Fiscal and Program Review and voted unanimously to approve a step increase for him.

General Fund revenue was over budget by \$22.1 million (5.6%) for the month of January and by \$27.9 million (1.2%) for the fiscal year to date. Individual income tax revenue was over budget by \$12.2 million for the month and by \$7.3 million for the fiscal year to date. Individual income tax withholdings were over budget for the month by \$6.7 million, while estimated payments were over budget for the month by \$6.2 million and by \$6.3 million for the fiscal year. The withholding tax revenue variance was largely a timing difference between December and January. The combined final estimated payments for December and January were 9.25% higher than the previous year. Corporate income tax revenue was under budget by \$1.2 million for the month and by \$1.0 million for the fiscal year to date. Sales and use tax revenue (December sales) was over budget for the month by \$1.7 million and by \$2.9 million for the fiscal year to date, with taxable sales increasing by 7.5% over December 2018. Transfers for tax relief programs were under budget for the month (less transferred than budgeted) by \$8.7 million for the month. As in previous fiscal years, this variance is expected to be a timing difference, with transfers taking place in subsequent months.

Highway Fund revenue was over budget by \$0.2 million (0.7%) for the month of January and by \$1.1 million (0.5%) for the fiscal year to date. Re: Youth in Government Program

I received a request from Lonney Steeves, Director of the Maine YMCA Youth in Government Program, regarding the scheduling of the 2020 Youth in Government Program. This excellent program has been very successfully using the State House in early November of the last several years and they are asking for the Legislative Council to once again approve the dates for this year's program.

The two weekends that Mr. Steeves is suggesting are November 6th to 8th or November 13th to 15th. Mr. Steeves' preference for scheduling the program would be the weekend beginning Friday, November 13th. According to the Secretary of the Senate and the Clerk of the House, either weekend would work from a staffing perspective and the likelihood of conflicts with legislative work right after the election is negligible. The potential conflict that could arise would be the scheduling of party caucuses shortly after the November 3rd election on either of those Fridays. We do not expect either Friday to conflict with a New Member Orientation that is typically scheduled at least a week after the election.

Therefore, the Legislative Council will need to consider the potential likelihood of any party caucuses being scheduled on either of those Fridays, the 6th or the 13th, and the preference of Mr. Steeves.



Woman Suffrage Marker at State House Proposal

This year, 2020, marks the centennial of most women winning the vote through the passage and ratification of the 19th Amendment.

In recognition of this historic anniversary, the <u>Maine</u> <u>Suffrage Centennial Collaborative</u> (MSCC) is proposing to place a commemorative marker on the State House grounds.

The example at right shows what the marker would look like, though of course the words on the sign would be customized for Maine. MSCC is willing to work with the Facilities Committee and the Legislative Council on the exact language, but it might read something like the following:



VOTES FOR WOMEN

NOV. 5, 1919. THE LEGISLATURE

AFTER A DECADES-LONG BATTLE

RATIFIED THE 19TH AMENDMENT

THROUGH WHICH MOST WOMEN

WON THE RIGHT TO VOTE.

Women's suffrage was one of the most successful political movements in history. Through peaceful protest, over many generations, suffrage supporters at last succeeded in redefining "women's sphere" to include voting and other activities outside the home. Yet we teach very little of this in our schools and there is almost no visible history of women's history anywhere. Nationally, fully 96% of public statues are of men.

To support efforts to promote women's history, the <u>William G. Pomeroy Foundation</u> has generously offered every state at least five roadside markers that can be used to commemorate a site that has suffrage significance. In Maine we've so far nominated three sites/suffragists, two in Portland and one in Lewiston. The signs are made of cast iron and placed on an aluminum pole. Pomeroy would create the sign and ship it and the pole to us at no cost; we would simply need the grounds crew to do the installation. We have control over the wording but not the color or size of the sign. We would work with the Legislative Council on determining the location of the sign on the State House Grounds.

We are eager to get the marker installed during this centennial year. It takes several months for the Pomeroy foundation to complete its review process, and to manufacture and ship the marker, so while there's no fixed deadline we would need a decision from the Legislative Council soon in order to have it installed before the ground freezes in the fall.



Gail Laughlin was one of the first women in Maine to practice law. She received her law degree from Cornell in 1898. Laughlin practiced first in NYC, then in Denver, when women received the right to vote there in 1908. She moved to San Francisco in 1914 where she served on the Republican state central committee, and as a judge for the police courts. She was involved in the women's suffrage movement at the national level, and in 1919 became the first president of the National Federation of Business and Professional Women.

She returned to Maine in 1924, practicing law in Portland with her brother. She was elected to the legislature in 1929, serving three terms. Among the bills she sponsored that became law were measures raising the marriage age from 13 to 16, and preventing husbands from committing their wives to mental institutions based on their testimony alone. She also helped establish the State Department of Health. From 1935 to 1941 Laughlin served in the Maine Senate. She then worked as the first woman to serve as recorder of courts.

Laughlin died in 1952.
