It is also challenging for parents when guiding their college-bound high school senior toward making the right decision. Where to go? How much will it cost? Will you graduate with a job? What will that career pay? How long will it take to pay off the college debt? Maine Educational and Attainment Research Navigation System, otherwise known as Maine EARNs, provides information on employment and wage outcomes for Maine workers who graduated from the University of Maine System and the Maine Community College System after July of 2008. Students, parents, educators, administrators, policymakers, and anyone interested in earning education credentials and employment in Maine, will be able to use this data to research, plan, and make decisions. The system is designed to help families of high school students and people considering entering a job training program or going back to school make informed decisions about real wages people with that degree earn in Maine. This can help students realistically assess how much student debt they will be able to afford to pay back after graduation. This

can help an individual determine how much an investment in a certification or degree program will pay off in terms of higher income for themselves and their families. Many states have a version of this tool. In Maine, the development of this program has been primarily funded by federal grants and 250,000 in General Fund dollars each of the past two years and the current biennium. This investment will have a tremendous impact on the financial future of thousands of Maine students. This also can be used by businesses to see how many workers with certain skills are graduating from Maine's institutions of higher learning. This model is being expanded to include not only University Systems and Community College Systems, but all of these training providers authorized by the Department of Labor for its job training programs. Eventually, private colleges will be able to join the system, as well as other programs that have job training outcomes, like Corrections and TANF. This bill seeks to provide statutory oversight and to recognize the system in the Maine Department of Labor for workforce research and information with a governing structure that includes agencies with federal regulatory authority over the data. I urge you to follow my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Fecteau.

Representative **FECTEAU**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I agree with all the things that the good Representative from Scarborough just stated. I think we just have a disagreement in terms of how we get there. This bill has a lot of merit. The program that is being spoken about has a lot of merit. The issue is the bill repeals a task force that was set up to oversee this information. And that task force has included, and should continue to include in our opinion, two members from the Senate, a representative from the University of Maine System, a representative from the Maine School Management Association, three members appointed by the Speaker as follows; two members of the House of Representatives, a representative from the Maine Community College System, a representative from the Maine Maritime Academy, a representative from private postsecondary education institutions, a representative from the Maine State Chamber of Commerce, a person with expertise in state and national higher education policy, the Commissioner of Education, the Commissioner of Labor, the Administrator of the database and the Administrator's designee, the Chief Executive Officer of the Finance Authority of Maine. We believe that this information and the management of it should continue to be a collaborative effort between all of those folks. And, we believe that this bill would move us in a different direction by putting it solely on the back of the Department of Labor. And that's not what we think is in the best interest of this information and getting this information into the hands of students so they can make worthwhile decisions about their future.

Representative KUMIEGA of Deer Isle moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

The SPEAKER: The Chair recognizes the Representative from Deer Isle, Representative Kumiega.

Representative **KUMIEGA**: Thank you, Madam Speaker. This legislation would prohibit the possession of bait boxes, and plastic bags, and plastic wrappers from frozen lobster bait or frozen fishing bait on commercial and recreational fishing boats. The bill was presented by Representative Devin. I want to read something from the Maine Lobstermen's Association testimony in favor of the bill. "The MLA Board grappled with LD 705's approach to mandate that none of these bait boxes get loaded aboard a boat. There are lobstermen who take the boxes when they fish and dispose of all the waste onshore. However, from the Maine Lobstermen's Association's perspective, having any bait box, plastic bag or strapping go overboard from a lobster boat is absolutely not acceptable. Lobstermen rely on a clean ocean to make a living. The ocean is not a dump. It is a precious resource that we must protect. MLA board members and staff have heard from many lobstermen along the coast that they are concerned about the cardboard boxes and plastic bags [that] they see floating in the ocean. This problem seems to impact all areas of the coast, including our offshore waters." I will note that the MLA is the largest trade group in Maine that represents fishermen that has approximately 1,200 members. MLA staff spoke to management at the Swan's Island Co-op and the Spruce Head Co-op. They both said they had no problem with unpackaging the bait for their members before it was loaded onto boats. The Stonington Co-op, which is in my district, is the largest seller of bait and buyer of lobsters and the largest lobster port in the state. They unpackage all their bait before it's loaded into members' boats. These are co-ops that are run by fishermen. Their Board of Directors are member fishermen. They hire management. So, all the decisions there are made by the local fishermen. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Beals, Representative Alley.

Representative **ALLEY**: Thank you, Madam Speaker. I have a difference of opinion with our person on the other side of the aisle here, and this is to do with the fishermen. It puts the fishermen on the spot. It says, this bill contains similar provisions but applies only to lobstering and crab fishing. So, I think that the gentleman is a little off base here, and the, not the Maine Lobster Union but the Downeast Lobster Union has called me and they are not for this. So, this violation, if you have this plastic on your boat, no plastic is what it says, or cardboard in your boat then the violation of this provision is a civil violation with a fine of \$250. And I think that's just a little bit ridiculous to tack that onto the fishermen who are already paying \$50 a bushel for bait. Thank you.

The SPEAKER: The Chair recognizes the Representative from Boothbay Harbor, Representative Hawke.

Representative **HAWKE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. Littering is already illegal. This bill, if passed, would fine lobstermen for having packaged bait on their boat. The bait comes in frozen and it's very easy to get it from the co-op to their boat and if they don't use it they can sell it back. It's already hard enough for lobstermen and the prices that they are paying that they just don't need this. It's already illegal and a \$250 fine is ridiculous.

The SPEAKER: The Chair recognizes the Representative from East Machias, Representative Tuell.

Representative **TUELL**: Thank you, Madam Speaker. With all respect, I have to disagree with my good friend from Beals today, and I do so because for many reasons. The first one being that this bill has been proposed by folks in the industry, the Maine Lobstermen's Association being one. I've heard from other folks in the industry both on the dock and in the water. But, one that really should stand out besides all of this is the Department of Marine Resources. The commissioner spoke in favor of this legislation and I'm going to attempt to read his testimony briefly again. It reads thus, towards the end: "The Department recognizes that the proposed change in law will require some fishermen to change their current practices. While this will no doubt be a challenge and an inconvenience, we feel strongly that keeping the trash on shore is the only way to be successful in addressing this issue. As we have discussed this concept with members of the lobster industry, we have heard repeatedly that unwrapping bait before fishing is already done at many operations already, including some of our State's busiest co-ops. This demonstrates conclusively that it is possible, and should become the common practice. In their consideration of the bills impacting the lobster fishery at their meeting on February 28<sup>th</sup>, the Lobster Advisory Council"—which includes lobster fishermen from up and down the coast from various affiliated organizations and independent of any organization or trade group—"voted 8 to 1 in favor of the legislation." On that note, Madam Speaker, I strongly encourage you to support the bill before us. Thank you.

The SPEAKER: The Chair recognizes the Representative from Arundel, Representative Parry.

Representative **PARRY**: Thank you, Madam Speaker and Ladies and Gentlemen of the House. I want to agree with my good friend from Beals. As somebody that lobsters every day, when I'm not in session here, we need to work a little bit more on nice days like this not being here so I can be out lobstering. I've never thrown anything overboard like this. No lobstermen that I know of would ever throw anything like this overboard. To make it a civil penalty, several times I've taken full boxes

because I may not use them. Keeps it frozen if it's going to be on the boat for an extra day or two. It's something that we always do and we always bring everything back. We're not throwing any of this stuff into the ocean. So, I really believe that this bill is not necessary. Thank you.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Reckitt.

Representative **RECKITT**: Madam Speaker, Ladies and Gentlemen of the House, sorry if you can't understand me, I am clearly not feeling that great. What you don't know about the various skeletons in my closet perhaps, is that I'm a marine biologist by education. In my entire interaction with the marine biologists, the people who do this work for a living, whether it's lobstermen or fishermen, are generally the ones that regard the environment the highest and I trust them to do this and I'm a little bit upset, or actually fairly upset, that it only applies to lobster and crab fishermen. Frankly, I think we would get rid of the debris if we could get private boat owners to stop doing this. So, I think that they're much more likely to do it, I believe, than lobstermen and crabbers who know that their livelihood depends on the fishery being sound. So, I ask you to vote in opposition to this motion. Thank you.

The SPEAKER: The Chair will inform the House there are six people in queue. The Chair recognizes the Representative from New Gloucester, Representative Espling.

Representative **ESPLING**: Thank you, Madam Speaker. I did hear many concerns about this bill within our caucus and the burden that this would place on folks in the industry. It sounds like a fantastic opportunity for the Lobstermen's Association and the industry groups to do some education with folks on the ground on proper use of some of this packaging material. I'm all for that. I don't think we need to pass a piece of legislation and I would ask for a roll call.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended Report**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Dresden, Representative Pierce.

Representative **PIERCE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I oppose this motion also. When you buy frozen bait in boxes, 40-pound boxes, they don't know if they are going on a tuna boat, halibut boat, lobster boat, or crab boat, so when they're thrown overboard, which I've never seen done actually. All the people that I know that lobster fish, halibut fish, tuna fish are very good stewards of the ocean. They don't want the plastic debris in the ocean. They don't want the cardboard boxes in the ocean. Gloves come in cardboard boxes; they usually buy them by the stack. This bill is unnecessary. We have a littering problem and I agree with the good Representative from New Gloucester, if the Department and the MLA think that this is a problem, they ought to be doing some educational outreach at their meetings they have, monthly meetings, the co-ops. But these guys buy these boxes, they go off shore for 10 days, they might buy 2,000 boxes, they all stick them under the deck and if they have 150 boxes left, which keeps them frozen, they take them back and they put them in the coolers. This is really too bad to single out an individual fishery like lobster and crab fishermen when we all claim we're trying to help them. Thank you.

The SPEAKER: The Chair recognizes the Representative from Rockport, Representative Casás.

Representative **CASÁS**: Thank you, Madam Speaker. Could I pose a question through the Chair?

The SPEAKER: The member may proceed.

Representative **CASÁS**: Thank you, Madam Speaker. So, the original text of the bill talks about lobster fishermen and crab fishermen but the amendment expands it to all commercial and recreational fishermen. And so, I just didn't know if someone could maybe explain the why of why we changed it from what was commercial to commercial and recreational fishermen. Thank you.

The SPEAKER: The Representative from Rockport, Representative Casás, has posed a question through the Chair for clarification. Is there anyone who is able to answer? The Chair recognizes the Representative from Deer Isle, Representative Kumiega.

Representative **KUMIEGA**: Thank you, Madam Speaker. In reference to the question, yes, the bill was expanded to, we felt that it was unfair, the Committee, the members that supported the motion, felt that it was unfair to single out lobster and crab fishermen, and that anybody who's using this type of frozen bait should unpackage it before they brought it out to sea. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Pittston, Representative Hanley.

Representative **HANLEY**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, one of the people, one of the groups of people not mentioned so far on the floor is the recreational fishermen. So, when I take my grandchildren fishing in the Kennebec and I buy Taylor's Worms in a plastic package or I buy some blood worms and they come in a plastic bag, is grampy going to get hauled off to prison or given a summons for taking the kids fishing and having a little of this material on board his fishing boat? Because that's exactly what this bill will do, and I hope that you will follow my light and oppose this. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Collings.

Representative **COLLINGS**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. This was a bill that a Navy veteran brought to me, the concept. He'd been working on it for about a year, and what you see now is the Ought to Pass as Amended. It was worked quite a bit with the Committee, with the Department of Labor, and some staff from the Chief Executive's Office. Basically, what it does is it took out the part about creating a veteran-friendly workplace similar to a business-friendly workplace, at the request of some people who were stakeholders in this. Basically, all it does is it

guarantees that any veteran when they come back, when they've got to go to a VA appointment, it basically guarantees that they can leave work to go to those appointments, and we also amended it further after working with the stakeholders a bit on this. So, when you talk about small businesses, to accommodate them, we changed it so when it's 25 or more employees, they get to go for a paid leave for their VA appointments. If it's 25 or less, then it's unpaid and they have to give 2 weeks of notice. If they don't give 2 weeks of notice, then they don't go. So, we found this to be a very reasonable compromise. I had support and cosponsors from all over the state, in both bodies, from both aisles, and independents as well. And, for really, for all that the veterans have done, I think this is a very simple and reasonable thing we can do when they come back after serving their country. We know what happens when a lot of veterans can't go to their appointments. There are a lot of veterans that aren't going to their VA appointments due to many reasons when they come back from combat. So, this is what this bill really addresses, and I would really hope that everyone in the body could vote for supporting this to let veterans go to their VA appointments. As you know, VA appointments aren't like usual doctor appointments we may set up. They are scheduled months in advance and if you don't go to those you can miss several other accompanying appointments, and you may not be able to go for several months and many issues can come about. So, I think this is a very reasonable bill. It's a very good bill for the veterans in Maine. I know there are some issues that really should be addressed in Washington, that could take care of this, but we can't wait on that. Whatever Washington wants to do is their business, but in Maine, we do right by veterans and I would encourage you all to follow my light on this bill. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Sheats.

Representative SHEATS: Thank you, Madam Speaker and Ladies and Gentlemen of the House. I did not intend to speak on this, so I will be off the cuff. I just want to tell you I did not receive veteran's benefits, although I am a veteran, because you have to be eligible. And there are so many different levels of eligibility and so many different aspects of the VA. But what I can tell you is my husband is eligible. I make my own doctor's appointments. He cannot make his doctor's appointments, they are made for him. If he does not go the day that he is told to go, then he has to reschedule, and it will be months in advance or months beyond. VA problems are not over the care that they give. VA gives excellent care. All of the concerns and all of the questions raised over the VA and the problem over the years has always been access. The problem is getting people to the care that they need and making them eligible. And this is just one more way to get people the access they need. The VA should be solving the problem, but we should be doing everything in our power to help. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative **SANDERSON**: Thank you, Madam Speaker, Men and Women of the House. I rise in opposition to the pending motion. While this bill was very broad when originally proposed, I think it's been narrowed to a reasonable level. If a woman who is pregnant goes to her doctor, that he can report this to the Department of Health and Human Services, so the Department would have an opportunity to provide supports and get them in place prior to a child being born addicted to drugs. We have over 1,000 drug-affected babies being born in this state every year. The Department can't know about this right now until after the baby is born, then the Department is alerted. That, in my opinion, is much too late to be able to get in there and support that mom, so we can, hopefully, have services in place for her, both prenatally and postnatally, to ensure that she is successful as a new mother or perhaps another child. This is a huge problem in our state. I know that some of the argument is, well, people won't get prenatal assistance, people will be afraid of the Department. But I ask you, please, we can lead the way by showing these folks that we've evolved in how we think about drug addiction, how we want to recognize drug addiction, how we want to treat drug addiction, and also how we want to get supports in place for the people who suffer for them, especially our moms who are pregnant. These babies are being born and they're going to have challenges. The moms are going to have challenges because, number one, they do suffer from substance abuse, which is a challenge all on itself. And they are going to be new mothers with all the emotions and hardships that go along with that as well. So, I urge you to vote in opposition to the pending motion. Allow doctors to contact the Department of Health and Human Services so they can get supports in place for these new moms. Thank you very much.

The **SPEAKER**: The Chair recognizes the Representative from Bethel, Representative Head.

Representative **HEAD**: Thank you, Madam Speaker. I rise today, which I don't very often do. But, today, I have a lot I want to tell you. And I'm going to ask you to think about the child born addicted and what they may be facing: birth defects possibly; life-long struggles with learning disabilities and many other number of issues that child could have to face. This bill is intended to get pregnant women help to ensure the unborn child is born healthy and starts their life without coming into the world addicted. Many do not see the value of reporting this problem, but there is a value, a child's health. The argument that the women might not choose to receive prenatal care is of course their choice, but given the fact that they will not be prosecuted, may be incentive enough to delete that fear. And when offered help through their pregnancy, and the possibility they could have a healthy child, might persuade them to accept treatment. The intent of this bill is to help pregnant women bring healthy babies into the world and if it, in the long run, turns that the mother gets the help that she needs, it might change her life as well. If this bill helps to bring even one baby into this world without being addicted, we can be proud. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Calais, Representative Perry.

Representative **PERRY**: Thank you, Madam Speaker and Fellow Representatives. I speak in support of this Ought Not to Pass. Every provider who sees a patient usually does a drug test to ensure that there is a safe environment. Also, as a result of that, they will treat them for this. This already happens, and anybody who is on opiates and addicted to opiates cannot be taken off them, because that then does jeopardize the life of the fetus. They need to be in treatment so that baby can be born healthy. Yes, addicted, but healthy, and then they can work with them after that. Reporting does not change a thing. All it does is report to the state that somebody has a problem. We have diseases that we report to the state so we can follow up on them. This is already being taken care of in the OB/GYN's office and with the providers. This does not do a thing. Thank you.

The SPEAKER: The Chair recognizes the Representative from Durham, Representative Chace.

Representative **CHACE**: Thank you, Madam Speaker. Thank you, Men and Women of the House. I rise today because during the discussion and debate of this in the Committee, what really swayed me was the fact that when these children are born, it's a mandated reporting already. It's mandated to be reported that this child is in this situation. This is where the state comes in and takes baby away from mom, and as far as I'm concerned, the sooner that mother can be taken care of and helped into the, you know, the good Representative from Calais is dead on. These babies aren't guaranteed to not be born free of drugs. They need to be taken care of, they need to be maintained. But, the way they are being reported right now, they become a foster child. In my opinion, let's talk to mom at eight months and get her started and get her in treatment, the state does not want to be the ward of these children. And anything we can do medically up front to take care of that, that is why I am against this motion. I would rather we do the right thing and put this in place. Thank you.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Madigan.

Representative **MADIGAN**: Thank you, Madam Speaker. I want to echo what my good friend, the good Representative from Calais has said. This already happens. All health care providers whether they are doctors, nurses, medical assistants, social workers, psychologists, are already mandated reporters. These reports go into the Department of Health and Human Services. There's a whole protocol, as I'm sure the good Representative from Calais was just about to say, after babies that are opiate exposed. So, every doctor who has a pregnant person who is using drugs, whether that is legitimately, a legitimate opioid prescription or illegal, has them under protocol because it is very dangerous for a baby to be taken off the opiates in utero. So, this is something that already happens. I've worked with women who, obviously, treatment starts in this period because they're going to need help and their children are going to need help. As far as whether the Department takes children away at birth or soon after birth, that does already happen for a number of reasons, drugs and alcohol use is just one of them. But, the reality is all our providers are already mandated reporters and when there is a risk they report, because that's already the law. Thank you.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative **SANDERSON**: Thank you, Madam Speaker, Men and Women of the House. I just wanted to add a couple of things. While there may be some treatment provided by the physician, there's also other services that are

vitaly important to these ladies. What about homelessness, mental health services? Oftentimes, someone who is addicted to, as we well know, oftentimes folks who are addicted to these substances have a lot of other extenuating circumstances. Those are some of the supports that the Department would like to be able to put into place to support these ladies before their child is born, to provide stability before the child is born. Right now, there is no mandated reporting of a mother who is using drugs to the Department. The Department is finding out about these children only after the child is born. So, that's the reason for this bill, is so that they can identify them. This is not punitive. This is to be able to provide help, provide services, provide stability. The mother needs it, the child needs it. Thank you.

The SPEAKER: The Chair recognizes the Representative from Cumberland, Representative Denno.

Representative **DENNO**: Thank you, Madam Speaker. I just want to read a little bit from the testimony of the Maine Medical Association. "We all want to protect children from any drug and alcohol exposure, whether prenatal or otherwise. This bill does not do that. Rather, it potentially creates a serious problem of incorrect reports requiring vastly expanded investigation requirements. At present, the reporting law works, and it works well." And then later in their testimony, "Physicians are deeply concerned that this bill, if enacted, would scare pregnant women away from badly needed prenatal care due to the fear of being reported at the time of such care." In my view, we need to listen to the medical professionals and support Majority Ought Not to Pass motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Hancock, Representative Malaby.

Representative **MALABY**: Thank you, Madam Speaker. I wanted to rise in opposition to the pending motion and perhaps correct a few, I perceive, some erroneous points. We have, within the State of Maine, a program called Methadone. That is a program that is a federal program that does not communicate with the state other than giving the names. They don't reveal if the people are pregnant. We have, historically, I can well remember the incident from four or five years ago, when I met by accident in Hannaford, our then Director of the Office of Child and Family Services, and that person received a phone call about the death of an infant whose mother had been on Methadone, from whom the state did not know. And the infant had passed because of poor sleeping and this happens to us. This is among the reasons we have such a high incidence of infant mortality. We are not intervening with some of these people. We need to do so. The fact that some people on the other side of the aisle would say that doctors report it, well, they do report it when they know. But, if these individuals are being treated for Methadone, their doctor does not know that unless they reveal same. Furthermore, subsequently, unless a well-baby plan is put together, it doesn't happen. I thank you.

The SPEAKER: The Chair recognizes the Representative from South Berwick, Representative Parker.

Representative **PARKER**: Yes, thank you, Madam Speaker and Members of the House. I rise in deep concern over the mothers and the children. And, I question the concern when we have a number of public health nurses going unfilled...

The SPEAKER: The member will defer. The member will direct their remarks to the bill in front of us. The member may proceed.

The Chair reminded Representative PARKER of South Berwick to confine her debate to the question before the House.

Representative **PARKER**: Thank you, Madam Speaker. I will sit then.

The **SPEAKER**: The Chair recognizes the Representative from York, Representative Hymanson.

Representative **HYMANSON**: Thank you, Madam Speaker, Men and Women of the House. The opiate crisis and alcohol use in this state is sad at so many different levels. And one great sadness that we're talking about are babies who are born to mothers who carried them while they used alcohol and while they used other substances. It's a great sadness. Right now, when a baby is born, there is mandatory reporting and while the mother is pregnant, the mother goes to her physician. This bill would require the physician, in its narrowed form, to report that the person is drug-affected, therefore, affecting the baby, a great sadness. What I would like to tell you is that when you actually ask the physicians who are going to take care of these patients what they think of that, they all say no. So, I would like to read a few testimonies from the American Society of Addiction Medicine, Maine's Health Chief Addictions Specialist, and the March of Dimes, and the Maine Medical Association, who are all in opposition to this. "Physicians are deeply concerned that this bill, if enacted, would scare pregnant women away from badly needed prenatal care due to the fear of being reported at the time of such care." So, what I would like to say is that the bill does not say what HHS would do with the information. That is not part of the bill. It's unclear what HHS would do with that information and physicians would have no way to report to their patients that they are going to report them to HHS and what would happen. What do...

The **SPEAKER**: The member will defer. The member will please direct remarks through the Speaker. The member may proceed.

The Chair reminded Representative HYMANSON of York to address her comments toward the Speaker.

Representative **HYMANSON**: I'm sorry. March of Dimes, "Services can cause women to distrust their healthcare and other providers and avoid seeking prenatal care." "Pregnant women who are addicted to opioids often do not seek prenatal care until late in pregnancy because they are worried that they will be stigmatized or that their newborn will be taken away." Maine Health testimony in opposition. This is a physician who works with people who are pregnant, who have addiction disorders. "In my experience as a physician who treats pregnant women with addiction, I fear that if enacted, the bill will result in significant unintended consequences and will worsen the situation." So I wanted to give those quotes to you to let you understand that the very people this is mandating are in opposition to this bill. Thank you, Madam Speaker.

The **SPEAKER**: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
