JOINT RESOLUTION RECOGNIZING MAY 2017 AS JEWISH AMERICAN HERITAGE MONTH

WHEREAS, May is Jewish American Heritage Month, established by the United States Congress to recognize the more than 360-year history of Jewish contributions to American culture; and

WHEREAS, Jewish Americans, in the face of unspeakable discrimination and adversity, have fought tirelessly to realize the promise of the nation's founding and their achievements have enriched the country, stirred our conscience and challenged us to extend the miracles of freedom and security; and

WHEREAS, Jewish Americans have worked to strengthen the promise of religious freedom because their ancestors were tested from the moment they came together and professed their faith, and Jewish Americans continue to teach us empathy and compassion, inspired by their parents and grandparents, who know how it felt to be a stranger, and to stand up for a more perfect union for all; and

WHEREAS, Jewish communities continue to confront hostility and bigotry, including in America; and

WHEREAS, our nation shares an obligation to condemn and combat anti-Semitism and hatred wherever it exists and we remain committed to standing against the ugly tide of anti-Semitism in all its forms, including the denial or trivialization of the Holocaust; and

WHEREAS, during Jewish American Heritage Month, we celebrate the hard-fought progress won through struggle and sacrifice and we rededicate ourselves to building a world where diversity is cherished and faith is protected; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the First Regular Session, on behalf of the people we represent, recognize May 2017 as Jewish American Heritage Month and take this opportunity to urge the citizens of the State to observe Jewish American Heritage Month with appropriate programs, ceremonies and activities.

The SPEAKER: The Chair recognizes the Representative from Topsham, Representative Tepler.

Representative **TEPLER**: Thank you, Madam Speaker. A 360-year history. What I most want people to remember in recognizing May as Jewish American Heritage Month is that like all immigrants and all Americans, except for Native people, we have arrived in this country and become American. I would like to tell a brief story about my family because it is a little different than the immigration story you hear of most American Jews. On my mother's side of the family, our family's ancient name was Abendoná. The Abendonás were from Portugal and possibly from Spain. During the Inquisition, they fled in the 1400s. They fled first to Holland and eventually to England. And they made their way to the City of Philadelphia in the 1770s at the time of the Revolution. They were founders of a synagogue there called Mikveh Israel, which was a Spanish synagogue, and my family is very proud of the heritage and the dating back of our family to the times of the Revolution. So, I would like you to join in celebrating Jewish American Heritage Month and to remember that all of us are immigrants and that our heritage is to be celebrated as an American Heritage. Thank you.

Representative **STEARNS**: Thank you, Madam Speaker. Goulette's IGA has been a landmark in Guilford for many years. March 13, 2017 was their final day of business in the same location since 1960 and the store was reopened as Whitney's Family Supermarket. The Goulette name has been synonymous with store ownership in the area since 1897, when the family moved to Sangerville from St.-Joseph-de-Beauce, Quebec, Canada and opened a candy store. Eventually, that store expanded and became Goulette's Market at Water Street in Dexter for 43 years. In 1953, Gene Goulette opened a grocery store in Guilford. Fire and growing clientele caused the business to move twice in the early years before constructing Goulette's Foodliner, in 1960, which is the present location. In 1977, Gene sold the store to his older brother, Gerald, and the store retained the family name. After renovating from extensive damage caused by the flood of '87, Gerald operated the store until his retirement in '91, at which time he sold it to his sons, Barry and Allen. In 1999, Allen sold his share to Barry who continued to run the store until March 13th, marking the end of an era. Folks in the Guilford area have been fortunate to have such a dedicated community partner for so many years and thank the Goulette family for their many years of serving their community and congratulate Barry on his retirement.

Representative **HAWKE**: I rise in opposition to the pending motion and wish to speak on my motion.

Representative **HAWKE**: I object to the Ought Not to Pass on this. This has been a really hot issue in Lincoln County and it's been filled for the papers and the people want this to pass. The selectmen, the townspeople, their taxes are going skyrocketing and they want some control on it. They don't have control on the schools, so they would like to have control on the commissioners. So, if we can move this along, it's not a state thing, it's just Lincoln County. Thank you.

Since it is the taxpayers who foot the bill so politicians can run for office, it seems only fitting that the law is accurately named. We must never forget it's the hardworking taxpayers who provide every dime the government spends. These taxpayers generally cannot take time off from work to testify in Augusta, have no paid lobbyists, and are sorely underrepresented. So, it's only proper that we remind ourselves at every opportunity where the source of funding truly emanates from. It is from the taxpayers. The proposed name, the Maine Taxpayer-funded Elections Program, more closely reflects what the program is all about. Changing names of programs is not without precedent. In the year 2000, Big Squaw Mountain, here in Maine, was forced to change its name in accordance with State law that required the renaming of all geographic features and locations in Maine called Squaw. There are also many instances nationwide where school mascots and sports teams have been renamed to avoid offending individuals and to

evolve with changing political climate and public opinion. I hope you will support this simple and commonsense measure to change the name to the Taxpayer-funded in the interest of better public policy and more transparency, and vote for the Minority Ought to Pass as Amended Report. Thank you.

Representative **HAMANN**: Thank you, Madam Speaker. I wish to speak to my motion. Madam Speaker, Men and Women of the House, I rise in support of this bill and in opposition to the pending motion. This is a bill that reimagines Columbus Day as an opportunity to celebrate the heritage of our indigenous people. Today, there are many thousands of Native Americans living in Maine. They are descendants of the people who called Maine soil home long before Europeans came to these shores. This was their hunting land, these were their fishing waters, yet we all know the sad chapter and the prologue of the story of America's founding when everything changed after European contact. However, today I want to focus not on past atrocities well-documented by historians, but rather in the reasons why we should celebrate Maine's indigenous people, their culture and traditions, and languages, the beautiful century's old heritage that persists to this day. By voting red on the pending motion, we will establish the second Monday in October as Indigenous People's Day in Maine. This day will provide an opportunity to honor our indigenous people and reflect upon what their contribution means to our state's history. This bill displaces Columbus Day. Christopher Columbus is an historical figure we learned about from grade school; 1492 Columbus sailed the ocean blue. He discovered America, but did he? Surrounding this holiday and the legend of its namesake, we're raised on the myth that simplify and sometimes distort the history of European origins in North America. Christopher Columbus's legacy as an explorer is irrefutable. But at the end of the day, we truly celebrate him for the folklore and whitewashed history that his legend is built upon. Yet, every year on the second Monday in October, we memorialize this myth...

The **SPEAKER**: The member will defer. The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: I guess I would just inquire as to the Chair. Representations are being made by the good speaker in regards to, I guess there's some questions of fact, as regards to what he, in fact, is asserting. And so if, I think, if he wants to talk about the bill and the need to recognize a certain day, I think that's fine, but to go back and try to retrace the history of Christopher Columbus and what's fact and what's not is, I think, a little bit beyond the scope of the bill.

The **SPEAKER**: The Chair's understanding regarding the bill is that it is a renaming of a holiday named after Christopher Columbus. To rename it as a holiday recognizing indigenous people, as such, the Chair would rule that the member's comments are in order at this time. The member may proceed.

Representative **HAMANN**: Thank you, Madam Speaker. Although this history is very well-documented by historians, I'm not interested in rehashing the history of Christopher Columbus and all of the controversies surrounding that and like I said, I'm here to talk about the value of indigenous people in the State of Maine. Christopher Columbus's legacy as an explorer is irrefutable but at the end of the day, we truly celebrate him for the folklore and whitewashed history that his legend is built upon. Yet every year on the second Monday in October, we memorialize this myth and these stories with a state holiday. Meanwhile, our indigenous people who called our ancestors immigrants have no holiday, even though their roots in Maine run deeper than ours. So, let's take this day, one day per year, to honor our indigenous people, their culture, their sacrifice, and their contribution to the American story. Their ancestors hunted in Northern Maine long before it was known as the North Maine Woods. They fished the Allagash, they harvested crops from this soil, they raised children, buried loved ones, created art, built community. They called this earth their home. It was their home. And it's still home for thousands and thousands of Mainers who are their descendants. We all come from immigrants, except for Maine's indigenous people. They deserve this one day per year to be a day where we can all reflect on their struggle, their resiliency, their culture and customs. Their history is worth memorializing. Let's honor the people whose heritage is woven into our national fabric, like the thread that fastens the stars and stripes to our flag. Please join me in voting red on the pending motion. Let's honor Maine's indigenous people by recognizing the second Monday in October as Indigenous People's Day. Thank you.

The **SPEAKER**: The Chair will note there are six people in queue. The Chair recognizes the Representative from South Portland, Representative Reckitt.

Representative **RECKITT**: Madam Speaker. The good news is I don't have written remarks, so I'll be brief. I just want to say that, to me, this bill, which has been surrounded around the periphery with controversy in one school after another as we change mascots here and there, to me, represents a message to the indigenous people in this state, from those of us who are not those people, that we value their contributions to this state. We understand the history here and we appreciate their presence, and we hope to continue to honor that presence in any and every way that we can. This is a bill that costs us nothing and would, in my mind, give us a way to make that message clear to the indigenous people who live here in the state. Thank you very much, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Newcastle, Representative Devin.

Representative **DEVIN**: Thank you very much, Madam Speaker. Madam Speaker, Men and Women of the House, this chamber is short three Representatives: The good Representative from Penobscot, the good Representative from Indian Township, who represents the Passamaquoddy, and the good Representative from the Houlton Band of Maliseets. We need to vote this particular bill, this particular motion down, and embrace our cultural diversity. This body is severely lacking without those three...

The SPEAKER: The member will defer. The Chair will warn the member to be careful about implying any ill intentions for other members. The member may proceed.

The Chair reminded Representative DEVIN of Newcastle that it was inappropriate to imply ill intentions of other members of the House.

Representative **SPEAR**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House, I rise in opposition to the motion. We can't change history but we can change how it is recorded, how it is taught, and how it is celebrated. It is argued that Columbus and other European explorers must be viewed through the lens of their day. That may be true but that doesn't excuse us. We must view them through the lens of today.

Representative **SCHNECK**: Thank you, Madam Speaker. Madam Speaker, Men and Women of the House, I rise in support of the pending motion. Non-compete contracts are agreements between workers and employers that restrict worker's ability to take new employment. Many employers require their employees to sign non-competes. Details of these contracts vary but share a common purpose: restricting the ability of the worker to compete with a current employer for some specified period of time, often in a specified geographic area. This prohibits the worker from taking employment at a rival firm where "rival" may be interpreted quite broadly to include all firms within a given industry. Many people, including members of this body, might be unaware of the existence and impact of these restrictive contracts because low wage and entry-level workers, often straddled with large amounts of student debt, lack the financial resources to advocate for their own rights. In today's job market, non-compete clauses have become all too common in the fine print employees are asked to sign. Potential workers may have accepted a position, resigning from their previous place of employment, unaware that they are required to sign a non-compete until they actually arrive for the first day of work. Furthermore, many workers sign a non-compete without fully understanding the implications. This is supported by a recent U.S. Treasury report, which estimated that 37 percent of these workers are in this position. Compared to other workers, low-wage and entry-level employees are the least likely to have access to employer's proprietary information. They often have minimal or no leverage in negotiating employment terms and do not receive any financial consideration to compensate for the reduction of future employment opportunities elsewhere. Furthermore, it's also crucial to understand that misappropriation of trade secrets is already protected under state and federal law without non-compete agreements. This bill would curb rampant misuse of non-compete agreements, which depress wages, limit economic mobility, and contribute to the plight of much needed young workers in the State of

Maine. This bill exempts low-wage and entry-level workers below 300 percent of the federal poverty level from non-compete agreements. That's about \$31,000 this year. For all other workers except physicians, employers must disclose that a non-complete agreement will be required in the job advertisement. Potential employees, who are asked to sign a non-compete, must be provided with a copy of the agreement at least three business days prior, in order to obtain legal review and have the opportunity to renegotiate terms before being required to sign the contract. In conclusion, hardworking Mainers are going to work each day trying to make a better life for themselves and their families. Forcing them to sign non-compete agreements makes it harder for affected workers to continue down their career path and stay employed. These agreements stifle fair competition and harm workers. We should take the opportunity to end this practice and protect our workers. I urge you to follow my light in support of this bill to advocate for Maine workers and their families and particularly young workers who are so vital to Maine's future economic growth. Thank you, Madam Speaker, and I request a roll call.

I think it would only add confusion to the process and I'm going to ask that you vote against the pending motion, and Madam Speaker, I ask that the Clerk read the Committee Report.

In fact, it was so bad that in 1999 the Legislature stepped in and passed a law to make them stop it. You can look it up. It's Title 26, Section 599. I'll wait, go ahead. Seriously. Specifically spelled out that the abuse was so bad that it was being prevented in statute. That actually saved my bacon and my entire announcing staff. We had just been purchased by a large out-of-state corporation based out of Atlanta and I was instructed to sign my entire staff to a non-compete clause with no compensation whatsoever. And we all knew what that was about. It was to depress our wages, to underpay us, and to keep us from going across town with the competition. Thanks to that law, I was able to say (raspberry) and I'm looking forward to reading the record of today's debate to see how they spell (raspberry). But, seriously, I am disappointed to see this abuse is now being forced on low-income Mainers, and I ask this body to do what it did back in 1999 and say stop it. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Sylvester.

Representative **SYLVESTER**: Thank you, Madam Speaker. I think I may have pressed my button in error but I'm going to speak anyway.

The **SPEAKER**: The House will be in order.

Representative **SYLVESTER**: This is a really good bill and it's a good bill for two reasons. One is non-competes certainly have their place with professional employees. Professional employees that have trade secrets, professional employees who are involved in developing strategy. You know, perhaps in those venues that's important. In venues where sandwich makers, where folks who are like my employees who are renting golf carts are being asked to sign a non-compete, in most part because corporate policy just decides that if one person should sign it everybody should sign...

The **SPEAKER**: The member will defer. The Chair recognizes the Representative from Dixfield, Representative Pickett, and inquires as to his Point of Order.

Representative **PICKETT**: Thank you, Madam Speaker. Would the Speaker please ask the good Representative to address the Speaker and not this side of the aisle? Thank you.

Is that where we want to go or do we want to protect the workers? I appreciate everyone's due consideration and I would ask that you support this Ought to Pass motion.

The **SPEAKER**: The Chair recognizes the Representative from Yarmouth, Representative Cooper.

Representative **COOPER**: Thank you, Madam Speaker and Ladies and Gentlemen of the House. Non-compete clauses and contracts may be common but they are not fair, particularly when we are talking about low-level employees who really do not possess the kind of information from their time during their employment that would pose a risk of any sort to the employer who imposes that restriction. What is really at stake here is that these provisions are what they call in the law, contracts of adhesion. In other words, you really are stuck with them. Because the employer has all the power and the employee has none except the right to go to court, which, in reality, is impossible given the expense of such a proceeding. So, all we're trying to do in this bill is to make the playing field more level. Thank you.
