Representative **FOLEY**: Madam Speaker, Ladies and Gentlemen of the House, I rise today to honor my colleague, my business partner, and my dear friend, Jeff Cole.

Jeff passed away suddenly and unexpectedly several weeks ago, leaving a void in our community and our business and our lives. Jeff was a community organizer, not from a political sense but from a community perspective. If there was something that needed to be done, Jeff was always there, quietly making sure that those things happened. Whether it was his time as the volunteer for the Kennebunk/Kennebunkport Fire and Rescue, serving on the boards of the public library, Brick Store Museum, the school board, or organizing a local road race, Jeff always strove to make a positive difference in all that he did.

Jeff was larger than life, sporting a joyous smile, an infectious laugh, a good story and countless words of encouragement for those who were fortunate enough to know him, to work with him, to call him a friend. I recall a story of a time when Jeff's church was planning a mission trip for their young parishioners to help out a poor community. They raised all the funds needed to make the trip but found late in the process that they all needed to bring their own sleeping bags. Upon hearing this news, Jeff quietly went out, purchased all the necessary sleeping bags and dropped them off at the church, with a note that said, "Please leave these sleeping bags for the homeless upon your return." No fanfare, no need for recognition, just doing what was right.

While we will all miss him terribly, I know in my heart that Jeff had set the right course for his business, his community, his family, and his many friends. I said to a friend, after learning of Jeff's passing, that it reaffirms what we all know but often forget: our time on this earth is unknown, but what we do here is important. Jeff filled his life with important things. He fought the good fight, he finished the race, and he kept the faith. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Kennebunk, Representative Babbidge.

Representative **BABBIDGE**: Thank you, Madam Speaker. Jeff Cole owned an insurance agency that was an intergenerational institution in the town of Kennebunk. Jeff himself was very active as a school board member, as a firefighter, and with other institutions in town like the Kennebunk Free Library and the Brick Store Museum, of which we're very proud. I am honored to rise to add my words of congratulation and appreciation to David LaFountain for his 40 years as a firefighter, and ultimately, as the fire chief in Waterville and Winslow. We all wish him the very best as he retires and enters this new phase of his life.

Representative **THERIAULT**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I wasn't planning on speaking. I didn't realize he was coming today, but knowing he's in the building, I feel I must.

I've worked very hard with David in the past, many, many years of training and calls together, and he has been a very good inspiration to me because he was a chief before I was, and I have looked for some guidance through him. Representative BERRY of Bowdoinham moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

The SPEAKER: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Madam Speaker. Madam Speaker and Men and Women of the House, this bill asks us a very simple question; should we as a body give taxpayer dollars, Maine taxpayer dollars, to corporations that sell the data of Maine citizens, Maine families, Maine people of all ages without their express consent? If our answer to that question is not a resounding no then I don't know what in the world has come over us.

Madam Speaker, Women and Men of the House, in some respects I would argue that our friendly neighborhood internet service provider knows more about us than we know about ourselves. The oracle at Delphi says "Know thyself" over the entrance to the building to the temple of Apollo. And that's good advice, to know thyself, and it's not easy. I try hard to know myself, but as hard as I try, Madam Speaker, my wife seems to know me better than I know myself. But, Madam Speaker, there is someone, many someones, actually, and they're not just here in Maine, who arguably know more about us and our family members than we know about ourselves. These omniscient oracular beings have names like Comcast and Spectrum, Consolidated and Verizon, AT&T and US Cellular. Because they are the pipes of the internet, they know what flows through those pipes. They know when you're on Facebook and they know when you're on Google. They know when you and your family members went to bed last night, and they know when you got up this morning. They know which websites and web pages you and your children and grandchildren have visited over the past several years, how many times you visited, and for how long. They know this whether you and your family used a so-called private browser to visit those pages or whether you did not.

Madam Speaker, the bill before us had an impressive hearing, and there were many Maine-based internet service providers who testified in favor of the bill. There were many individuals from Maine who testified in favor of the bill. We heard support from Senator Garrett Mason, we heard support from the good Representative from Glenburn, who I'm sorry is not here today to speak to this bill, I know she cares about it. The bill was scaled back significantly by the Committee

because of concerns about what was certainly within Maine's purview and what perhaps might not be, and we settled on a bill that only required that if you're going to take Maine taxpayer dollars, Madam Speaker, that you will honor your commitment as an ISP to protect your customer data, to not sell or share their information without the user's consent. And, Madam Speaker, fortunately, the internet service providers I've spoken with all say they do not share or sell your data without your consent. They've showed us policies to support that; and yet, they oppose this bill. Not the Maine-based internet service providers, mind you, but the others. Why is that? How could that possibly be?

We have on our desks today a letter from a certain Chamber of Commerce of which these ISPs are members, stating that the sky will fall and there will be no tourism in Maine if we hold these ISPs to their own commitments, to their own policies. I don't see it. They're going to continue to do what they've always done, and the sky will fall and we won't have tourism in Maine? I don't see it.

Madam Speaker, I want to ask the opponents of this legislation: can you find me, please, one voter, one honest-to-goodness, flesh-and-blood constituent, unaffiliated with a multinational internet service provider or a business organization they belong to, who does not support this legislation? Because I've tried, Madam Speaker, and I've come up short.

Madam Speaker, we and our children are spending more and more of our lives online, and we can choose our platforms, we can choose between Twitter and Facebook and Instagram, but we cannot choose the pipes. We need a pipe in order to use the internet. This bill merely asks the internet service providers to honor the commitments they've already made to not sell or share customer data without consent. It asks whether we, as a body, should give Maine taxpayer dollars to corporations that sell the data of Maine citizens, Maine families, Maine people of all ages, without their express consent. I think our choice today is clear. I think our support for this bill should be unanimous in this body and, Madam Speaker, when the vote is taken, I request that it be by the yeas and nays.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended Report**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Hiram, Representative Wadsworth.

Representative **WADSWORTH**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. Internet service providers actively protect consumers' private information. There is a market incentive to do so, as violating one's privacy would deter customers, and federal law is in place that requires all actors in the communications space to guard personal information. The status quo allows bad actors to be punished by the FTC and State Attorney General while still promoting competition and innovation in the industry. LD 1610, on the other hand, would do neither. This misguided privacy rule would zero in on who holds consumers' data rather than the data type, applying onerous and costly regulations to ISPs only. Admittedly, this is a pretty bizarre approach to take if protecting one's privacy is the intent. Compared to individual websites, for example, ISPs see far less of what you do online. That is because over 70% of the websites use HTTPS encryption. An ISP can only see which website you visited, not what you do on the websites. ISPs do not know your movie

preferences, product purchases, email content, or anything of the like. In the light of these truths, state-level privacy laws such as LD 1610 are completely unnecessary. In fact, they would be a huge mistake. The cost of consequences of complying with a patchwork of many state privacy laws throughout this country would make it more difficult for ISPs to maintain and expand their service and invest in the next generation of broadband. Consequently, LD 1610 would leave Mainers with fewer choices, outmoded technology in an overall quality of internet. In addition to harming consumers, LD 1610 is likely to result in negative consequences for the taxpayers in Maine. Legislation or executive orders that attempt to regulate privacy through procurement or contractors violate federal law. As such, LD 1610 would likely result in millions of hard-earned taxpayer dollars being wasted on costly legal challenges. If implemented, LD 1610 would stifle innovation and allow government to pick winners and losers in the communications space, while doing nothing to improve the consumer privacy. Please oppose the pending motion.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Sanborn.

Representative **SANBORN**: Thank you, Madam Speaker. This bill is very timely, as we've seen internet privacy splashed across the headlines, the two days of testimony from Facebook's Mark Zuckerberg in front of Congress earlier this week. But let me be very clear; the bill before us does not regulate Facebook. Instead, it regulates something even more fundamental, the internet service providers, or ISPs, who allow us the very access to any part of the internet. And even more than that, this bill would regulate only ISPs that want to receive contracts paid for with state taxpayer dollars. These internet service providers operate in the background all the time that we are connected to the computers that are connected to the internet. I'm old enough to remember a time when our computers were not always connected to the internet. I can remember the telltale sign of connecting to the internet that your modem made when you dialed up, that strange beeping noise that let you know that you were now connected to the rest of the world. But, Madam Speaker, at this point, we're always connected to the rest of the world.

Our internet service providers are listening in all the time, and we don't think about them at all except for when we pay our monthly invoice for the service. And, so, here's the analogy that I'd like you to think about. We would not be okay with allowing our phone lines to have a tap on them at all times, recording every word out of our mouths, and then having that data sold to the highest bidder, whoever wanted to pay for whatever use. We would require, instead, that some court process be followed before that type of tap were allowed, and that the information be fiercely guarded. And, Madam Speaker, it's no different with our internet service providers. We cannot allow all of the traffic on the internet to be sold to the highest bidder, and we must regulate Mainers' privacy in the way that we can, with the bill before us. Thank you.

The **SPEAKER**: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

Representative **MOONEN**: Thank you, Madam Speaker. Madam Speaker, Women and Men of the House, this bill came to our Committee because of a problem that has resulted from disagreements between two of our state's officials, and I want to be very clear that I am going to try not to impugn the motives of either one of those officials and just talk about the bill. So, we passed a budget for the Attorney General's office last year that includes a whole bunch of positions that we viewed as a priority, this Legislature passed it, the Chief Executive signed it; and unfortunately, there are a lot of hiring justification forms and financial orders currently sitting on the desk of the Chief Executive that are not getting signed and not allowing us to fill these positions. Those positions include one, two, three -- seven positions that would work in District Attorneys' offices around the state, an AAG position that would work on child support enforcement, a Medicaid fraud prosecutor, a welfare fraud prosecutor, licensing enforcement positions, all kinds of positions in the Attorney General's office and in our District Attorneys' offices that are important to the people of the State of Maine, and positions that do good work on behalf of the people. And, I certainly understand that there are tensions between these two individuals regarding financial orders and how all of that works, but at the end of the day, my view on this is that these positions are important. We need them filled so that the work of the people of Maine can get done, whether it's child support prosecution, welfare fraud, whatever it is.

So, the Majority Amendment on this bill is fairly simple. It took the language that already exists for the Judicial Branch and the Legislative Branch and mirrors that for the Attorney General's office and their statute. Under current law, the

Legislature does not have to send our financial orders to the Chief Executive. I'm really grateful for that, because I think if we did we would never get paid. We... In addition, the Judicial Branch does not have to send their financial orders to the Chief Executive. It's really about separation of powers, and because the Attorney General's office is independent of the Executive Branch, it was the view of the Majority Report of the Committee that it made sense that they also have the independence to move forward on their financial orders, just as the Legislative Branch and the Judicial Branch do. So, that's what the amendment does. It authorizes the Attorney General to approve financial orders affecting the office of the Attorney General, and that's it. Thank you very much, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Fredette.

Representative **FREDETTE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I'm actually a little speechless, because I think I just heard the good Representative identify the Legislature and the Judiciary as two branches of government, but now evidently we would like to make Attorney General the fourth branch of government, so that her financial orders do not have to be signed. I'm going to be objecting, voting no on this, and I request a roll call.

Representative **BRADSTREET**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I rise in opposition to the pending motion. It's an improper intrusion into the separation of powers. It certainly is, and it usurps the Chief Executive's proper authority and prerogatives. And, I'd like to also say that last year 35 financial orders were issued, 14 so far this year, and five are outstanding. Thank you.

The SPEAKER: The Chair recognizes the Representative from Kennebunk, Representative Babbidge.

Representative **BABBIDGE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, for me this is about responsible government. Our constitutional officers and our chief executives come and go, but the folks that we hire to staff our state government are very, very important, and sometimes have long careers. When we have somebody that is a gem that is willing to give up their private practice to come to public service, and that opportunity is lost because of a period of months that we're waiting, then this state is not well-served. So, I'm looking for good government here, and the Chief Executive's approval of these financial orders has in the past been one of formality, one of communication, one of, yes, it's in the budget, great, go ahead. But, because we've had this impasse, the state has not been well-served, and I think we can improve on that. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Wilton, Representative Black.

Representative **BLACK**: Thank you, Madam Speaker, Men and Women of the House. I rise in opposition to 1844. This bill is yet another attack on the tree growth taxation law. LD 1844 is no longer about foreign investors. It affects every landowner and every land sale in Maine greater than 5,000 acres. It takes away landowners' rights without compensation. Major landowners share their land with the public, provide wildlife habitat management, support an \$85 billion forest

economy and create jobs across Maine. They just want to be treated fairly, and LD 1844 attacks their livelihood. Thank you, Madam President.

The SPEAKER: The Chair recognizes the Representative from Knox, Representative Kinney.

Representative **KINNEY**: Thank you, Madam Speaker, Men and Women of the House. I rise in opposition of the pending motion. This bill allows the State of Maine to have right of first refusal on private property sales over 5,000 acres in tree growth. This will result in entitling encumbrances on privately owned property. One concern brought up in favor of this bill was because the state was not making the proper payments to municipalities based on tree growth rules. There's no guarantee the state will make their payments in lieu of taxes if they use their right of first refusal to purchase this land. I question that if this is already a problem, why give the state more authority over private land?

Another issue that was brought forward is the possibility that Maine's lumber mills will not have sufficient timber to remain operational without this bill, but the reality is the mill capacity in Maine has diminished over the years to the point that when - that's when, not if - the spruce budworm arrives in Maine, these mills will not be able to handle the timber harvest when that outbreak arrives. I urge you to follow my light and vote in opposition to the pending motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lincoln, Representative Hanington.

Representative **HANINGTON**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. May I pose a question through the Chair?

The SPEAKER: The Representative may proceed.

Representative **HANINGTON**: Could someone on the Tax Committee tell me how much tax that you're going to lose that goes into fighting forest fire if this is taken off the tax rolls?

The SPEAKER: The Representative from Lincoln has posed a question, if there is anyone in the Chamber who cares to answer. The Chair recognizes the Representative from Gardiner, Representative Grant.

Representative **GRANT**: Thank you, Madam Speaker. In response to the Representative's question, I must say that I, in fact, think this bill should have gone to the Taxation Committee, and I actually can't answer his question but I feel I should be able to answer his question.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Doore.

Representative **DOORE**: Thank you, Madam Speaker. Can anyone in this body tell us, or tell me at least, how many owners own 5,000 acres or more here in the State of Maine?

The SPEAKER: The Representative from Augusta, Representative Doore has posed a question through the Chair if there is anyone in the body who is able and willing to answer. The Chair recognizes the Representative from Eagle Lake, Representative Martin.

Representative **MARTIN**: Thank you, Madam Speaker, Members of the House. I hate to use a little history here, but tree growth is a legislation that I actually sponsored when I was in my second or third term in the Legislature, and the purpose of tree growth was to try to keep Maine woods operative and not being sold off by bits and pieces. The purpose of the legislation that you have before you simply says that when land is being sold that the state has a right to first refusal. And, so, in fact, there won't be any money lost to the State, because obviously someone else will be paying for it. The whole question -- and the Maine Forest Products Council has decided

that they oppose this bill, which is already contrary to the people I represent. And so I urge you to vote for the bill.

The SPEAKER: The Chair recognizes the Representative from Durham, Representative Chace.

Representative **CHACE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. If I'm not incorrect on tree growth law, if you purchase property in tree growth, you are required to maintain it in tree growth, and if you do not maintain it in tree growth, you'll pay penalties that can be quite significant. I just wanted to add that to the debate. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Collings.

Representative **COLLINGS**: Madam Speaker, Ladies and Gentlemen of the House, I would urge you to vote for this bill and support Maine jobs in Maine mills in a rural economy. Thank you.

Representative HYMANSON of York moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

The SPEAKER: The Chair recognizes the Representative York, Representative Hymanson.

Representative **HYMANSON**: Thank you, Madam Speaker. It's time that we re-looked at the medical marijuana or medical cannabis program. The reason is because of the adult use program which is coming on board. It's been a long time since we looked at it, and there's been leakage into the black market from the program.

So, I want to remind you that cannabis contains chemicals that treat certain disorders, and over time, we in the medical community are learning more and more about those chemicals. So, the ones of note are CBD and THC, and those are chemicals -- CBD does not produce euphoria or make anybody high, so it is an extractable medication from a plant that has properties that also have psychoactive properties that make people high. So, the goal was really to create a program or look at the program so that it became a real medical program,

and honored the medicinal properties of cannabis. If you'll remember that willow bark has aspirin in it, digitalis -- or, foxglove plant has digitalis in it, which slows the heart rate. So there are many common plants that are all around us that have true medicinal properties that have been made into pharmaceuticals, that we take for granted on the shelves. The problem with cannabis is that it has a component that has psychoactive properties that make people high, and so that has been a deterrent to exploring the real true medicinal properties of cannabis.

So, with the opportunity to take away the adult use -- to take away adult use from this, we wanted to create a medical program that really honored that. So, our process was to form a subcommittee in HHS. We worked more than 50 hours over the last three months. We worked with many stakeholders to come to consensus. So, this bill does a number of things. This is not the whole list, but I'll review some of the things it does. Number one, it acknowledges the physician or physician assistant or nurse practitioner role in the patient relationship, and I personally really started at that level with honoring the provider-patient relationship, and so there is a bona fide relationship in order to receive -- that has to occur in order to receive a certificate to obtain medical cannabis, and there are limits regarding pediatric use. It professionalizes the caregiver, who are the people who grow and sell medical cannabis. It tightens up accountability. It reduces the opportunity for diversion to the black market, because there is now a seed-to-sale tracking. That means every single plant is tracked. It allows for municipal control, and I'll emphasize that municipal control was not there before. We worked very hard with the Maine Municipal Association to put in language that allows for appropriate municipal control. It regulates potentially explosive extraction process for safety, and it allows for local control in facilities where patients might be using it. So, I hope that you can support this with me. Thank you, Madam Chair.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Sanderson.

Representative SANDERSON: Thank you, Madam Speaker, Men and Women of the House. It's a pleasure to follow along behind my colleague on the Health and Human Services Committee, the Representative from York, Representative Hymanson, and she's correct. Our Committee did set a subcommittee aside, and we did a really deep dive into this program. Back in the 125th, there was a bill that I sponsored, which really did a lot of work with the program. It was a big bill. It corrected some of the things that had happened after the citizens' initiative that the industry or folks in the industry were unhappy with. And since that time, we've had several bills that have either made small additions to, little tweaks to, but there really hasn't been any big substantive changes or a really deep dive in restructuring of this program since that time.

Last fall, I was approached by some folks who are caregivers in the industry, and they brought forth this bill and asked me to sponsor it, and what it did was it had taken a look at where we were in the legislation from the 125th, where we were now, and really with an acknowledgment of, after all these years seeing how the program has worked, seeing how access to patients has either worked or not worked, understanding that, with greater oversight, this program can have greater integrity and, you know, more legitimacy for those who may not believe in this program out in the communities. You know, they brought forth these efforts. You know, they wanted to say okay, we're okay with the inspection process. So we put an inspection process in here, and all they asked in

return is that there's a clear, you know, list of what the inspection process will look like so that they know what is expected, so when they are inspected without a prior notification, they know what is expected of them. There will be no gray areas, no ambiguity. They have also asked for other things to help improve patient access, and I think that's -- I think that was a real legitimate ask, because they are serving a large number of individuals in our state who have gone through the gamut of trying to use standard pharmaceuticals, and they just have not worked for them or have not worked as well; or maybe they have worked, but they have found that cannabis is working better for them, without maybe some side effects.

So, this bill was a huge amount of work, and as the good Representative from York said, it tightens -- it allows for municipal regulation. There was none over caregivers before. It allows for an inspection process. There was none over caregivers before. It also sets up manufacturing facilities and provides legislation for that. We worked really hard to make sure we were looking at what was happening down in the Committee at the other end of the Cross Building, in the MLI Committee, and what was happening with the adult use bill. We made sure that, you know, although hopefully there won't be anything that's in conflict, we've really tried to make sure that everything would fit seamlessly with that, mirroring language and making it the same. I think this bill was a fine example of real bipartisan work, people rolling up their sleeves, talking to folks in the industry, legislators coming together, looking forward to what was the best for Maine people who needed to access medical cannabis as their medicine and their preferred form of treatment. So, I hope you will all support this bill all the way through to the end. I think it's a really important day for this program. Thank you so much.
