Amend the bill by striking out all of the emergency preamble (page 1, lines 1 to 9 in L.D.)

Amend the bill by inserting after section 1 the following:

Sec. 2. Requests for transfers for costs incurred. Notwithstanding any other provision of law to the contrary, executive branch departments and agencies may request transfers from the Salary Plan program for the additional General Fund and Highway Fund costs incurred as a result of the additional unemployment benefits authorized by this Act.

Sec. 3. Appropriations and allocations. The following appropriations and allocations are made.

SUMMARY

This amendment, which is the majority report of the Joint Standing Committee on Labor, strikes the emergency preamble and the emergency clause from the bill. The amendment also provides funding for the estimated cost of the expansion of unemployment insurance benefits for state agencies that must directly reimburse the Unemployment Trust Fund and adds an appropriations and allocations section to the bill.
