### SUMMARY

2 This amendment establishes the Task Force To Study the Coordination of Services 3 and Expansion of Educational Programs for Young Adults with Disabilities. The membership of the task force consists of Legislators who serve on the joint standing 4 committees of the Legislature having jurisdiction over education and cultural affairs, 5 health and human services matters and labor and housing matters, the Commissioner of 6 Education, the Commissioner of Health and Human Services and the Commissioner of 7 Labor and members of organizations or associations knowledgeable about services for 8 young adults with disabilities after high school. The Commissioner of Education 9 10 convenes the task force, which must hold a minimum of 4 meetings and submit a report to the joint standing committees of the Legislature having jurisdiction over education and 11 cultural affairs, health and human services matters and labor and housing matters on 12 recommendations and targeted reforms to improve the efficiency and effectiveness of 13 services provided by different agencies and continuing educational opportunities for 14 young adults with disabilities after high school. 15
