## An Act To Clarify and Correct Maine's Fish and Wildlife Laws

- 1 Be it enacted by the People of the State of Maine as follows:
- 2 Sec. 1. 12 MRSA §10001, sub-§§1-A, 11-A and 28-A are enacted to read:
- <u>1-A. Airbow. "Airbow" means a device for propelling an arrow or bolt by means of</u>
   <u>compressed air, mounted on a stock and having a working mechanical trigger safety</u>
   <u>device and a minimum pressure of 2,000 pounds per square inch.</u>
- 6 <u>11-A. Crossbow.</u> "Crossbow" means a device for propelling an arrow or bolt by 7 means of traverse limbs and a string, mounted on a stock and having a working 8 mechanical trigger safety device and a minimum draw weight of 100 pounds.

28-A. Hand-held bow or bow. "Hand-held bow" or "bow" means a device for
 propelling an arrow by means of limbs and a string that is hand held, hand drawn and
 held in a drawn position by hand or a hand-held mechanical release. "Hand-held bow" or
 "bow" includes a compound bow, a recurve bow and a long bow.

- D. For a resident 70 years of age or older. For a person who holds a valid senior 15 lifetime license under this section at any time during the calendar year that person 16 turns 70 years of age, that lifetime license includes all hunting permits and licenses 17 authorized in this Part and may renew at no cost a guide license under section 12853. 18 19 A license holder under this paragraph who qualifies to hunt during the special season on deer under section 11153 and who meets the eligibility requirements of section 20 11106 and section 11162 must have included in that person's license one antlerless 21 deer permit and one either-sex permit. A person who is 70 years of age or older may 22 purchase a senior lifetime license that entitles the holder to all the privileges 23 described in this paragraph for a one-time \$8 fee. 24

  wild bird or a wild animal with a crossbow during any open season on that wild bird or
  wild animal subject to this Part.

- 32 §10955. Open seasons for hunting with airbow
- 33 <u>1. Species and seasons.</u> A person may hunt deer with an airbow during the open
   34 <u>firearm season on deer as provided in section 11401.</u>
- 35 2. Airbow requirements. A person may not hunt with an airbow unless the airbow
   36 meets the following requirements:

1 2	<u>A.</u> The airbow must have a shoulder-type stock. A hand-held pistol-type airbow may not be used;
3 4	B. The airbow must be charged to a minimum pressure of 2,000 pounds per square inch;
5 6	C. The arrowhead, including a mechanical broadhead when open, must be at least $\frac{7/8 \text{ inch in width}}{1}$
7	D. An airbow arrow or bolt that has an explosive or poisonous tip may not be used;

17 18 19 20	A. "Loaded firearm or crossbow" means a firearm with a cartridge or shell in the chamber or in an attached magazine, clip or cylinder or a muzzle-loading firearm charged with powder, lead and a primed ignition device or mechanism or a cocked and armed crossbow.
21 22	B. "Vehicle" means a motor vehicle or a trailer or other type of vehicle being hauled by a motor vehicle.
23 24 25	<b>2. Prohibition; vehicles.</b> A person may not shoot while in or on a vehicle, have a loaded firearm or crossbow while in or on a vehicle or rest a loaded firearm or crossbow on a vehicle except as provided in subsection 3.

27 28 29	A. While hunting, a person who is not in or on a vehicle may rest a loaded firearm or crossbow that is under the person's control on the vehicle to shoot only when the vehicle is not in motion and the engine of the vehicle is not running.

While hunting, a person who is on but not within an enclosed area or passenger compartment of an all-terrain vehicle or snowmobile may shoot a firearm or crossbow or rest a loaded firearm or crossbow that is under the person's control on the all-terrain vehicle or snowmobile to shoot only when the all-terrain vehicle or snowmobile is not in motion and the engine of the all-terrain vehicle or snowmobile is not running.</li><li>C. - 6 Sec. 10. 12 MRSA §12661, sub-§3, as amended by PL 2017, c. 164, §22, is 7 further amended to read:

**3. Removal of abandoned ice-fishing shacks.** A person may not leave a structure on another person's land without permission from the landowner. Notwithstanding the provisions of Title 33, chapter 41 and Title 17, section 2263-A, a landowner on whose property an ice fishing abandoned ice-fishing shack as defined in Title 17, section 2263 left in violation of this section may remove or destroy the shack. The landowner may recover any costs of removing or destroying the shack from the owner of the shack in a civil action.

17 1-D. Abandoned ice-fishing shack. "Abandoned ice-fishing shack" means a
 18 temporary structure used for ice fishing and left on property not owned by the person
 19 owning the structure without permission of the landowner for more than 15 days after the
 20 inland waters on which the shack or structure was located are closed to ice fishing.

- 21 SUMMARY
- 22 This bill changes the inland fisheries and wildlife laws to:

Define the terms "airbow," "crossbow" and "hand-held bow" or "bow" and
 establish an open season for hunting deer with an airbow during the open firearm season
 on deer;

27. Specify that lifetime license holders must meet eligibility requirements for hunting
with bows and crossbows;

3. Make technical and grammatical corrections to the law regarding having a loaded
 firearm or crossbow in a motor vehicle or hunting or shooting from a motor vehicle or
 motorboat;

- 4. Repeal outdated language regarding carrying a handgun during the regular
   archery-only season on deer;
- 5. Clarify that it is only beaver, and no other species, that may be trapped by the
  holder of a nonresident trapping license who is not a citizen of the United States;

Require the court to impose a fine of \$20 for each quart of smelts rather than for
 each fish unlawfully possessed over the limit adopted by the Commissioner of Inland
 Fisheries and Wildlife by rule; and

7. Require any shack or temporary structure used for ice fishing to be removed by
 March 31st and, in the laws regarding litter control, amend the definition of the term
 "abandoned ice-fishing shack."
