1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 29-A MRSA §101, sub-§6-B is enacted to read:
3 4	<u>6-B.</u> Autocycle. "Autocycle" means an enclosed motorcycle having no more than 3 wheels in contact with the ground and that:
5 6	A. Meets the general motorcycle inspection standards, except those standards that do not apply due to the design of the vehicle; and
7	B. Is equipped with:
8	(1) Safety belts for all passengers;
9	(2) A roll bar or enclosed cab;
10	(3) A steering wheel or tiller; and
11	(4) Brakes on at least 2 main wheels.
12 13	The manufacturer's certificate of origin must state that the vehicle meets the federal specifications for a motorcycle.
14 15	This subsection is repealed 90 days after the adjournment of the First Regular Session of the 126th Legislature.

18 19	§202. Appointment of agents for the issuance of noncommercial driver's license renewals, nondriver identification card renewals and duplicates
20 21 22 23 24 25 26 27 28	The Secretary of State may appoint agents authorized solely to issue renewals of operator's licenses and to issue noncommercial driver's license renewals, nondriver identification card renewals and duplicates of those documents who are stationed at convenient locations in the State. Agents may charge an applicant a fee over the required operator's license fee fees for each renewal or duplicate issued. The agent retains the additional fee and forwards all other fees to the Secretary of State. The Secretary of State shall determine by rule the fee to be charged by an agent under this section. Rules adopted pursuant to this section are routine technical rules pursuant to Title 5, chapter 375 , subchapter $H-A 2-A$.
29 30 31	Renewal agents <u>Agents</u> appointed pursuant to this section are not authorized to issue registrations or, initial operator's <u>noncommercial driver's</u> licenses <u>or initial nondriver</u> <u>identification cards</u> .

33 34 35 36 37	12-A. Autocycles. The Secretary of State may issue a registration for an autocycle upon application and payment of an annual fee of \$21. The registrant must provide a certificate of title required by section 651, proof of financial responsibility required by section 1601 and evidence of payment of the excise tax as required by Title 36, section 1482, subsection 1, paragraph C. An autocycle registered under this section is issued a

1 2	registration plate with the word "autocycle" instead of "Vacationland." The Secretary of State may issue a facsimile plate for a 60-day period.

The Secretary of State may not issue a license for a driver education school until the applicant has filed with the Secretary of State a certificate showing that the applicant is covered by an automobile bodily injury and property damage liability insurance policy insuring against any legal liability in accordance with the terms of the policy for personal injury or death of any one person in the sum of \$100,000 and for any number of persons in the sum of \$300,000 and against property damage in the

In lieu of that insurance, the applicant may file with the Secretary of State a bond or bonds issued by a surety company authorized to do business in the State in the amount of at least \$100,000 on account of injury to or death of one person and subject to such limits as respects injury to or death of one person, of at least \$300,000 on account of any one accident resulting in injury to or death of more than one person and of at least \$100,000 for damage to property of others. Failure to comply with this subsection is grounds for suspension or revocation of a driver education school license.
10 11 12 13 14	B. A vehicle used as a training vehicle must be maintained in safe mechanical condition at all times. Each vehicle must be equipped with dual-control foot brakes and, if the vehicle is not equipped with an automatic transmission, dual-control clutch pedals. While being used in actual instruction, a vehicle must be equipped with an identification sign listing the name of the school and a student driver sign.
15 16	The following vehicles are not required to have dual controls and an identification sign listing the name of the school and a student driver sign:
17 18	(1) A vehicle that is being used to instruct a person with a disability and is specially equipped for use by a person with a disability; and
19 20 21	(2) A vehicle that is being used to instruct a person in possession of a valid Maine driver's license or instruction permit when the vehicle is not provided by the driver education school.

For the privilege of operating a motor vehicle or camper trailer on the public 21 22 ways, each motor vehicle, other than a stock race car, or each camper trailer to be so 23 operated is subject to excise tax as follows, except as specified in subparagraph (3)24 (4): a sum equal to 24 mills on each dollar of the maker's list price for the first or 25 current year of model, 17 1/2 mills for the 2nd year, 13 1/2 mills for the 3rd year, 10 mills for the 4th year, 6 1/2 mills for the 5th year and 4 mills for the 6th and 26 succeeding years. The minimum tax is \$5 for a motor vehicle other than a bicycle 27 28 with motor attached, \$2.50 for a bicycle with motor attached, \$15 for a camper trailer 29 other than a tent trailer and \$5 for a tent trailer. The excise tax on a stock race car is 30 \$5.

31 (1) On new registrations of automobiles, trucks and truck tractors, the excise tax
32 payment must be made prior to registration and is for a one-year period from the
33 date of registration.

34 (2) Vehicles registered under the International Registration Plan are subject to an
35 excise tax determined on a monthly proration basis if their registration period is
36 less than 12 months.

37(3) For commercial vehicles manufactured in model year 1996 and after, the38amount of excise tax due for trucks or truck tractors registered for more than3926,000 pounds and for Class A special mobile equipment, as defined in Title4029 A, section 101, subsection 70, is based on the purchase price in the original41year of title rather than on the list price. Verification of purchase price for the

1 2 3	application of excise tax is determined by the initial bill of sale or the state sales tax document provided at point of purchase. The initial bill of sale is that issued by the dealer to the initial purchaser of a new vehicle.
4 5 6 7	(4) When a person registers a truck or truck tractor with a registered weight of more than 26,000 pounds or Class A special mobile equipment, as defined in Title 29-A, section 101, subsection 70, the amount of excise tax due from that person is based on:
8 9	(a) For the first 6 years, the purchase price of that truck, truck tractor or Class A special mobile equipment in the original year of title; and
10 11	(b) For the 7th and subsequent years, the list price of that truck, truck tractor or Class A special mobile equipment.
12 13 14 15	Verification of purchase price for the application of excise tax is determined by the initial bill of sale or the state sales tax document provided at point of purchase. The initial bill of sale is that issued by the dealer to the initial purchaser of a new vehicle.
16 17 18	For motor vehicles being registered pursuant to Title 29-A, section 405, subsection 1, paragraph C, the excise tax must be prorated for the number of months in the registration.
19	SUMMARY
20	This bill:
21 22	1. Changes the repeal date for autocycle registrations to coincide with changes made in Public Law 2011, chapter 356;
23 24 25 26	2. Current law allows the Secretary of State to appoint agents to issue renewals of operator's licenses. This bill allows appointed agents to renew nondriver identification cards in addition to noncommercial driver's licenses and to issue duplicates of those documents;
27	3. Removes obsolete language referencing "driver education teachers";
27 28 29 30	 Removes obsolete language referencing "driver education teachers"; Requires the Secretary of State, in consultation with the Commissioner of Transportation, to establish by rule the fees for vehicles covered by long-term overlimit permits; and
