## An Act To Allow Retired Marine Patrol Officers To Obtain up to 2 Marine Fisheries Licenses

1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 12 MRSA §6421, sub-§5, as amended by PL 2011, c. 486, §1, is further amended to read:
4 5 6	<b>5. Eligibility.</b> A noncommercial or student lobster and crab fishing license may only be issued to an individual who is a resident. A Class I, Class II or Class III license may be issued to a person 17 years of age or older only if the person:
7 8	A. Possessed a Class I, Class II or Class III lobster and crab fishing license in the previous calendar year;
9	C. Meets the requirements of the apprentice program under section 6422; or
10 11 12	D. Did not possess a Class I, Class II or Class III lobster and crab fishing license in the previous calendar year because the commissioner had suspended the person's license privileges for a length of time that included the previous calendar year.; or
13	I. Meets the requirements of subsection 5-F.
14 15 16 17	Notwithstanding the age requirements of this subsection, a person who holds a Class I, Class II or Class III license on December 31, 2007 may continue to be issued a Class I, Class II or Class III license provided that person continues to meet the requirements of paragraph A.

4	SUMMARY
5	This bill provides that a retired marine patrol officer who applies for a Class I, Class
6	II or Class III lobster and crab fishing license, an elver fishing license, a hand fishing
7	scallop license, a scallop dragging license, a handfishing sea urchin license, a sea urchin
8	dragging license or a sea urchin hand-raking and trapping license must be issued up to 2
9	of the licenses, but in no case 2 of the same license, if certain conditions are met. To be
10	issued a license, the applicant must be eligible for service retirement benefits under the
11	State Employee and Teacher Retirement Program and the issuance of the license must not
12	result in an increase in the total number of licenses outstanding in the fishery for which
13	the license is issued.
