- 1**1. Applicant.** "Applicant" means a person or group that develops and submits an2application for a public charter school to an authorizer.
- 3 2. Application. "Application" means a proposal from an applicant to an authorizer
 4 to enter into a charter contract whereby the proposed school obtains public charter school
 5 status.

6 **3.** At-risk pupil. "At-risk pupil" means a pupil who has an economic or academic 7 disadvantage that requires special services and assistance to enable the student to succeed 8 in educational programs. "At-risk pupil" includes, but is not limited to, pupils who are 9 members of economically disadvantaged families, pupils who are identified as having 10 special educational needs, pupils who are limited in English proficiency, pupils who are 11 at risk of dropping out of high school and pupils who do not meet minimum standards of 12 academic proficiency.

- 4. Authorizer. "Authorizer" means an entity empowered under this chapter to
 review applications, decide whether to approve or reject applications, enter into charter
 contracts with applicants, oversee and monitor public charter schools and decide whether
 to renew, not renew or revoke charter contracts.
- 17 5. Charter contract. "Charter contract" means a performance-based contract for a
 18 fixed term between a public charter school and an authorizer that describes performance
 19 expectations, defines operational responsibilities and outlines the autonomy and
 20 accountability for each party to the contract.
- 6. Conversion public charter school. "Conversion public charter school" means a
 public charter school that existed as a noncharter public school before becoming a public
 charter school.

7. Education service provider. "Education service provider" means an education
 management organization, charter management organization, school design provider or
 any other partner entity with whom a public charter school intends to contract for
 education design, implementation or comprehensive management.

- 28 8. Governing board. "Governing board" means the independent board of a public
 29 charter school that is party to the charter contract with the authorizer and whose members
 30 have been elected or selected pursuant to the school's application.
- 31 9. Local school board. "Local school board" means a school board exercising
 32 management and control of a local school district pursuant to the Constitution of Maine
 33 and the laws of the State.
- **10. Local school district.** "Local school district" means a system of public schools
 established and maintained by a local school board within its limits pursuant to the
 Constitution of Maine and the laws of the State.
- 37 <u>11. Noncharter public school.</u> "Noncharter public school" means a public school
 38 <u>that is under the direct management, governance and control of a local school board.</u>
- 39 **12. Parent.** "Parent" means a parent, guardian or legal guardian.

1	13. Public charter school. "Public charter school" means a public school that:
2 3	A. Has autonomy over key decisions, including, but not limited to, decisions concerning finance, personnel, scheduling, curriculum and instruction;
4	B. Is governed by an independent board;
5 6	C. Is established and operated under the terms of a charter contract between the governing board and its authorizer in accordance with this chapter;
7	D. Is a school to which parents choose to send their children;
8	E. Provides a program of education that:
9 10	(1) Includes one or more of the following: preschool, prekindergarten and any grade or grades from kindergarten to grade 12;
11 12	(2) May include a focus on students with special needs, such as at-risk pupils, English language learners or students involved with the juvenile justice system;
13	(3) May include a specific academic approach or theme, such as:
14	(a) Vocational and technical training;
15	(b) Natural resources and the environment;
16	(c) Farming, fishing and forestry;
17	(d) Foreign language and culture;
18	(e) Visual and performing arts;
19	(f) Science, mathematics and technology; and
20	(g) Project-based learning, experiential learning or online instruction;
21 22	F. Operates in pursuit of a specific set of educational objectives as defined in its charter contract; and
23 24	<u>G.</u> Operates under the oversight of the authorizer from which its charter contract is granted and in accordance with its charter contract.
25 26	14. Pupil or student. "Pupil" or "student" means any child who is eligible for attendance in public schools in the State.
27 28 29	15. Start-up public charter school. "Start-up public charter school" means a public charter school that did not exist as a noncharter public school prior to becoming a public charter school.
30 31	16. Virtual public charter school. "Virtual public charter school" means a public charter school that offers education services predominantly through an online program.
32	§2402. Public charter schools authorized
33 34 35 36	Charter schools may be established as public schools pursuant to this chapter to improve pupil learning by creating more high-quality schools with high standards for pupil performance; to close achievement gaps between high-performing and low- performing groups of public school students; to increase high-quality educational

opportunities within the public education system; to provide alternative learning environments for students who are not thriving in traditional school settings; to create new professional opportunities for teachers and other school personnel; to encourage the use of different, high-quality models of teaching and other aspects of schooling; and to provide students, parents, community members and local entities with expanded opportunities for involvement in the public education system.

7 §2403. Role of the department; commissioner; rules

8 **<u>1. Information and technical assistance.</u>** The department shall disseminate 9 information on how to form and operate a public charter school and on how to enroll in a 10 public charter school once the school is created. The department may provide assistance 11 and guidance to authorizers in developing effective authorization and oversight 12 procedures.

2. Applications for federal funds. The department may apply for assistance from
 the federal charter school grant program on behalf of potential and actual public charter
 schools in the State.

3. Use of federal funds. If the department receives a grant from the federal charter
 school grant program on behalf of potential and actual charter schools, the grant must be
 used according to the applicable federal law and primarily for planning and start-up
 grants to public charter school organizers and for such activities as:

- 20 <u>A. Establishing a charter school office in the department;</u>
- 21B. Providing information and technical assistance to potential and actual public22charter school organizers and authorizers; and
- 23 C. Allocating funds to support the work of potential and actual authorizers.
- 4. Rules. The department may adopt routine technical rules pursuant to Title 5,
 chapter 375, subchapter 2-A to implement this chapter.

26 5. Reports. Four years after public charter schools have been in operation, the 27 commissioner shall issue to the Governor, the Legislature and the public a report on the State's charter school program, drawing from the annual reports submitted by every 28 29 authorizer pursuant to section 2407, subsection 4, as well as any additional relevant data 30 compiled by the commissioner up to the school year ending in the preceding calendar 31 year. The report must include an assessment of the charter school program's successes, 32 challenges and areas for improvement in meeting the purposes of this chapter and any 33 suggested changes in state law or policy necessary to strengthen the charter school program. The commissioner shall issue a similar report after 8 years of operation of 34 35 public charter schools.

- 36 §2404. Public charter school eligibility; enrollment
- 37 <u>1. Eligibility.</u> Any student residing in the State is eligible to apply to a public
 38 <u>charter school.</u>

1 2	2. Enrollment. A public charter school shall enroll students in accordance with this subsection.
3 4	A. Public charter school organizers shall include all segments of the populations served by the existing public schools in their area in their recruitment efforts.
5 6 7	B. A public charter school shall enroll all students who wish to attend the school, unless the number of students exceeds the enrollment capacity of a program, class, grade level or building.
8 9 10 11	C. Except as provided in paragraphs G and H, if capacity is insufficient to enroll all students who wish to attend the school, the public charter school shall select students through a random selection process. A list maintained to fill potential vacancies may be carried over to the succeeding year.
12 13 14	D. A public charter school, unless authorized by a school administrative unit, may not enroll more than 10% of a school administrative unit's public school students per grade level in each of the first 2 years of the public charter school's operation.
15 16 17	<u>E.</u> A public charter school may limit enrollment to pupils within a given age group or grade level and may be organized around a special emphasis, theme or concept as stated in the school's application for a charter contract pursuant to section 2410.
18 19 20	F. Any noncharter public school converting partially or entirely to a public charter school shall adopt and maintain a policy that gives enrollment preference to pupils who reside within the former attendance area of that public school.
21 22 23	G. A public charter school shall give enrollment preference to pupils enrolled in the public charter school the previous school year and to siblings of pupils already enrolled in the public charter school.
24 25 26	H. A public charter school may give enrollment preference to children of a public charter school's founders, governing board members and full-time employees, as long as they constitute no more than 10% of the school's total student population.
27 28	I. A public charter school may enroll students from outside the State if space is available.
29 30 31 32 33 34 35	3. Discrimination prohibited. A public charter school may not discriminate on the basis of race, ethnicity, national origin, religion, gender, income level, disabling condition, proficiency in the English language or academic or athletic ability, except that nothing in this subsection may be construed to limit the formation of a public charter school that is dedicated to focusing education services on at-risk pupils, students with disabilities and students who pose such severe disciplinary problems that they warrant a specific education program.
36	§2405. Prohibition

1 §2406. Public information

2 3 4 5	A local school district shall provide or publicize to parents and the general public information about public charter schools authorized by the district as an enrollment option within the district to the same extent and through the same means that the district provides and publicizes information about noncharter public schools in the district.
6	<u>§2407. Authorizers</u>
7 8	1. Eligible authorizers. The following groups may become authorizers of public charter schools:
9	A. A local school board within the boundaries of a school administrative unit;
10 11	B. A collaborative among authorizing entities that forms to set up a regional public charter school;
12 13	C. A college or university located in the State that offers a baccalaureate degree in education; and
14	D. The State Charter School Commission established in subsection 9.
15	2. Powers and duties. An authorizer may:
16 17	A. Solicit, invite and evaluate applications from organizers of proposed public charter schools;
18	B. Approve applications that meet identified educational needs;
19	C. Deny applications that do not meet identified educational needs;
20	D. Create a framework to guide the development of charter contracts;
21 22	E. Negotiate and execute sound charter contracts with each approved public charter school;
23	F. Monitor the performance and compliance of public charter schools; and
24	G. Determine whether each charter contract merits renewal or revocation.
25 26 27 28	3. Principles and professional standards. An authorizer shall develop and maintain policies and practices consistent with nationally recognized principles and professional standards for authorizing public charter schools including standards relating to:
29	A. Organizational capacity and infrastructure;
30	B. Soliciting and evaluating applications;
31	C. Performance contracting;
32	D. Ongoing public charter school oversight and evaluation; and
33	E. Charter renewal decision making.
34 35	<u>4. Reporting and evaluation.</u> An authorizer shall submit to the commissioner an annual report within 60 days of the end of each school fiscal year summarizing:

1 2	A. The authorizer's strategic vision for chartering and progress toward achieving that vision;
3 4 5	B. The performance of all operating public charter schools overseen by the authorizer, according to the performance measures and expectations specified in the charter contracts;
6 7	C. The status of the authorizer's public charter school portfolio, identifying all public charter schools within that portfolio as:
8	(1) Approved, but not yet open;
9	(2) Operating;
10	(3) Renewed;
11	(4) Transferred;
12	(5) Terminated;
13	(6) Closed; or
14	(7) Never opened; and
15 16	D. The oversight and services provided by the authorizer to the public charter schools under the authorizer's purview.
17 18	5. Funding. To cover costs for overseeing public charter schools in accordance with this chapter, an authorizer may:
19 20	A. Expend its own resources, seek grant funds and establish partnerships to support its charter school office and activities; and
21 22 23	B. Charge up to 3% of annual per-pupil allocations received by each public charter school it authorizes. These funds must be used to cover the costs for an authorizer to provide oversight services to its public charter schools.
24 25 26	6. Conflicts of interest. An employee, trustee, agent or representative of an authorizer may not simultaneously serve as an employee, trustee, agent, representative, vendor or contractor of a public charter school of that authorizer.
27 28 29 30	7. Exclusivity of authorizing functions and rights. A governmental entity or other entity, other than an entity expressly granted chartering authority as set forth in this chapter, may not assume any authorizing function or duty in any form, unless expressly allowed by law.
31 32 33 34	8. Services purchased from authorizer. With the exception of charges for oversight services as required by subsection 5, a public charter school may not be required to purchase services from its authorizer as a condition of charter approval or of executing a charter contract, nor may any such condition be implied.
35 36 37 38	A. A public charter school may, at its discretion, choose to purchase services from its authorizer. In such event, the public charter school and authorizer shall execute an annual service contract, separate from the charter contract, stating the parties' mutual agreement concerning any services to be provided by the authorizer and any service

1 2	fees to be charged to the public charter school. An authorizer may not charge more than market rates for services provided to a public charter school.
3 4 5	B. Within 90 days after the end of each school fiscal year, an authorizer shall provide to each public charter school it oversees an itemized accounting of all the actual costs of services purchased by the public charter school from the authorizer.
6 7 8 9 10	C. Any difference between the amount initially charged to the public charter school and the actual cost must be reconciled and paid to the owed party. If either party disputes the itemized accounting, any charges included in such accounting or charges to either party, the disputing party is entitled to request a 3rd-party review at its own expense.
11 12 13	<u>9. State Charter School Commission.</u> The State Charter School Commission, established under Title 5, section 12004-G, subsection 10-D, is referred to in this chapter as "the commission."
14 15	A. The commission consists of 7 members appointed by the state board for 3-year terms.
16 17 18	(1) Three members must be members of the state board, and those 3 members shall nominate the other 4 members who must be approved by a majority vote of the state board.
19 20 21 22	(2) Members appointed to the commission must have diverse professional experience in education, social services, youth training, business startup and administration, accounting and finance, strategic planning and nonprofit governance.
23	(3) A commission member may serve a total of 3 consecutive terms.
24 25	(4) A commission member may not receive compensation, but may be reimbursed for travel expenses.
26 27 28	B. The commission shall, subject to the requirements of all charter school authorizers under this chapter, develop, implement and refine procedures related to the process of authorizing the creation of public charter schools in this State.
29	C. The commission shall, in keeping with its authorizing responsibilities:
30	(1) Engage professional and administrative staff, separate from the department;
31	(2) Convene stakeholder groups and engage experts; and
32	(3) Seek and receive state, federal and private funds.
33 34 35	D. The commission is the sole authorizer in this State for virtual public charter schools, except that a local school district may authorize a public charter school within its jurisdiction that integrates online and on-site instruction.
36	<u>§2408. Request for proposals</u>
37 38	1. Issuance. To invite, solicit, encourage and guide the development of high-quality public charter school applications, an authorizer shall issue and broadly publicize requests

1 2	for proposals. The content and dissemination of the request for proposals must be consistent with the purposes and requirements of this chapter.
3 4	2. Content. An authorizer's request for proposals must contain information outlined in this subsection.
5 6	A. A request for proposals must present the authorizer's strategic vision for and interests in chartering.
7 8 9 10 11 12 13 14	B. Authorizers may give priority to proposals that expand opportunities for children who are not realizing their full potential, who may be disaffected or disengaged in their current education situations and who may be at risk of failure academically, socially, economically or personally. Authorizers may encourage proposals that include a specific academic approach or theme to address the diverse educational needs of communities in the State. A request for proposals must include a clear statement of any priority or preference the authorizer wishes to grant to particular types of applications.
15 16 17	C. A request for proposals must include or otherwise direct applicants to the performance framework that the authorizer has developed for public charter school oversight and evaluation in accordance with section 2411.
18 19	D. A request for proposals must include the criteria and standards that will guide the authorizer's decision to approve or deny an application.
20 21 22 23	E. A request for proposals must state clear, appropriately detailed questions as well as guidelines concerning the format and content essential for applicants to demonstrate the capacities necessary to establish and operate a successful public charter school.
24 25 26	F. A request for proposals must require applications to provide or describe thoroughly, at a minimum, all of the following essential elements of the proposed public charter school plan:
27	(1) The proposed public charter school's vision, including:
28	(a) An executive summary;
29 30 31	(b) The mission and vision of the proposed public charter school, including identification of the targeted student population and the community the school hopes to serve; and
32 33	(c) Evidence of need and community support for the proposed public charter school;
34	(2) The proposed public charter school's governance plan, including:
35 36	(a) Background information on proposed board members and any assurances or certifications required by the authorizer;
37	(b) Proposed governing bylaws;
38 39 40	(c) An organization chart that clearly presents the school's organizational structure, including lines of authority and reporting between the governing board, staff and any related bodies such as advisory bodies or parent and

1 2	teacher councils, and any external organizations that will play a role in managing the school;
3 4 5	(d) A clear description of the roles and responsibilities for the governing board, the school's leadership and management team and any other entities shown on the organization chart;
6 7	(e) Identification of the proposed founding governing board members and, if identified, the proposed school leader or leaders; and
8 9	(f) Background information on the school's leadership and management team. if identified;
10	(3) The proposed public charter school's plan of organization, including:
11	(a) The location or geographic area of the school;
12	(b) The grades to be served each year for the full term of the charter;
13 14	(c) Minimum, planned and maximum enrollment per grade per year for the term of the charter:
15	(d) The school's proposed calendar and sample daily schedule;
16 17	(e) Plans and timelines for student recruitment and enrollment, including lottery procedures;
18 19	(f) Explanations of any partnerships or contractual relationships central to the school's operations or mission;
20 21	(g) The school's proposals for providing transportation, food service and other significant operational or ancillary services;
22	(h) A facilities plan, including backup or contingency plans if appropriate;
23 24	(i) A detailed school start-up plan, identifying tasks, timelines and responsible individuals; and
25 26 27	(j) A closure protocol, outlining orderly plans and timelines for transitioning students and student records to new schools and for appropriately disposing of school funds, property and assets in the event of school closure;
28	(4) The proposed public charter school's finances, including:
29 30	(a) A description of the school's financial plan and policies, including financial controls and audit requirements;
31	(b) Start-up and 3-year budgets with clearly stated assumptions;
32 33	(c) Start-up and first-year cash-flow projections with clearly stated assumptions;
34 35	(d) Evidence of anticipated fund-raising contributions, if claimed in the application; and
36	(e) A description of the insurance coverage the school proposes to obtain;
37	(5) The proposed public charter school's student policy, including:

1 2 3	(a) The school's plans for identifying and successfully serving students with the wide range of learning needs and styles typically found in schools of the sending area;
4 5	(b) The school's plans for compliance with applicable laws, rules and regulations; and
6 7	(c) The school's student discipline plans and policies, including those for special education students;
8	(6) The proposed public charter school's academic program, including:
9 10	(a) A description of the academic program aligned with the statewide system of learning results under section 6209;
11 12 13 14	(b) A description of the school's instructional design, including the type of learning environment, such as classroom-based or independent study, class size and structure, curriculum overview, teaching methods and research basis;
15 16 17	(c) The school's plan for using internal and external assessments to measure and report student progress on the measures and metrics of the performance framework developed by the authorizer in accordance with section 2411; and
18 19	(d) A description of cocurricular or extracurricular programs and how they will be funded and delivered; and
20	(7) The proposed public charter school's staff policy, including:
21 22	(a) A staffing chart for the school's first year and a staffing plan for the term of the charter;
23	(b) Plans for recruiting and developing school leadership and staff;
24 25	(c) The school's leadership and teacher employment policies, including performance evaluation plans; and
26	(d) Opportunities and expectations for parent involvement.
27 28 29 30 31 32	G. With respect to the conversion of an existing public school to public charter school status, in addition to the other requirements of this subsection, the request for proposals must require applicants to demonstrate support for the proposed conversion public charter school by submitting 2 petitions, one signed by a majority of teachers in the existing public school and the other signed by a majority of parents and guardians of students in the existing public school.
33 34 35	If the school to be converted is the only public school option for students in the school administrative unit, the request for proposals must additionally require that the conversion be approved by voters in that school administrative unit.
36 37 38 39	H. With respect to a proposed charter school that intends to contract with an education service provider for substantial education or management services, in addition to the other requirements of this subsection, the request for proposals must require applicants to:
40	(1) Explain how and why the education service provider was selected;

1 2 3 4	(2) Provide evidence of the education service provider's success in serving student populations similar to the targeted population, including demonstrated academic achievement as well as successful management of nonacademic school functions if applicable;
5 6 7 8 9 10	(3) Provide information on the proposed duration of the service contract; roles and responsibilities; scope of services and resources to be provided by the education service provider; performance evaluation measures and timelines; compensation structure, including clear identification of all fees to be paid to the education service provider; methods of contract oversight and enforcement; investment disclosure; and conditions for renewal and termination of the contract;
11 12	(4) Provide a draft of the proposed service contract including all of the terms in subparagraphs (1), (2) and (3);
13 14 15 16 17	(5) Explain the relationship between the governing board and the education service provider, specifying how the governing board will monitor and evaluate the performance of the education service provider, the internal controls that will guide the relationship and how the governing board will ensure fulfillment of performance expectations:
18 19	(6) Provide a statement of assurance that the governing board is legally and operationally independent from the education service provider; and
20 21 22	(7) Disclose and explain any existing or potential conflicts of interest between the governing board and the education service provider or any affiliated business entities.
23 24 25 26	I. With respect to a public charter school proposal from an applicant that currently operates one or more schools in any other state or nation, in addition to the other requirements of this subsection, the request for proposals must require applicants to provide evidence of past performance and current capacity for growth.
27	<u>§2409. Charter applications</u>
28 29 30 31 32 33 34 35	1. Application. An applicant for approval as a public charter school must submit an application as set out in this section. An applicant may submit an application only to an authorizer that has issued a request for proposals in accordance with section 2408. An applicant may submit a proposal for a particular public charter school to no more than one authorizer at a time. The purposes of the application are to present the proposed public charter school's academic and operational vision and plans, demonstrate the applicant's capacities to execute the proposed vision and plans and provide the authorizer a clear basis for assessing the applicant's plans and capacities.
36 37	<u>2. Conversion of existing public schools.</u> A public school or public school program may apply to its local school board to become a conversion public charter school.
38 39 40 41 42	3. Start-up schools. An application for a start-up public charter school may be submitted by a nonprofit, nonreligious organization. If the organizers of a start-up public charter school have been affiliated with a previous school or education program, they must form a separate nonprofit organization in this State to be eligible for state and federal grants.

1 2 3 4	4. Application review process. In reviewing and evaluating applications, authorizers shall employ procedures, practices, criteria and standards consistent with nationally recognized principles and standards for authorizing high-quality public charter schools.
5 6 7	A. The application review process must include, at a minimum, substantive participation by a team of reviewers who collectively possess appropriate academic expertise and operational experience with charter schools.
8 9	B. The application review process must include a thorough evaluation of each application, an in-person interview with the applicant and a public hearing.
10	C. In deciding whether to approve applications, authorizers shall:

5. Reports for multiple campuses. With respect to a public charter school that

31 32 33	B. A charter contract may include one or more schools, to the extent approved by the authorizer and consistent with applicable law. Each public charter school that is part of a charter contract must be separate and distinct from any others.
34 35 36	C. A single governing board may be issued one or more charter contracts. Each public charter school operating under its own contract is a discrete legal entity, separate and distinct from any others.
37 38	2. Local educational agency status. The following provisions govern the local educational agency status of public charter schools.

To the extent permitted by federal, state or local laws, the public charter school has primary responsibility for special education at the school, including identification and provision of service, and is responsible for meeting the needs of enrolled students with disabilities. 9 10	<u>G.</u> Solicit and accept any gifts or grants for school purposes subject to applicable laws and the terms of its charter contract;
11 12	H. Acquire real property for use as its facility or facilities from public or private sources; and
13	I. Sue and be sued in its own name.
14 15	4. General requirements. A public charter school is subject to the general requirements set out in this subsection.
16 17 18	A. A public charter school may not discriminate against any person on the basis of race, creed, color, sex, disability or national origin or on any other basis that would be unlawful if done by a public school.
19 20	B. A public charter school may not engage in any religious practices in its educational program, admissions or employment policies or operations.
21 22 23 24	C. A public charter school may not charge tuition and may only charge such fees as may be imposed by other public schools in the State. A public charter school may charge tuition to an out-of-state student admitted to the school on a space-available basis.
25 26	D. A public charter school must have a plan that describes how the school will meet the transportation needs of its students.
27 28	E. The powers, obligations and responsibilities set forth in a charter contract may not be delegated or assigned by either party.
29 30	5. Applicability of other laws, rules and regulations. The applicability of other laws, rules and regulations to public charter schools is as set out in this subsection.
31 32 33	A. Public charter schools are subject to the same civil rights and health and safety requirements applicable to other public schools in the State, except as otherwise specifically provided in this chapter.

Public charter schools are subject to the same student assessment and accountability requirements applicable to other public schools in the State, but nothing in this chapter precludes a public charter school from establishing additional student assessment measures that go beyond state requirements if the school's authorizer approves such measures.
39	C. Governing boards are subject to and must comply with Title 1, chapter 13.

Except as provided in this chapter and its charter contract, a public charter school is exempt from all statutes and rules applicable to a public school, a local school board or a local school district, although it may elect to comply with one or more provisions of statutes or rules. School administrative units may not interpret this paragraph as reducing their obligation to provide education for their residents. E. A public charter school is exempt from the restrictions normally associated with any state-funded categorical education funding program.
8	6. Teachers. This subsection governs teacher employment in a public charter school.
9 10	A. A public charter school must comply with applicable federal laws and regulations regarding the qualification of teachers and other instructional staff.

All full-time teachers in a public charter school must either hold an appropriate teaching certificate or become certified within 3 years of the date they are hired, except for those with an advanced degree, professional certification or unique expertise or experience in the curricular area in which they teach.

17 18 19	D. Teachers and other public charter school personnel, as well as governing board trustees, are subject to criminal history record checks and fingerprinting requirements applicable to other public schools.
20 21	E. Teachers at a public charter school may choose to bargain collectively or form a professional group in accordance with this paragraph.
22 23 24 25 26 27 28	(1) Teachers who are employees of the public charter school have the same rights as other teachers in public education to organize and bargain collectively. Bargaining units at the public charter school must be separate from other bargaining units, such as a district bargaining unit. Staff at noncharter public schools converting to public charter schools have a right to employment benefits as stated in applicable collective bargaining agreements or they may vote to be represented in alternative ways.
29 30 31 32	(2) A teacher who is an employee of the public charter school may choose to be part of a professional group that operates the instructional program under an agreement with the public charter school, forming a partnership or producer cooperative that the teachers collectively own.
33 34 35 36 37	(3) Teachers who are employees of the public charter school may not be required to be members of any existing collective bargaining agreement between a local school district and its employees. A public charter school may not interfere with civil service laws or other applicable rules protecting the rights of employees to organize and be free from discrimination.
38 39 40	7. External audit. A public charter school shall adhere to generally accepted accounting principles and shall annually engage an external auditor to do an independent audit of the school's finances.

1. Enrollment count; report. Students attending public charter schools must be
 included in all enrollment and attendance counts of students of the local school districts in
 which the students reside. The public charter school shall report all such data to the local
 school districts of residence in a timely manner. Each local school district shall report

12 13 14 15 16 17	(1) Public charter schools with students eligible for funds under Title I of the federal Elementary and Secondary Education Act of 1965, 20 United States Code, Section 6301 et seq. must receive and use these funds in accordance with federal and state law. During the first year of operation, a public charter school must receive Title I funds on the basis of an estimated enrollment of eligible students, as agreed with its authorizer.

A facility of a public charter school is subject to the same building codes, regulations and fees that apply to other public schools.

32 33 34 35 36	1. Transfer of credits. If a student who was previously enrolled in a public charter school enrolls in another public school in this State, the school to which the student transfers must accept credits earned by the student in courses or instructional programs at the public charter school in a uniform and consistent manner and according to the same criteria that are used to accept academic credits from other public schools.
37 38 39 40	2. Access to extracurricular and interscholastic activities. A public charter school is eligible for state-sponsored or local school district-sponsored interscholastic leagues, competitions, awards, scholarships and recognition programs for students, educators, administrators and schools to the same extent as noncharter public schools. A

1 public charter school student is eligible to participate in extracurricular activities not 2 offered by the student's public charter school at the public school within whose 3 attendance boundaries the student's custodial parent or legal guardian resides or the public school from which the student withdrew for the purpose of attending a charter school. A 4 charter school student is eligible for extracurricular activities at a public school subject to 5 6 eligibility standards applied to full-time students of the public school. A local school district or public school may not impose additional requirements on a public charter 7 school student to participate in extracurricular activities that are not imposed on full-time 8 9 students of the public school.

- **3. Retirement.** A public charter school may establish a retirement plan or plans for
 employees.
- 12A. Teachers enrolled in the Maine Public Employees Retirement System who take13leave to teach in a public charter school may continue their participation in the Maine14Public Employees Retirement System while on such leave.
- 15B. If a public charter school chooses to set up a plan with the Maine Public16Employees Retirement System, the public charter school may establish a participating17local district plan with the Maine Public Employees Retirement System under Title 5,18chapter 425.

19 Sec. 9. Review of retirement laws. The Maine Public Employees Retirement 20 System shall review the laws governing participating local districts' retirement plans and 21 shall submit, by December 1, 2011, a report to the Joint Standing Committee on 22 Appropriations and Financial Affairs that includes any proposed legislation necessary to 23 fully implement this Act.

Sec. 10. Staggered terms. Notwithstanding the Maine Revised Statutes, Title 25 20-A, section 2407, subsection 9, of the initial members of the State Charter School 26 Commission, one member who is also a member of the State Board of Education serves a 27 3-year term, one member who is a member of the state board serves a 2-year term and 28 one member who is a member of the state board serves a one-year term. Two members 29 who are approved by the state board serve 3-year terms, one serves a 2-year term and one 30 serves a one-year term.
