### **An Act Regarding the Board of Trustees of the Maine Public Broadcasting Corporation**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. PL 1991, c. 848, §3, 2nd ¶**, as amended by PL 1997, c. 599, §1, is further  
3 amended to read:

4 The transfer may occur only if the transferee corporation has a board of trustees that  
5 includes the chancellor of the University of Maine System; 3 members representing the  
6 Board of Trustees of the University of Maine System; the President of Bates College; the  
7 President of Bowdoin College; the President of Colby College; and not fewer than 8 nor  
8 more than 12 public trustees elected by the board in the manner prescribed in the  
9 corporation's bylaws. The president of the transferee corporation is a nonvoting member  
10 of the board. By January 1, 1999, 2 additional public trustees must be appointed by the  
11 Governor, subject to review by the joint standing committee of the Legislature having  
12 jurisdiction over education matters and to confirmation by the Senate. By January 1,  
13 1999, the board shall amend the Maine Public Broadcasting Corporation bylaws to reflect  
14 the method of appointment of public trustees described in this paragraph. Beginning  
15 January 1, 2014, the composition of the board described in this paragraph is no longer  
16 required.

17 **Sec. 2. PL 1991, c. 848, §3**, as amended by PL 1997, c. 599, §1, is further  
18 amended by adding after the 2nd paragraph a new paragraph to read:

19 By January 1, 2014, the board shall amend the Maine Public Broadcasting  
20 Corporation bylaws to establish the number, terms and qualifications of trustees of the  
21 corporation and the method and manner of their selection consistent with the Maine  
22 Revised Statutes, Title 13-B.

23 **Sec. 3. Transition.** Members of the board of trustees of the Maine Public  
24 Broadcasting Corporation serving on the effective date of this Act serve until the  
25 selection of a new board of trustees pursuant to the corporation bylaws as amended in  
26 accordance with this Act.

27 **SUMMARY**

28 This bill amends the law establishing the membership of the board of trustees of the  
29 Maine Public Broadcasting Corporation and requires the current board of trustees to  
30 amend the bylaws of the corporation by January 1, 2014 to establish the number, terms  
31 and qualifications of trustees of the corporation and the method and manner of their  
32 selection consistent with Maine nonprofit corporation laws. The members of the current  
33 board serve until the new board is selected.
