An Act To Update the Career and Technical Education Laws

1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas,** federal law requires that states report the number of students who meet
4 career and technical education standards; and

5 **Whereas,** career and technical education centers and regions must provide programs
6 and courses aligned with career and technical education standards; and

7 **Whereas,** to ensure that career and technical education providers in this State meet
8 the federally required career and technical education standards, the State must adopt
9 national industry standards, or state-level standards where national industry standards are
10 not available; and

11 **Whereas,** career and technical education regions, centers and programs must file
12 applications to the Maine Department of Education for approval in July 2012; and

13 **Whereas,** the amendments proposed in this Act must be in place by July 1, 2012;
14 and

15 **Whereas,** in the judgment of the Legislature, these facts create an emergency within
16 the meaning of the Constitution of Maine and require the following legislation as
17 immediately necessary for the preservation of the public peace, health and safety; now,
18 therefore,

19 **Be it enacted by the People of the State of Maine as follows:**

20 **Sec. 1. 20-A MRSA §254, sub-§3,** as enacted by PL 1983, c. 693, §§5 and 8 and
21 amended by PL 2005, c. 397, Pt. D, §3, is further amended to read:

22 **3. Contracts for career and technical educational programs.** The commissioner
23 may:

24 A. Contract with a private school for the conduct of ~~vocational~~ career and technical
25 education courses in accordance with section 3002; and

26 B. Reimburse the private schools for part of the cost of conducting approved
27 ~~vocational~~ career and technical education courses from funds available from the
28 Federal Government for the purpose of career and technical education.

29 **Sec. 2. 20-A MRSA §2413, sub-§2, ¶A,** as enacted by PL 2011, c. 414, §5, is
30 amended to read:

31 A. For each public charter school student, the school administrative unit in which the
32 student resides must forward the per-pupil allocation to the public charter school
33 attended by the student as follows.

34 (1) The per-pupil allocation amount is the EPS per-pupil rate for the school
35 administrative unit in which the student resides, as calculated pursuant to section
36 15676, based on the student's grade level and adjusted as appropriate for

1 economic disadvantage and limited English proficiency pursuant to section
2 15675, subsections 1 and 2. For transportation expenses, the average per-pupil
3 expense in each school administrative unit of residence must be calculated and a
4 per-pupil allocation of that amount must be forwarded to the public charter
5 school attended on the same basis as the per-pupil allocations for operating funds.
6 Debt service and capital outlays may not be included in the calculation of these
7 per-pupil allocations. The department shall adopt rules governing how to
8 calculate these per-pupil allocations, including those for gifted and talented
9 programs, ~~vocational, technical and career~~ and technical education programs, and
10 targeted funds for assessment technology and kindergarten to grade 2 programs.

11 (2) For students attending public charter schools, the school administrative unit
12 of residence shall forward the per-pupil allocations described in subparagraph (1)
13 directly to the public charter school attended. These per-pupil allocations must
14 be forwarded to each public charter school on a quarterly basis, as follows. For
15 each fiscal year, allocations must be made in quarterly payments on September
16 1st, December 1st, March 1st and June 1st. The September payment must be
17 based on the number of students enrolled or anticipated to be enrolled in the
18 public charter school at the opening of school for that school year, which may not
19 exceed the maximum enrollment approved in the charter contract for that year
20 unless a waiver is obtained from the authorizer. In February of the school year, if
21 the number of students is higher or lower than the number of students at the
22 beginning of the school year, adjustments must be made in the June payment,
23 with 50% of the annual per-pupil allocation added for additional students or
24 subtracted if the total number of students is lower.

27 **§3002. Career and technical education**

28 The commissioner may contract with a private school, which is serving one or more
29 municipalities in lieu of a public secondary school, for the conduct of ~~vocational~~ career
30 and technical education courses ~~which that~~ meet the same standards for approval as those
31 conducted in public secondary schools.

32 **Sec. 4. 20-A MRSA §6952, first ¶**, as enacted by PL 2009, c. 296, §1, is
33 amended to read:

34 To qualify for support, approval and funding under this chapter, the center must
35 provide services to at-risk students who are or have been enrolled in one or more of
36 grades 7 to 12. The admission of an at-risk student to the center is subject to approval by
37 the center based upon criteria of the center approved by the commissioner. The center
38 shall provide residential and nonresidential instruction that is approved pursuant to
39 section 6951 and designed to effect positive, sustainable change in the lives of at-risk
40 students through comprehensive on-site education services in 4 major areas, including
41 high-quality scholastic, ~~vocational~~ career and technical and behavioral health education;
42 training and support for families of students; training and support for public school
43 teachers in dealing with students who are at risk of failing or dropping out of school; and

1 providing an environment conducive to research aiding the improvement of education for
2 at-risk students.

3 **Sec. 5. 20-A MRSA §8301-A, sub-§5**, as enacted by PL 1991, c. 518, §2, is

11 **Sec. 7. 20-A MRSA §8305-A, sub-§3**, as corrected by RR 2003, c. 2, §43, is

13 **3. Adult participation in career and technical education courses.** Persons who
14 are 20 years of age or older or who have graduated from a secondary school and who
15 otherwise comply with the requirements of this section may receive career and technical
16 education in a career and technical education course if, after all other eligible persons
17 have been enrolled in that course, space exists to accommodate participation by persons
18 who are 20 years of age or older or who have graduated from a secondary school. A
19 region, center or satellite program may charge reasonable fees to persons who ~~are 20~~
20 ~~years of age or older and who~~ receive career and technical education pursuant to this
21 ~~section~~ subsection.

24 **§8306-B. Approval of programs and courses; industry standards**

25 **1. Rules.** The commissioner may adopt rules to establish requirements for career
26 and technical education programs and courses in alignment with the system of learning
27 results established in section 6209, to establish procedures for approving career and
28 technical education programs and courses and to otherwise carry out the purposes of this
29 chapter. Rules adopted pursuant to this subsection are routine technical rules as defined
30 in Title 5, chapter 375, subchapter 2-A.

31 **2. Approval required.** A career and technical education program must be approved
32 by the commissioner, in accordance with this chapter, in order to:

33 A. Be offered by a career and technical education center, region or affiliated unit;

34 B. Receive state subsidy; or

35 C. Receive approval for federal funding, except that the commissioner may approve
36 federal funding for new and emerging industry programs prior to granting approval
37 for the career and technical education program.

1 **3. Industry standards.** An approved career and technical education program must
2 be designed to enable a student to meet industry standards applicable to the program.

3 A. The commissioner shall establish an industry stakeholder group to recommend
4 industry standards to be met in each program offered by a career and technical
5 education region, center or affiliated unit.

6 B. The industry stakeholder group under paragraph A shall recommend national
7 industry standards for each program, unless there are no relevant, applicable national
8 industry standards or the group determines that the national industry standards do not
9 meet the needs of students and employers in this State.

10 C. If the industry stakeholder group under paragraph A does not recommend a
11 national industry standard for a program, the commissioner shall convene one or
12 more stakeholder groups to adopt or create state industry standards for that program.

13 D. The commissioner shall accept or reject the industry stakeholder group's
14 recommendations under this subsection. If the commissioner accepts the
15 recommendations, those industry standards become the applicable industry standards
16 for the program. If the commissioner rejects the recommendations, the commissioner
17 shall either designate alternative standards or ask the stakeholder group to make other
18 recommendations.

19 **4. Coordination with postsecondary programs.** Career and technical education
20 programs offered at secondary career and technical education centers and regions must be
21 coordinated with appropriate postsecondary programs when applicable.

22 **5. Application.** A statewide career and technical education program seeking
23 approval from the commissioner after the effective date of this section must meet the
24 requirements of this section. A program approved by the commissioner prior to the
25 effective date of this section must meet the requirements of this section by July 1, 2012.

36 programs previously approved under former section 8306-A. The programs must offer a

21 **SUMMARY**

22 This bill provides an update in language for the career and technical education laws
23 to reflect current terminology, including changing all statutory references to "vocational"
24 education to "career and technical" education. It requires all career and technical
25 education programs to be based on national industry standards, or state-level standards if
26 national industry standards are not available or applicable. This bill also clarifies
27 references to school units other than those school units composed of single towns in an
28 effort to reduce confusion resulting from school reorganization.
