**JOINT RESOLUTION COMMEMORATING THE HOLOCAUST AND HUMAN RIGHTS CENTER OF MAINE'S LEGISLATIVE AWARENESS DAY AND YOM HASHOAH, THE DAY OF REMEMBRANCE**

WHEREAS, from 1933 to 1945, 6,000,000 Jews were murdered in the Holocaust as part of a state-sponsored, systematic persecution and annihilation program of genocide, and millions of other people suffered as victims of Nazism, such as the handicapped, political dissidents and many others for racial, ethnic or national reasons; and

WHEREAS, the people of the State of Maine should always remember the atrocities committed by the Nazis so that such horrors are never repeated and the history of the Holocaust offers an opportunity to reflect on the moral responsibilities of individuals, societies and governments; and

WHEREAS, the people of the State of Maine should always remember those who liberated the Nazi concentration camps, some of whom lost their lives and others of whom have experienced lifelong emotional suffering, as holding an honored place in our history; and

WHEREAS, the people of the State of Maine should continually rededicate themselves to the principle of equal justice for all people, remain eternally vigilant against all tyranny and recognize that bigotry provides a breeding ground for tyranny to flourish; and

WHEREAS, the national community, pursuant to an Act of Congress, will be commemorating the week of May 1 through May 8, 2011 as the Days of Remembrance of the Victims of the Holocaust, including the Day of Remembrance, known as Yom HaShoah, May 1, 2011; and

WHEREAS, it is appropriate for the people of the State of Maine to join in this international commemoration and April 26, 2011 has been designated as the Holocaust and Human Rights Center of Maine's Legislative Awareness Day; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fifth Legislature now assembled in the First Regular Session, on behalf of the people we represent, pause in solemn memory of the victims of the Holocaust and in honor of the survivors, rescuers and liberators, urge everyone to recommit themselves to the lessons of the Holocaust through the Holocaust and Human Rights Center of Maine's Legislative Awareness Day and the international week of commemoration and express our common desire to continually strive to overcome prejudice and inhumanity through education, vigilance and resistance; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Holocaust and Human Rights Center of Maine and the United States Holocaust Memorial Council in Washington, D.C. on behalf of the people of the State of Maine.

**READ.**

The SPEAKER: The Chair recognizes the Representative from Orono, Representative Cain.

Representative **CAIN**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I rise in honor of this recognition today of the Holocaust and Human Rights Center and particularly of Yom Hashoah, the Day of Remembrance. I want to thank and recognize Robert Bernheim, the Executive Director of the Holocaust and Human Rights Center at the University of Maine at Augusta. Because of the work that he does, the volunteers that he has and the support of the center, we are able to remember the past, to take the memory of those who did not survive alive and the stories of the survivors told for generations to come.

I don't have a personal connection necessarily to the Holocaust, but in November of 2009, my husband and I traveled to Israel for eight days. We toured the Kotel, the Old City, the Judean Desert and more. But one day we dedicated to a visit to Yad Vashem, which is Israel's Holocaust memorial museum and remembrance area of the city of Jerusalem. I can't describe to you the feeling that you have when you go there because I have been to the Holocaust Museum in Washington, D.C., I have been to events, I have been to remembrances, but to visit Yad Vashem is something special because its both a story of what happened, a story of what is, and a story of the potential of what can be. That's what I want to share with you today as we recognize Yom Hashoah.

Yad Vashem is a very intense experience. I spent more than four hours inside of a very long and winding museum that is

intentionally built to guide you through the story of the Holocaust. What led to it, what happened during it; the stories of survivors, the stories of the heroes who helped save people who were being persecuted. When you arrive at the end of a very emotional journey through the museum, you come to a balcony where you step outside, you breathe the outside air and you look out at the most glorious vision of Israel, and you don't have to be told what the point of the balcony is, but because you may not have been there, I will tell you.

It is about journeying through what happened in the past and coming to a point where you can see and appreciate the future, see and appreciate the potential and a future full of possibility, not only for the nation of Israel but for the entire world. It is a place I hope you all can visit some day, a place that has touched me deeply, and a place that compels me to rise today as we remember those who were impacted by the Holocaust, those who are the heroes of the Holocaust, and those who work today to continue the stories so that we will not forget. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Alna, Representative Fossel.

Representative **FOSSEL**: Thank you very much, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. We are here today because of the idealism and sacrifice of those who came before us. I am Leslie Truman Fossel, Junior. My father joined the OSS before the war started to be ready. He fought behind enemy lines. I still have his passport entering occupied Europe through Portugal. He died of those injuries when I was very young.

My mother, Virginia Van Brunt, worked for Vogue in Paris before the war. Foreign correspondents' film of the concentration camps was being confiscated at the German border. My mother entered Nazi Germany to get pictures of those concentration camps out. I still have her passport with the swastika on it. She raised five boys alone with great pride. I am one of those boys. Thank you.

The SPEAKER: The Chair recognizes the Representative from China, Representative Cotta.

Representative **COTTA**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I present this Resolution and there are stories and those more eloquent in the Chamber than I. I would like to add though that as time passes and memories dim, that we never forget. This is a blight on the soul of humanity. We must remember, we must learn, we must be better. Thank you.

The SPEAKER: The Chair recognizes the Representative from Brewer, Representative Celli.

Representative **CELLI**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I became a student of the Holocaust at a very early age and our thoughts are always, how can something like this happen? How can such a monstrous society do this? There was no way, I used to think, no way it could ever happen again. Yes, it is happening again. Therefore, that makes it even more important to remember, remember our history and work hard to make sure that this stops now and forever.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Webster.

Representative **WEBSTER**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. It is an honor for me to stand today and celebrate the survival of a friend and constituent, the survival of people who stood against overwhelming oppression and help us to remember what has taken place and what could take place and what does take place on a daily basis, that we witness or deny.

From the Resolution, it says, "WHEREAS, the people of the State of Maine should continually rededicate themselves to the principle of equal justice for all people, remain eternally vigilant against all tyranny and recognize that bigotry provides a breeding ground for tyranny to flourish;..."

Mr. Speaker, I would encourage all of us to visit the Holocaust and Human Rights Center of Maine. It is a monument to memory, but it is more than that. It is a living place to help us remember that what has taken place still takes place.

I quote Henry Friedman, Chairman of the Holocaust Education Center, Washington: "We are all different; because of that, each of us has something different and special to offer and each and every one of us can make a difference by not being indifferent."

Mr. Speaker and Men and Women of the House, if you were to visit and look at the curriculum of the Human Rights Center, you would see that there are many discussions about us and them, what is different, and the fact that we are not. We are all one if we are willing to accept that. Unfortunately, our tendency is to forget.

I quote Richard von Weizsaecker: "There were many ways of not burdening one's conscience, of shunning responsibility, looking away, keeping mum. When the unspeakable truth of the Holocaust then became known at the end of the war, all too many of us claimed that they had not known anything about it or even suspected anything."

We still have in this state, in this world, the seeds of what took place, and it is our responsibility as leaders, each one of us in our own way, to ensure that we do not plant such seeds nor ever let them flourish again.

The SPEAKER: The Chair recognizes the Representative from Falmouth, Representative Nelson.

Representative **NELSON**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise today in honor and in memory of the millions who were murdered in the Holocaust. We honor the survivors of the concentration camps. We honor the liberators, who, 65 years ago, in liberating prisoners from the Nazi concentration camps, witnessed scenes which would haunt them for the rest of their lives. Edward R. Murrow, reporting in a broadcast from Buchenwald concentration camp on April 15, 1945, said "I pray you to believe what I have said about Buchenwald. I have reported what I saw and heard, but only part of it. For most of it I have no words."

We are a country and a people who value freedom. We value equal rights for all. We honor differences in our country – and indeed, I believe that those individual differences and strengths are what make us a great nation. But one of the lessons of the Holocaust is how fragile freedom truly is. The Jews in Europe did not lose their freedom all at once – they lost it little piece by little piece. If you go to the Holocaust Memorial Museum in Washington, D.C., you can see how there were tiny pieces taken away, each one of which was a building of the entire loss of freedom. There were not enough people who had the courage to stop this curtailment of liberties until it was too late.

At the Holocaust Memorial Museum in Washington, D.C., there is a statement, a quotation, attributed to Pastor Martin Niemöller. It is one that I think is worthy to revisit regularly. "First they came for the socialists and I did not speak out – because I was not a socialist. Then they came for the trade unionists and I did not speak out – because I was not a trade unionist. Then they came for the Jews and I did not speak out – because I was not a Jew. Then they came for me – and there was no one left to speak for me." What we do does matter. What we say does matter. Speaking out and defending and protecting freedom does matter and respecting differences does matter.

I was a history major in college. I believe that we can learn much from studying history. I hope that we can all learn the lessons of this darkest of chapters in human history, and that we can build from that lesson a more tolerant and compassionate society for all. Thank you, Mr. Speaker.

Representative **TUTTLE**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I will be supporting the pending motion on the Majority Report and I would like to thank Representative Nass for her support on this issue over the years.

Before I explain the purpose of this bill, I would like to take a moment to give this body a background of the situation of Number One Pond in Sanford. The pond was originally formed in 1791, when a dam built on the Mousam River impounded water at the current site. By 1944, the pond had taken its current form in the size of the pond covering 45.1 acres.

Around the turn of the 19th century, the Mousam River became known as the next location for millworks and operation and spawned Sanford's historical mill heritage. Today Number One Pond is currently used as a public park and wildlife refuge. It is an important community gathering area for a focal point for Sanford and the surrounding community. We host Fourth of July fireworks, fishing derbies, and recreational fishing as well as water-ski tournaments and recreational boating. In the winter, residents of Sanford use the pond for ice fishing and ice skating.

Unfortunately, due to several factors, the pond is in desperate need of cleanup. Laboratory sediment from a core that was collected by members of the Fish and Game Club in 2005 from the pond bottom indicated a very high organic content and heavy metals and PCBs. These cores also indicate approximately three feet deep. As I said before, we have worked with the committee, we have met with the commissioner of DEP, with town officials, and the committee has sent a letter to the Department of Environmental Protection on our concerns. Therefore, this legislation is no longer needed and I would ask you to support the Majority Report, Mr. Speaker.
