² For the purposes of this summary, transfers out are treated as an expenditure/use and are positive amounts, while transfers in are negative amounts.

³ The Governor's proposed EFY 2015 bill, LD 236 would adjust fiscal year 2014-15 funding in the Medical Care - Payments to Providers program by \$7,196,570 and the Low-cost Drugs To Maine's Elderly program by -\$416,736 to reflect a redistribution of funding within the Fund for a Healthy Maine. The Governor's proposed EFY 2015 bill, LD 232 would provide \$29,805 in fiscal year 2014-15 for Maine's portion of a multistate cost-sharing agreement related to the Tobacco Master Settlement Agreement diligent enforcement requirement.
