**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, I wish to speak just very briefly about L.D. 1600. This is an issue we talked about at some detail in the Insurance and Financial Services Committee. The basic background is that if you get certain bad diseases, Lymphoma, Leukemia, etcetera, there are now treatments that are very good with bone marrow transplants. Bone marrow transplants are, needless to say, very complicated. You have to find a good match. It's just like blood transfusions. If you have a blood transfusion that's a poor match you can have very bad allergic reactions that can kill you. Ditto with bone marrow. It turns out that there is a very impressive member of our larger community, Colonel Greg Sanborn, who lives in the western part of the state, who needed a bone marrow transplant and there were simply not enough people available to be tested, hence the family has taken this effort to try to increase the pool of available donors. The background there is that if you need a transplant 30% of people will be able to have a family but the other 70% depend upon some member of the larger community here in the United States who may, by luck, be very close to their specific needs. In the United States, currently, there are roughly 6 million people who have already been tested. This bill will increase that pool so that someone such as Colonel Sanborn could get a bone marrow really very rapidly. He would not have to wait. He might have a transplant from Arizona, from Washington, from Maine. Who knows. The other way it would work in exactly the same way. The bill, as it came out, mandates that insurance companies be required to put up front the cost of \$150 for this test, that the individual agreeing to have their tissue typed in this particular way agrees that there will be a bone marrow donor, and there are

some other specific things that would help enlarge the pool so that individuals such as Colonel Sanborn would be able to get their transplant really very rapidly. This had the majority support of the committee. It does have a price tag of \$48,000 associated with it. On the other hand one can certainly argue that time and lives saved are going to be worth a great deal more than that. I support the Majority Report, Ought to Pass as Amended. Thank you, sir.

WHEREAS, the United States and Taiwan, the Republic of China, share a most important relationship supported by our common values of freedom, democracy, rule of law and a free market economy; and

WHEREAS, Taiwan's President Ma Ying-jeou has worked tirelessly to uphold democratic principles in his nation, ensure the prosperity of Taiwan's 23,000,000 people, promote Taiwan's international standing and further improve relations between the United States and Taiwan; and

WHEREAS, the United States, and in particular the State of Maine, and Taiwan share a historically close relationship, marked by strong bilateral trade, educational and cultural exchange, scientific and technological interests and tourism; and

WHEREAS, Taiwan now is a member of the United States Visa Waiver Program, reflecting the friendship, trust and cooperation shared between our 2 countries and making travel between Taiwan and the United States for business and tourism even more convenient; and

WHEREAS, the United States ranks as Taiwan's 3rd-largest trading partner and Taiwan ranks as the 11th-largest trading partner of the United States with approximately \$85,000,000,000 in 2013 in goods and services traded between the United States and Taiwan, with New England exporting \$1,400,000,000 in goods to Taiwan and Maine exporting \$19,000,000 in goods, including machinery, transportation equipment, computer and electronic products and paper; and

WHEREAS, the Asia-Pacific region is the largest market in the world for American exports and many of Maine's exports went to markets in the Asia-Pacific region, the export of Maine goods supports an estimated 21,000 jobs and recent data indicate that 1,347 companies exported goods from Maine; and

WHEREAS, Taiwan is the 18th-largest trading economy in the world and a member of the Asia-Pacific Economic Cooperation forum, which promotes free trade and economic cooperation throughout the Asia-Pacific region; and

WHEREAS, the United Nations Framework Convention on Climate Change is the world's key instrument to deal with climate change, a concerted global effort to combat the challenges posed by climate change requires that Taiwan also be included in the

work of the convention and Taiwan has expressed a keen interest to participate in the global effort to address climate change; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, reaffirm the friendship between Maine and Taiwan, the Republic of China, and we continue to support efforts to further strengthen Maine-Taiwan trade relations and support Taiwan's participation in international organizations and agreements, including the United Nations Framework Convention on Climate Change; and be it further

Senator **CLEVELAND:** Thank you Mr. President. Women and men of the Senate, this is a fairly significant bill which received a fair amount of attention. It's a unanimous bill which I'm very

pleased we were able to get from the Energy, Utilities and Technology Committee. I wanted to just take a minute to briefly outline the importance of the bill. It does two major things. One is what it does is makes very explicit in the current statute that a process called load shedding, which means that a major industrial manufacturer can go down for a short period of time and that energy is sold onto the grid at periods when there is a high demand and a high price for the fuel. It also makes it explicitly clear that it's the intent and support of the Legislature that the mill in Millinocket, East Millinocket, as well as the power provider, electric hydro power provider, enter into negotiations to find a mutual agreement on how that can be achieved. The second thing that it does is that it amends the current statutes so that it allows that to happen in the current shut down that began on January 23<sup>rd</sup>. Without this legislation that could not have happened. This permits that to happen on this one time basis for the current shut down period and in the future, under mutual agreement, as well. We hope that the parties will come to a mutual agreement. It's very important. Some 250 jobs are at stake here. We have facilitated direct conversations between the parties on these agreements and we certainly hope and encourage them to find an agreement that both parties can live with and that can put those 250 people back to work.
