30 **SUMMARY**

31 This bill authorizes a designee of the Director of the Maine Emergency Management
32 Agency within the Department of Defense, Veterans and Emergency Management to serve
33 as chair of the State Emergency Response Commission. The bill increases from \$50 to
34 \$100 the maximum fee for registering a facility that is required by federal law to report to
35 the commission. It also makes other clerical changes.
