Resolve, to Amend the MaineCare Hospital Readmission Protocol

1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and 3 Whereas, the MaineCare program's hospital readmission protocol does not target the 4 reduction of avoidable readmissions: and 5 Whereas, the protocol penalizes hospitals for readmissions outside of the control of the hospitals and the exceptions to the protocol should reflect clinically appropriate care; 6 7 and 8 Whereas, it is essential that the issues with readmission be addressed as soon as 9 possible due to the financial burden on the hospitals and for the proper care of the patients; 10 and 11 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as 12 13 immediately necessary for the preservation of the public peace, health and safety; now, 14 therefore, be it 15 Sec. 1. Department of Health and Human Services to amend MaineCare 16 rules regarding hospital readmission. Resolved: That, no later than 30 days after the effective date of this resolve, the Department of Health and Human Services shall 17 amend the MaineCare benefits rules regarding exceptions to the 14-day hospital 18 19 readmission protocol to: 20 1. Add to the exceptions readmission of an individual who previously left the hospital 21 against medical advice; 22 2. Add to the exceptions readmission of an individual with substance use disorder 23 whose primary or secondary diagnosis is a result of the individual's substance use disorder; 24 and 25 3. Remove from the exceptions readmission of an individual whose symptoms met the American Society of Addiction Medicine Level 4 Criteria, as defined in the most recent 26 27 edition of the society's treatment criteria for addictive, substance-related and co-occurring 28 conditions. 29 **Emergency clause.** In view of the emergency cited in the preamble, this legislation 30 takes effect when approved. 31 SUMMARY 32 This resolve requires the Department of Health and Human Services to amend its 33 MaineCare benefits rules by excepting from its readmission protocol individuals who 34 previously left the hospital against medical advice or were previously discharged with 35 substance use disorder when the individual's primary or secondary diagnosis is a result of the individual's substance use disorder. It removes from the exceptions to the readmission 36 37 protocol individuals who were previously discharged whose symptoms meet the American Society of Addiction Medicine Level 4 Criteria. 38
