2	Sec. 1. 20-A MRSA §15672, sub-§1-E is enacted to read:
3 4 5	1-E. Clinical mental health provider. "Clinical mental health provider" means a licensed clinical social worker, licensed clinical professional counselor, licensed alcohol and drug counselor or licensed pastoral counselor.
6	Sec. 2. 20-A MRSA §15672, sub-§27-A is enacted to read:
7 8	27-A. School counselor. "School counselor" has the same meaning as in section 4008, subsection 1, paragraph B.

11	A. For the elementary school level and the middle school level:
12 13	(1) Beginning July 1, 2017, the student-to-education technician ratio is 114:1 for the elementary school level and 312:1 for the middle school level;
