#### Be it enacted by the People of the State of Maine as follows:

Sec. 1. PL 2025, c. 2, Pt. J, §1 is amended to read:

Sec. J-1. Transfer from General Fund; Board of Trustees of the Maine Community College System, MCCS Free Community College - Two Enrollment Years Program; fiscal year 2025-26. Notwithstanding any provision of law to the contrary, on or before June 30, 2026, the State Controller shall transfer \$7,300,000 \$6,500,000 from the unappropriated surplus of the General Fund to the MCCS Free Community College - Two Enrollment Years program, Other Special Revenue Funds account within the Board of Trustees of the Maine Community College System to continue support of the 2 years of free community college for all eligible students who meet the conditions in Public Law 2023, chapter 412, Part QQQ, section 3, subsection 2.

Sec. 2. Appropriations and allocations. The following appropriations and allocations are made.
