of Racial, Indigenous and Tribal Populations**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §25012** is enacted to read:

3 **§25012. Confidentiality**

4 Personally identifiable information obtained in furtherance of the commission's duties
5 pursuant to section 25007, subsection 1, paragraph A is confidential, except that the
6 executive director may authorize disclosure of personally identifiable information if the
7 executive director has obtained the consent of the individual to whom the personally
8 identifiable information applies. "Personally identifiable information" includes, but is not
9 limited to, name, address, date of birth, e-mail address, Internet protocol address and any
10 other information that permits the identity of an individual to whom the information applies
11 to be able to be reasonably inferred or known by either direct or indirect means.

12 **SUMMARY**

13 This bill is reported out by the Joint Standing Committee on Judiciary to implement
14 statutory changes recommended by the Right to Know Advisory Committee. The joint
15 standing committee has not taken a position on the substance of this bill. By reporting this
16 bill out, the joint standing committee is not suggesting and does not intend to suggest that
17 it agrees or disagrees with any aspect of this bill; instead, the committee is reporting the
18 bill out for the sole purpose of having a bill printed that can be referred to the committee
19 for an appropriate public hearing and subsequent processing in the normal course. The
20 joint standing committee is taking this action to ensure clarity and transparency in the
21 legislative review of the proposals contained in the bill.

22 The bill adds a new section of law in the Maine Revised Statutes, Title 5 to make
23 confidential personally identifiable information obtained in furtherance of the Permanent
24 Commission on the Status of Racial, Indigenous and Tribal Populations' duties pursuant to
25 Title 5, section 25007, subsection 1, paragraph A to carry out research necessary to
26 determine the status of historically disadvantaged racial, indigenous and tribal populations,
27 except that the executive director may authorize disclosure of personally identifiable
28 information if the executive director has obtained the consent of the individual to whom
29 the personally identifiable information applies.
