**An Act Regarding Access to Telehealth Behavioral Health Services  
during Public Health Emergencies**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 22 MRSA §51** is enacted to read:

3 **§51. Exemption to written informed consent requirement for mental health services**  
4 **and substance use disorder treatment during public health emergency**

5 **1. Definitions.** As used in this section, unless the context otherwise indicates, the  
6 following terms have the following meanings.

7 A. “Licensed facility” means a facility licensed under Title 5, section 20005, subsection  
8 6, paragraph B or Title 34-B, section 1203-A.

9 B. “Public health emergency” means a federal public health emergency declared  
10 pursuant to 42 United States Code, Section 247d or a state public health emergency  
11 declared pursuant to section 802 or Title 37-B, chapter 13, subchapter 2.

12 **2. Written informed consent not required.** The department may not require a  
13 licensed facility to obtain written informed consent from a person receiving mental health  
14 services or substance use disorder treatment from the licensed facility during a public health  
15 emergency. The licensed facility may obtain consent through verbal, electronic or written  
16 means from a person receiving mental health services or substance use disorder treatment  
17 during a public health emergency.

18 **3. Rulemaking.** The department shall adopt rules to implement this section. Rules  
19 adopted pursuant to this subsection are routine technical rules as defined in Title 5, chapter  
20 375, subchapter 2-A.

21 **Sec. 2. Department of Health and Human Services to amend certain**  
22 **licensing rules.** No later than January 1, 2023, the Department of Health and Human  
23 Services shall amend its rules in 14-193 C.M.R. Chapter 6, Licensing of Mental Health  
24 Facilities, and 14-118 C.M.R. Chapter 5, Regulations for Licensing and Certifying of  
25 Substance Abuse Treatment Programs, to allow a facility licensed under the Maine Revised  
26 Statutes, Title 5, section 20005, subsection 6, paragraph B or Title 34-B, section 1203-A to  
27 obtain consent through verbal, electronic or written means from a person during a public  
28 health emergency in accordance with Title 22, section 51. Rules adopted pursuant to this  
29 section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

30 **SUMMARY**

31 This bill provides that the Department of Health and Human Services may not require  
32 a licensed mental health facility or licensed substance use disorder treatment facility to  
33 obtain written informed consent from a client during a federal or state public health  
34 emergency. The licensed facility may instead obtain a client’s consent verbally,  
35 electronically or in writing. The bill directs the Department of Health and Human Services  
36 to, no later than January 1, 2023, amend its rules in 14-193 C.M.R. Chapter 6, Licensing  
37 of Mental Health Facilities, and 14-118 C.M.R. Chapter 5, Regulations for Licensing and  
38 Certifying of Substance Abuse Treatment Programs, to meet the requirements of this  
39 legislation.
