24 **SUMMARY**

25 This bill adds operating under the influence, or OUI, and operating or attempting to
26 operate a watercraft, snowmobile or all-terrain vehicle, or ATV, under the influence to the
27 list of crimes that do not qualify for immunity from arrest, prosecution and certain
28 revocation and termination proceedings when assistance has been requested for a suspected
29 drug-related overdose.
