1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas,** behavioral health services are important for an individual’s overall health
4 and well-being; and

5 **Whereas,** Riverview Psychiatric Center is an integral part of the behavioral health
6 system in the State; and

7 **Whereas,** this legislation provides funding for an immediate increase to wages for
8 employees of the Riverview Psychiatric Center, including the Outpatient Services team;
9 and

10 **Whereas,** this legislation needs to take effect before the expiration of the 90-day
11 period in order for the funding to be provided as soon as possible during this biennium; and

12 **Whereas,** in the judgment of the Legislature, these facts create an emergency within
13 the meaning of the Constitution of Maine and require the following legislation as
14 immediately necessary for the preservation of the public peace, health and safety; now,
15 therefore,

16 **Be it enacted by the People of the State of Maine as follows:**

17 **Sec. 1. Appropriations and allocations.** The following appropriations and
18 allocations are made.

19 **HEALTH AND HUMAN SERVICES, DEPARTMENT OF**

20 **Disproportionate Share - Riverview Psychiatric Center Z220**

21 Initiative: Provides funding for an immediate increase to wages for all employees of the
22 Riverview Psychiatric Center, including the Riverview Psychiatric Center Outpatient
23 Services team, by \$3 per hour.
