### **An Act Establishing a State Calendar for the State of Maine**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §90-H** is enacted to read:

3 **§90-H. State calendar**

4 The Secretary of State or the secretary's designee shall establish a state calendar that  
5 includes important religious days and holidays of residents of the State and citizens of the  
6 United States.

7 **1. Purpose of state calendar; limitation.** The state calendar must be established to  
8 assist state agencies when scheduling events involving members of the public.  
9 Notwithstanding any provision of law to the contrary, inclusion on the state calendar does  
10 not establish a paid holiday for an employee of the State or an employee of a private entity.

11 **2. Administration.** By April 15, 2034, and every 10 years thereafter, the Secretary of  
12 State or the secretary's designee shall review and update the state calendar in consultation  
13 with persons representing the Christian, Muslim and Jewish faith communities, other  
14 religious traditions practicing in the State, immigrants in the State, the Permanent  
15 Commission on the Status of Racial, Indigenous and Tribal Populations, as established in  
16 section 12004-J, subsection 19, and the federally recognized Indian nations, tribes and  
17 bands located in the State.

18 **3. Distribution.** The Secretary of State or the secretary's designee shall distribute no  
19 later than June 1st the state calendar for the next calendar year to all state agencies. The  
20 Secretary of State shall post the calendar on the publicly accessible website of the office of  
21 the Secretary of State.

22 **SUMMARY**

23 This bill is reported out by the Joint Standing Committee on State and Local  
24 Government pursuant to Resolve 2023, chapter 91 for the sole purpose of referring the bill  
25 back to the committee for public hearing and subsequent processing in the normal course  
26 of committee work. The bill directs the Secretary of State to establish a state calendar that  
27 includes important religious days and holidays. The bill is based on legislation proposed  
28 by the office of the Secretary of State in its report, dated January 30, 2024, submitted to the  
29 committee pursuant to Resolve 2023, chapter 91.
