- 1 **Emergency preamble. Whereas,** acts and resolves of the Legislature do not 2 become effective until 90 days after adjournment unless enacted as emergencies; and
- 3 **Whereas,** Maine residents need access to comprehensive, quality health insurance 4 coverage; and
- 5 Whereas, recent court decisions may endanger important consumer protections 6 related to health insurance coverage in the federal Patient Protection and Affordable Care 7 Act, including preexisting condition exclusions, essential health benefits and annual and 8 lifetime limits on the dollar value of benefits; and
- 9 Whereas, the purpose of this legislation is to ensure that those consumer protections
 10 are codified in state law; and
- Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,
- 15 Be it enacted by the People of the State of Maine as follows:

<u>7. Rule of construction.</u> This section may not be construed to prohibit a health plan
 <u>from providing benefits in excess of the essential health benefits described in this section.</u>

8. Rules. Rules adopted pursuant to this section are major substantive rules as
 defined in Title 5, chapter 375, subchapter 2-A.

5 **Emergency clause.** In view of the emergency cited in the preamble, this 6 legislation takes effect when approved.

SUMMARY

8 The purpose of this bill is to ensure that consumer protections related to health 9 insurance coverage included in the federal Patient Protection and Affordable Care Act are 10 codified in state law.

11 In Part A, the bill does the following.

7

12 1. It makes clear that individual and group health plans may not impose any 13 preexisting condition exclusion on an enrollee. The bill does permit a carrier to restrict 14 enrollment in individual health plans to open enrollment and special enrollment periods 15 established in rule.

16 2. It clarifies that carriers offering individual or group health plans may not establish 17 lifetime or annual limits on the dollar value of benefits. The bill specifies that the 18 provision prohibiting annual limits on the dollar value of benefits applies to the dollar 19 value of essential health benefits as determined by the Superintendent of Insurance.

3. It allows children, until they attain 26 years of age, to remain on their parents'
health insurance policy.

4. It changes the maximum rate differential due to age that may be filed by the
 carrier to the rate differential that is permitted under the federal Patient Protection and
 Affordable Care Act.

In Part B, the bill requires that, at a minimum, health plans cover essential health benefits that are substantially similar to those benefits required for health plans subject to the federal Patient Protection and Affordable Care Act as of January 1, 2019. The bill directs the Superintendent of Insurance to define essential health benefits in rule and designates those rules as major substantive and subject to legislative review and approval.
