1	Be it enacted by the People of the State of Maine as follows:
2 3	<b>Sec. 1. 34-A MRSA §3231, sub-§3, ¶A,</b> as repealed and replaced by PL 1999, c. 583, §18, is amended to read:
4 5 6 7	A. The warden may appoint deputy wardens, subject to the Civil Service Law. A deputy warden designated by the warden has the powers, duties, obligations and liabilities of the warden when the warden is absent from the prison location or is unable to perform the duties of the office.
8	Sec. 2. 34-A MRSA §4203, as enacted by PL 2013, c. 508, §7, is amended to read:
9	§4203. <del>Director</del> <u>Warden</u>
10 11 12	1. Chief administrative officer. The chief administrative officer of the facility is ealled the director and the warden of the Maine State Prison, referred to in this subchapter as "the warden." The warden is responsible to the commissioner.
13 14	<b>2. Duties.</b> In addition to other duties set out in this Title, the <u>director warden</u> has the following duties.
15 16	A. The director warden shall exercise proper supervision over the employees, grounds, buildings and equipment at the facility.
17 18	B. The director warden shall supervise and control the prisoners at the facility in accordance with departmental rules.
19 20 21 22	<b>3. Powers.</b> In addition to other powers granted in this Title, the director may appoint one assistant director, subject to the Civil Service Law; the assistant director has the powers, duties, obligations and liabilities of the director when the director is absent or unable to perform the director's duties.
23 24	<b>Sec. 3. 34-A MRSA §4204, sub-§2,</b> as enacted by PL 2013, c. 508, §7, is amended to read:
25 26 27 28	2. Education. The director warden shall maintain suitable courses for academic and career and technical education of the prisoners. The director warden shall maintain necessary equipment and employ suitable qualified instructors as necessary to carry out the objectives of the facility's programs.
29	Sec. 4. 34-A MRSA §4205, as enacted by PL 2015, c. 48, §2, is amended to read:
30	§4205. Employees of the facility
31 32 33	Employees of the facility have the same power as do deputy sheriffs in their respective counties to search for and apprehend escapees from the facility when authorized to do so by the director warden.
34	SUMMARY
35 36 37	This bill designates the warden of the Maine State Prison as the chief administrative officer of the Bolduc Correctional Facility and removes the power to appoint an assistant director.
38 39	The bill also changes the provision of law allowing the warden to appoint deputy wardens to clarify that any deputies appointed by the warden are responsible when the

- warden is absent or unable to perform the duties of the office rather than specifically absent from the Maine State Prison or unable to perform the duties of the office. 1
