1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 32 MRSA §13831, sub-§1**, as amended by PL 2015, c. 211, §1, is further
3 amended to read:

4 **1. Administration of influenza vaccines.** A pharmacist licensed in this State who
5 meets the qualifications and requirements of section 13832 and rules adopted by the board
6 may administer topically or by injection or by inhalation all forms of influenza vaccines,
7 including intranasal influenza vaccines, to a person ~~7~~ 3 years of age or older without a
8 prescription.

9 **Sec. 2. 32 MRSA §13831, sub-§2**, as amended by PL 2013, c. 6, §1, is further
10 amended to read:

11 **2. Administration of other vaccines.** A pharmacist licensed in this State who meets
12 the qualifications and requirements of section 13832 and rules adopted by the board, in
13 addition to influenza vaccines under subsection 1, may administer vaccines licensed by the
14 United States Food and Drug Administration that are recommended by the United States
15 Centers for Disease Control and Prevention Advisory Committee on Immunization
16 Practices, or successor organization, for administration ~~to adults~~ to a person ~~18~~ 3 years of
17 age or older ~~according to a valid prescription when the person has an existing primary care~~
18 ~~physician or other existing relationship with a nurse practitioner or an authorized~~
19 ~~practitioner in this State.~~ A pharmacist may administer vaccines licensed by the United
20 States Food and Drug Administration that are outside the guidelines recommended by the
21 United States Centers for Disease Control and Prevention Advisory Committee on
22 Immunization Practices, or successor organization, to a person ~~18~~ 3 years of age or older
23 ~~according to a valid prescription when the person has an existing primary care physician or~~
24 ~~other existing relationship with a nurse practitioner or an authorized practitioner in this~~

34 **Sec. 3. 32 MRSA §13831, sub-§6** is enacted to read:

35 **6. Administration of vaccines by a pharmacy technician.** A pharmacy technician
36 who holds a registration to administer vaccines issued by the board and is working under
37 the direct supervision of a pharmacist who meets the requirements of section 13832 may
38 administer vaccines under this section.

39 SUMMARY

40 This bill authorizes certain pharmacy technicians to administer vaccines under the
41 supervision of a pharmacist. It changes the age of a person to whom a pharmacist may
42 administer influenza vaccines without a prescription from a person 7 years of age or older

- 1 to a person 3 years of age or older. It authorizes a pharmacist to administer other vaccines
- 2 to a person 3 years of age or older without a prescription.
