2 **Sec. 1. 7 MRSA §606, sub-§1, ¶G**, as amended by PL 2021, c. 673, §4, is further
3 amended to read:

4 G. Beginning January 1, 2022, a pesticide containing chlorpyrifos as an active
5 ingredient; or

6 **Sec. 2. 7 MRSA §606, sub-§1, ¶H**, as enacted by PL 2021, c. 673, §4, is amended
7 to read:

8 H. A pesticide that has been contaminated by perfluoroalkyl and polyfluoroalkyl
9 substances; ~~or~~

10 **Sec. 3. 7 MRSA §606, sub-§1, ¶I**, as enacted by PL 2021, c. 673, §4, is repealed.

22 ~~carbon atom~~ contain at least 2 sequential fully fluorinated carbon atoms, excluding
23 polymers, gases and volatile liquids.

26 A. Beginning January 1, ~~2023~~ 2024, a manufacturer of a product for sale in the State
27 that contains intentionally added PFAS shall submit to the department a written
28 notification that includes:

- 29 (1) A brief description of the product;
- 30 (2) The purpose for which PFAS are used in the product, including in any product
31 components;
- 32 (3) The amount of each of the PFAS, identified by its chemical abstracts service
33 registry number, in the product, reported as an exact quantity determined using
34 commercially available analytical methods or as falling within a range approved
35 for reporting purposes by the department;
- 36 (4) The name and address of the manufacturer, and the name, address and phone
37 number of a contact person for the manufacturer; and
- 38 (5) Any additional information established by the department by rule as necessary
39 to implement the requirements of this section.
