**An Act to Amend the Composition of the Landowners and Land  
Users Relations Advisory Board**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §10157, sub-§1-A**, as amended by PL 2023, c. 405, Pt. A, §28,  
3 is further amended to read:

4 **1-A. Appointment and composition.** The Landowners and Land Users Relations  
5 Advisory Board, referred to in this chapter as "the advisory board" and established by Title  
6 5, section 12004-I, subsection 49-C, consists of the following 18 members:

7 A. ~~Eleven~~ Thirteen voting members, appointed by the Commissioner of Inland  
8 Fisheries and Wildlife:

9 (1) One representative of a statewide small woodland owners association;

10 (2) One representative of a large landowners association;

11 (3) One representative of a statewide farmers organization;

12 (4) Three representatives who hunt, fish or trap;

13 (5) ~~Two~~ Three representatives of outdoor recreationists, including one  
14 representative of an all-terrain vehicle club and one representative of a  
15 nonmotorized recreation industry with a focus on hiking, wildlife watching, biking,  
16 paddling, trail running or other popular outdoor pursuits;

17 (6) Two representatives of environmentalist organizations; ~~and~~

18 (7) One representative of land trust organizations; ~~and~~

19 (8) One representative of an organization managing recreational access to the  
20 North Maine Woods; and

21 B. Five nonvoting members:

22 (1) Two representatives of the Bureau of Warden Service, designated by the  
23 Commissioner of Inland Fisheries and Wildlife;

24 (2) One representative of the Department of Economic and Community  
25 Development, designated by the Commissioner of Economic and Community  
26 Development; and

27 (3) Two representatives of the Department of Agriculture, Conservation and  
28 Forestry, designated by the Commissioner of Agriculture, Conservation and  
29 Forestry.

## 30 SUMMARY

31 This bill is reported out by the Joint Standing Committee on Inland Fisheries and  
32 Wildlife pursuant to Resolve 2025, chapter 82. The bill amends the composition of the  
33 Landowners and Land Users Relations Advisory Board. It increases the number of outdoor  
34 recreationists on the board and adds specificity about the requisite experience of these  
35 members. It also adds a representative of an organization managing recreational access to  
36 the North Maine Woods. Finally, it adds 5 nonvoting members to the board: two  
37 representatives of the Department of Inland Fisheries and Wildlife, Bureau of Warden  
38 Service, one representative of the Department of Economic and Community Development  
39 and 2 representatives of the Department of Agriculture, Conservation and Forestry.
