COMMITTEE AMENDMENT “ ” to H.P. 348, L.D. 529, “An Act Regarding Dams”

Amend the bill by striking out the title and substituting the following:

**'An Act to Establish the Alamoosook Lake Watershed Management District'**

Amend the bill by striking out everything after the title and inserting the following:

**'Emergency preamble. Whereas,** acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

**Whereas,** the current owner of the dam on Alamoosook Lake has petitioned the Department of Environmental Protection for release from ownership of that dam and all property rights necessary to maintain and operate that dam under the Maine Revised Statutes, Title 38, chapter 5, subchapter 1, article 6; and

**Whereas,** pursuant to Title 38, chapter 5, subchapter 1, article 6, a dam owner petitioning for release from ownership is required to consult with the persons listed in Title 38, section 902, subsection 3 to determine if any of those persons wish to assume ownership of the dam; and

**Whereas,** the municipalities in which a dam is located are included in the mandatory consultation procedure under Title 38, section 902, and the consultation period for a municipality is significantly time-limited to 180 days after the date a petition for release from dam ownership is filed by the dam owner, with the opportunity for one extension of 180 days following that initial period; and

**Whereas,** the watershed management district established in this legislation is designed to assume ownership of the dam on Alamoosook Lake and to subsequently maintain and operate that dam, including coordinating water level management, on Alamoosook Lake; and

**COMMITTEE AMENDMENT**

1           **Whereas**, the watershed management district must therefore be established prior to  
2 the expiration of the statutory period in Title 38, section 902 to effectuate and implement  
3 the municipal consultation procedure; and

4           **Whereas**, in the judgment of the Legislature, these facts create an emergency within  
5 the meaning of the Constitution of Maine and require the following legislation as  
6 immediately necessary for the preservation of the public peace, health and safety; now,  
7 therefore,

8           **Be it enacted by the People of the State of Maine as follows:**

9           **Sec. 1. District established; general provisions.** The Alamoosook Lake  
10 Watershed Management District, referred to in this Act as "the district," is established as a  
11 quasi-municipal corporation, incorporated for the purposes described in this Act.

12           **1. Tax exemption.** The property, both real and personal, rights and franchises of the  
13 district held within the boundaries of the Town of Orland are forever exempt from taxation.

14           **2. Liability.** The district is a governmental entity for the purposes of the Maine Tort  
15 Claims Act.

16           **3. Funding eligibility.** The district qualifies for any grants, loans or other funding in  
17 the same manner as a municipality.

18           **4. Watershed district.** The district is eligible for state agency assistance for watershed  
19 districts as provided in the Maine Revised Statutes, Title 38, section 2012.

20           **5. Fiscal year.** The fiscal year of the district is from July 1st to June 30th of each year.

21           **Sec. 2. Governance.** The affairs of the district are managed by a board of trustees,  
22 referred to in this Act as "the board," made up of a combination of trustees appointed by  
23 the municipal officers of the Town of Orland and trustees elected by the owners of the  
24 waterfront properties abutting Alamoosook Lake, referred to in this Act as "the waterfront  
25 property owners."

26           **1. Membership.** Except as otherwise provided in this section, the board consists of 5  
27 trustees as follows:

- 28           A. Three trustees appointed by the municipal officers of the Town of Orland; and  
29           B. Two trustees elected by the waterfront property owners as provided in this section.

30           **2. Nominations for election.** Candidates for election by the waterfront property  
31 owners must be nominated by a lake or pond association representing at least 20% of the  
32 waterfront properties abutting Alamoosook Lake. If no such association is in existence,  
33 the nomination process is as adopted by the board.

34           **3. Conduct of elections.** Upon the establishment of the district, the trustees appointed  
35 by the Town of Orland shall conduct the initial election of the trustees for the waterfront  
36 property owners. The full board shall conduct elections subsequent to the initial election.  
37 The election ballot must list the names of each trustee candidate and whether the candidates  
38 are seeking a full term or to complete the remaining term for a vacant board seat and must  
39 include any write-in candidates. Regardless of the number of actual or beneficial owners  
40 of a waterfront property, a duly authorized representative of each waterfront property  
41 owner may cast one vote for each open board seat listed on the election ballot. The

1 candidate or, in the event that more than one board seat is listed on the election ballot,  
2 candidates who receive the most votes cast must be declared elected.

3 **4. Staggered terms.** The initial terms of the trustees appointed by the Town of Orland  
4 and the trustees for the waterfront property owners must be staggered, as determined by  
5 lot, with as closely as possible equal numbers of trustees serving initial terms of one year,  
6 2 years and 3 years. Subsequently appointed or elected trustees serve 3-year terms.

7 **5. Vacancies.** In the event a board seat occupied by a trustee appointed by the  
8 municipal officers of the Town of Orland under subsection 1, paragraph A becomes vacant,  
9 the municipal officers of the Town of Orland may appoint a replacement trustee to complete  
10 the term for that seat. In the event a board seat occupied by a trustee elected by the  
11 waterfront property owners under this section becomes vacant, a lake or pond association  
12 representing the greatest percentage of waterfront properties abutting Alamoosook Lake  
13 may appoint an interim trustee to that seat until a replacement trustee is elected at the next  
14 regular annual election of trustees. If the association fails to appoint an interim trustee or  
15 if no such association is in existence, the seat remains vacant until the next regular annual  
16 election.

17 **6. Quorum; voting.** A majority of the trustees appointed and elected to the board  
18 must be present at a meeting of the board to constitute a quorum. The board may take an  
19 action requiring a vote only upon the affirmative vote of:

20 A. A majority of the trustees appointed and elected, regardless of the number of  
21 trustees present and voting at a meeting; and

22 B. At least one trustee appointed by the Town of Orland and at least one trustee elected  
23 by the waterfront property owners.

24 **7. Effect of withdrawal.** If the Town of Orland withdraws from the district in  
25 accordance with section 6, the trustees appointed to represent the Town of Orland must be  
26 reduced to one, with that reduction determined by lot, and the number of trustees for the  
27 waterfront property owners must be increased to 4, with the additional seats to be filled in  
28 the same manner as a vacancy for a board seat for the waterfront property owners under  
29 subsection 5.

30 **Sec. 3. Powers; responsibilities.** The district may sue; make contracts; apply for  
31 and accept grant or loan funds; accept gifts; purchase, lease, devise or otherwise acquire,  
32 hold or dispose of real or personal property; disburse money; contract debt; adopt rules;  
33 and do such other acts as necessary to carry out the powers and responsibilities described  
34 in this section.

35 **1. Powers.** The district may:

36 A. Develop operational rules for the management of the district, including developing  
37 topic-specific committees with outside experts when necessary;

38 B. Deliver an annual request to the Town of Orland, subject to voter approval, to fund  
39 a portion of the district's operating and other costs;

40 C. Levy and collect an assessment on the waterfront property owners to fund a portion  
41 of the district's operating and other costs and establish a lien on a waterfront property  
42 in the event the waterfront property owner does not pay in full the assessed amount by  
43 the date the payment is due; and

1 D. Enter into cooperative agreements with other watershed management districts,  
2 municipalities and entities for the purposes of planning, operations and maintenance  
3 and watershed improvement and for other purposes determined by the district.

4 **2. Responsibilities.** The district is responsible for:

5 A. Acquiring ownership of, owning, maintaining and operating the dam, the land under  
6 the dam, the equipment and other personal property necessary to maintain and operate  
7 the dam and flowage and access rights associated with the dam on Alamoosook Lake,  
8 including general operations, managing water levels and flow, managing inspections,  
9 planning for upgrades or repairs and other dam management activities;

10 B. Preparing an annual operating and capital budget as described in this Act;

11 C. Holding at least one public meeting to discuss the district's annual proposed budget  
12 as described in this Act, which must be held at least 2 weeks prior to a vote by the  
13 legislative body of the Town of Orland on an article requesting the annual municipal  
14 contribution;

15 D. Conducting elections of trustees for the waterfront property owners;

16 E. Electing trustees as officers of the board;

17 F. Administering the affairs of the district, including, but not limited to, financial  
18 management activities, record keeping, public communications and contract  
19 management; and

20 G. Proactively assessing watershed improvements and developing policies and  
21 practices to enhance the Alamoosook Lake watershed, including seeking funding  
22 opportunities for watershed improvements such as fish passage improvements,  
23 courtesy boat inspections and water quality and invasive species monitoring activities.

24 **Sec. 4. Annual operating and capital budget.** The board shall develop an annual  
25 operating budget, which must include proposed appropriations into reserves for any capital  
26 expenditure purpose or capital expenditure appropriations as described in this section.

27 **1. Budget hearing; board approval.** Prior to January 15th of each year and with  
28 sufficient time to incorporate any public input, the board shall hold a public budget hearing.  
29 At the budget hearing, the board shall explain the proposed budget, and residents of the  
30 Town of Orland and the waterfront property owners must be given an opportunity to be  
31 heard. At the budget hearing, only those items concerning the expenses necessary to  
32 operate the district, appropriations for a reserve fund and capital expenditure are subject to  
33 public input. A proposed annual budget may not be finalized and submitted for  
34 appropriation to the Town of Orland unless approved by the board as follows:

35 A. A proposed annual budget of less than \$100,000 may be finalized and approved  
36 only by the affirmative vote of a majority of the trustees appointed and elected to the  
37 board, regardless of the number of trustees present and voting, if at least one such  
38 affirmative vote is provided by a trustee appointed by the Town of Orland under section  
39 2, subsection 1, paragraph A and at least one such affirmative vote is provided by a  
40 trustee elected by the waterfront property owners under section 2; and

41 B. A proposed annual budget of \$100,000 or more may be finalized and approved only  
42 by the affirmative vote of 2/3 of the trustees appointed and elected to the board,  
43 regardless of the number of trustees present and voting.

1 The \$100,000 budget figure in paragraphs A and B must be adjusted annually for  
2 cumulative price inflation since December 31, 2024, based on the change in the Consumer  
3 Price Index for All Urban Consumers, Annual City Average, for the Northeast Region, as  
4 published by the United States Department of Labor, Bureau of Labor Statistics or, if that  
5 statistic is no longer published or available, by an alternative measure of price inflation as  
6 determined by the board.

7 The board shall ensure that the final annual budget is finalized for approval no later than  
8 January 15th.

9 **2. Budget approval process.** Upon finalization of the annual budget by the board,  
10 the Town of Orland, for consideration at a town meeting, shall incorporate a warrant article  
11 as described in this section to allow the voters of the town to approve or reject the budget.  
12 During the initial funding period for the district, any requests for appropriation from the  
13 district may include only those amounts in excess of the amounts already appropriated by  
14 the Town of Orland at the time the district was formed.

15 The district shall provide information in print or electronic format regarding the annual  
16 budget and appropriation request to the Town of Orland prior to and at the town's annual  
17 town meeting, which must include the total amounts proposed by the district for each cost  
18 center summary budget category, the amount approved by the board after public input  
19 gathered at the budget hearing and a summary of the total authorized expenditures for the  
20 district.

21 The board shall prepare the warrant article for this purpose and shall deliver the article to  
22 the municipal clerk of the Town of Orland no later than February 1st of each year. The  
23 warrant article must be in substantially the following form:

24 "Do you favor the Town of Orland raising and appropriating from property  
25 tax \$ (insert amount) to pay the Town of Orland's municipal contribution  
26 to the Alamoosook Lake Watershed Management District?"

27 **3. Failure to approve municipal contribution.** The Town of Orland's vote on the  
28 warrant article determines its obligation to pay the municipal contribution for the budgeted  
29 fiscal year. If the Town of Orland fails to appropriate funds for its municipal contribution,  
30 the amount not appropriated must be included in the assessment on the waterfront property  
31 owners.

32 **Sec. 5. Contributions; assessments.** The annual budget for the district as  
33 described in this Act must reflect all expected expenditures and additions to capital  
34 reserves, net of any grants, donations, loans or other anticipated sources of funds. To the  
35 extent that additional funds are required to balance the budget, referred to in this Act as  
36 "the aggregate funds required," the Town of Orland and the waterfront property owners  
37 shall provide funding for the aggregate funds required as follows.

38 **1. Municipal contributions.** If approved by the voters of the Town of Orland pursuant  
39 to section 4, the Town of Orland shall provide funding for 50% of the aggregate funds  
40 required, which must be determined by the board in the manner described in section 4. The  
41 Town of Orland's appropriated municipal contribution must be paid to the district prior to  
42 August 1st of each year.

43 **2. Waterfront property owners.** The waterfront property owners shall provide  
44 funding for the aggregate funds required that are not provided pursuant to subsection 1,

1 which must be determined by the board as described in section 4. If the Town of Orland  
2 fails to appropriate funds for its municipal contribution, the amount not appropriated must  
3 be included in the assessment on the waterfront property owners.

4 A. Each waterfront property owner shall pay an assessment proportionate to the  
5 amount of shoreline frontage along Alamoosook Lake on that waterfront property  
6 owner's lot or parcel. For the purposes of calculating this assessment, the shoreline  
7 frontage is the amount used for the purposes of property tax assessment, up to a  
8 maximum of 300 feet of shoreline frontage, and a lot or parcel with more than 300 feet  
9 of shoreline frontage must be deemed to have only 300 feet of shoreline frontage.

10 B. The district shall mail an invoice for the assessment amount due to each waterfront  
11 property owner on a schedule and with a specified payment due date as determined by  
12 the board. Failure to pay the assessment amount by the specified payment due date  
13 incurs interest as determined by the board in a manner consistent with the Maine  
14 Revised Statutes, Title 36, section 505. The district may place a lien on the lot or parcel  
15 of a waterfront property owner that fails to pay the assessment amount by the specified  
16 payment due date.

17 **Sec. 6. Withdrawal; dissolution.** The legislative body of the Town of Orland may  
18 by majority vote elect to withdraw from the district, and the board must approve the  
19 withdrawal, subject to conditions and requirements reasonably necessary for the continued  
20 operation of the district as may be directed by the board. If the Town of Orland fails to  
21 appropriate funds for its municipal contribution in accordance with the requirements of this  
22 Act for 2 consecutive years, it is considered to have withdrawn from the district, subject to  
23 conditions and requirements reasonably necessary for the continued operation of the district  
24 as may be directed by the board. The district may be dissolved upon the disposition of all  
25 of its assets and settlement of any liabilities and by an affirmative vote on dissolution by a  
26 majority of the trustees of the board.

27 **Sec. 7. Authorized activities prior to referendum.** Notwithstanding the  
28 referendum requirement of section 8, the municipal officers of the Town of Orland shall  
29 prepare an estimated budget for the district for its first year of operation and shall determine  
30 the aggregate funds required for that year. The municipal officers shall determine the  
31 required municipal contribution for the Town of Orland, which must represent 50% of those  
32 aggregate funds required. The municipal contribution amount determined pursuant to this  
33 section must be used for the purposes of the referendum required in section 8.

34 **Sec. 8. Emergency clause; referendum; effective date.** In view of the  
35 emergency cited in the preamble, this Act takes effect when approved only for the purposes  
36 of allowing the municipal officers of the Town of Orland to prepare an estimated budget  
37 and determine the aggregate funds required and required municipal contribution pursuant  
38 to section 7 and for permitting the Act's submission to the legal voters of the Town of  
39 Orland at a referendum called for that purpose and held after June 1, 2025 but within 2  
40 years after the effective date of this Act. The referendum must be called by the municipal  
41 officers of the Town of Orland and must be held at the regular voting places. The  
42 referendum must be called, advertised and conducted according to the law relating to  
43 municipal elections. For the purpose of registration of voters, the registrar of voters must  
44 be in session the regular workday preceding the referendum. The subject matter of this Act  
45 must be reduced to a question in substantially the following form:

1 "Do you favor the establishment of and the Town of Orland's participation  
2 in the Alamoosook Lake Watershed Management District and the  
3 appropriation of \$ (insert amount) to provide the Town of Orland's share  
4 of the estimated budget for the first year of operation of the Alamoosook  
5 Lake Watershed Management District?"

6 The voters shall indicate by a cross or check mark placed against the word "Yes" or  
7 "No" their opinion of the same.

8 The results must be declared by the municipal officers of the Town of Orland and due  
9 certificate of the results filed by the clerk with the Secretary of State.

10 This Act takes effect for all other purposes immediately upon its approval by a majority  
11 of the legal voters of the Town of Orland voting at the referendum. Failure to achieve the  
12 necessary approval in any referendum does not prohibit subsequent referenda consistent  
13 with this section as long as the referenda are held within 2 years after the effective date of  
14 this Act.'

15 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section  
16 number to read consecutively.

17 **SUMMARY**

18 This amendment replaces the bill, which is a concept draft, and changes the title.  
19 Subject to approval by the voters of the Town of Orland at referendum, the amendment  
20 establishes the Alamoosook Lake Watershed Management District for the purposes of  
21 acquiring ownership of, owning, maintaining and operating the dam on Alamoosook Lake  
22 and engaging in other related activities. The costs of operations of the Alamoosook Lake  
23 Watershed Management District are to be funded as follows: 50% of the costs by municipal  
24 contribution from the Town of Orland, if approved by its voters; and the remainder of the  
25 costs by assessments on the owners of waterfront property abutting Alamoosook Lake as  
26 determined based on the shoreline frontage of each waterfront property owner.
