COMMITTEE AMENDMENT “ ” to H.P. 365, L.D. 546, “Resolve, to Require the Preparation of Preapproved Building Types”

Amend the resolve in section 1 in the first to 3rd lines (page 1, lines 1 to 3 in L.D.) by striking out the following: "Department of Agriculture, Conservation and Forestry, Bureau of Resource Information and Land Use Planning" and inserting the following: 'Maine Office of Community Affairs'

Amend the resolve in section 1 in the 3rd line (page 1, line 3 in L.D.) by striking out the following: "bureau" and inserting the following: 'office'

Amend the resolve in section 1 in the first indented paragraph (page 1, line 7 in L.D.) by striking out the following: "bureau" and inserting the following: 'office'

Amend the resolve in section 1 in subsection 3 in the 2nd line (page 1, line 30 in L.D.) by inserting after the following: "to," the following: 'in-person focus groups,'

Amend the resolve in section 2 in the first and 2nd lines (page 1, lines 42 and 43 in L.D.) by striking out the following: "**Department of Agriculture, Conservation and Forestry, Bureau of Resource Information and Land Use Planning**" and inserting the following: '**Maine Office of Community Affairs**'

Amend the resolve in section 2 in the 3rd line (page 1, line 44 in L.D.) by striking out the following: "bureau" and inserting the following: 'office'

Amend the resolve in section 2 in the last line (page 2, line 10 in L.D.) by striking out the following: "First Regular Session of the 133rd Legislature" and inserting the following: '133rd Legislature in 2027'

Amend the resolve by inserting after section 2 the following:

**'Sec. 3. Appropriations and allocations. Resolved:** That the following appropriations and allocations are made.

**Maine Office of Community Affairs Z396**

Initiative: Provides one-time funding to contract with a consultant to establish a set of building types that municipalities may adopt as preapproved building types in order to reduce the cost and time associated with processing building permit applications.

### **SUMMARY**

This amendment, which is the unanimous report of the committee, moves responsibility for the provisions of the resolve from the Department of Agriculture, Conservation and Forestry, Bureau of Resource Information and Land Use Planning to the Maine Office of Community Affairs. It also adds a requirement for in-person focus groups as part of the process for public engagement. The amendment also adds an appropriations and allocations section.
