17 18 19	Whereas, the lack of an elver exporter's license provides opportunity for the transport of elvers that may have been caught in violation of state law, and the high value of elvers provides an incentive to engage in this practice; and
20 21 22	Whereas, the requirement that elver exporters hold an elver exporter's license will improve the ability of the Department of Marine Resources to better enforce all elver fishing laws; and

In view of the emergency cited in the preamble, this 5 legislation takes effect when approved.' **SUMMARY** 6 7 This amendment eliminates the requirement that the Department of Marine Resources issue an elver dealer transaction card to the holder of an elver exporter's license and 8 9 instead provides that the department must issue an electronic recording device that records the information on an elver dealer transaction card.
