## **COMMITTEE AMENDMENT**

### **SUMMARY**

2 The bill directs the creation of resentencing units in the Office of the Attorney General 3 as well as in each district attorney's office. This amendment instead directs the establishment of just one resentencing unit in the Office of the Attorney General to review 4 and make recommendations to the Attorney General about cases prosecuted by district 5 6 attorneys' offices as well as the Office of the Attorney General. Because the resentencing 7 unit will be located within the Office of the Attorney General, this amendment reallocates the statutory language to the statutes governing the Attorney General and corrects cross-8 9 references. The amendment also adds an appropriations and allocations section. 10 FISCAL NOTE REQUIRED
