SUMMARY 1 2 This amendment clarifies that the Maine Health Care Education Training and Medical 3 Residency Fund may be used for clinical preceptorships and clinical rotations for all health profession students in rural and underserved communities. It also provides that the fund 4 may be used to expand rural residency positions and rotations for medical school graduates 5 in the State, instead of medical students as in the bill.
