2 3	This amendment, which is the majority report of the committee, makes the following changes to the bill.

It removes the provisions in the bill that allow a voter to apply for status as an ongoing absentee voter in the same manner as a voter requesting an absentee ballot or at any time the voter is able to register to vote or update the voter's voter registration. It maintains the current provision of law that requires a voter to apply using procedures designated by the Secretary of State.
9 10 11	2. It restores the requirement that the clerk or the Secretary of State terminate a voter's ongoing absentee voter status upon the designation of the voter's status as inactive in the central voter registration system.
12 13	3. It removes the provisions regarding the absentee ballot tracking and notification system.
14	4. It changes the effective date from July 1, 2025 to December 31, 2025.
