Amend the bill in section 1 in c. 1083 in §4100-D in subsection 3 in the first line (page 1, line 19 in L.D.) by striking out the following: "November 1, 2025" and inserting the following: 'July 1, 2026'

Amend the bill in section 1 in c. 1083 in §4100-D in subsection 3 in the first line (page 1, line 19 in L.D.) by striking out the following: "4" and inserting the following: '2'

Amend the bill in section 1 in c. 1083 in §4100-D in subsection 3 in paragraph B in the first line (page 1, line 24 in L.D.) by inserting after the following: "the" the following: 'Maine'

Amend the bill in section 1 in c. 1083 in §4100-D in subsection 3 in paragraph B in the first line (page 1, line 24 in L.D.) by inserting after the following: "Cabinet" the following: 'Early Childhood Advisory Council'

Amend the bill in section 2 in the 4th line (page 4, line 9 in L.D.) by striking out the following: "4" and inserting the following: '2'

**SUMMARY**

This amendment, which is the majority report of the committee, changes the number of early childhood learning and development resource hubs to be established from 4 to 2, delays the date of establishment from November 1, 2025 to July 1, 2026 and changes the starting date of the Department of Health and Human Services' annual report to the Legislature to January 1, 2028. It clarifies that the department must seek input from the Maine Children's Cabinet Early Childhood Advisory Council rather than the Children's Cabinet in establishing the resource hubs. It changes the date that the department reports its plans for establishing the resource hubs to the Joint Standing Committee on Health and
