Project rating criteria may include the potential extent of public safety; emergency management and infrastructure resiliency benefits; future climate conditions; ability to leverage federal and other funding; and community, economic and environmental benefits. Funds must be used for public infrastructure projects and may be used for some types of private infrastructure. For the purposes of this Part, "working waterfront infrastructure" means wharves and piers that support commercial fisheries and aquaculture businesses in this State. Projects must demonstrate increased resilience to future storm and flooding impacts. Project types may include working waterfront infrastructure, culverts, storm 18 water systems, water system upgrades and other interventions that support infrastructure 19 repair and reducing or eliminating climate impacts, especially coastal and inland flooding. 20 21 Funds may be used to support project planning and federal matching funds. Funds will be used for public infrastructure projects with project exemptions available for some types of 22 23 private infrastructure upgrades with significant community benefits, such as working 24 waterfronts. Business Recovery and Resilience Fund program established.** The Business Recovery and Resilience Fund program is established in the Department of Economic and Community Development to provide grant opportunities for businesses and organizations, including nonprofit organizations, affected by severe weather-related events.

Sec. B-2. Transfer from unappropriated surplus of General Fund; Business 36 Recovery and Resilience Fund program, Other Special Revenue Funds 37 38 **account.** Notwithstanding any provision of law to the contrary, the State Controller shall transfer \$10,000,000 by the close of the fiscal year ending June 30, 2024 from the 39 unappropriated surplus of the General Fund to the Department of Economic and 40 Community Development, Business Recovery and Resilience Fund program, Other Special 41 Revenue Funds account for economic recovery and resilience grants to businesses and 42 43 nonprofit organizations within areas that were impacted in the December 18, 2023 storm,

The award criteria 8 must require that recipients demonstrate that the damage or project costs are not covered 9 10 by Federal Emergency Management Agency disaster funds, or other insurance, and that the recipient has exhausted all emergency relief funding programs currently available. The 11 12 administration of the funds must include sufficient documentation and record-keeping requirements to provide assurance that funds have been awarded consistent with the 13 program guidelines and used for the intended purpose. 14

SUMMARY

33 This amendment, which is one of 2 minority reports of the committee, replaces the bill. As in the bill, the amendment provides \$50,000,000 to the Department of Transportation, 34 35 Infrastructure Adaptation Fund, Other Special Revenue Funds account for municipal, state 36 or regionally significant infrastructure adaptation, repair and improvements that support 37 public safety, protection of essential community assets, regional economic needs and long-38 term infrastructure resiliency. This amendment provides the funding through a transfer 39 from the unappropriated surplus of the General Fund instead of from the Maine Budget 40 Stabilization Fund. This amendment also creates the Business Recovery and Resilience 41 Fund program within the Department of Economic and Community Development and transfers \$10,000,000 from the unappropriated surplus of the General Fund for economic 42
