HOUSE AMENDMENT “ ” to COMMITTEE AMENDMENT “A” to S.P. 577, L.D. 1733, “An Act To Provide Allocations for the Distribution of State Fiscal Recovery Funds”

Amend the amendment by inserting after Part MM the following:

PART NN

Sec. NN-1. Department of Corrections hazard duty stipend. The Department of Corrections, and any entity providing services on behalf of the department, shall compensate employees who are eligible for a hazard duty stipend related to the COVID-19 pandemic under a signed agreement between a labor union representing those employees and the Department of Corrections. The stipend must be paid to those employees retroactively from the time the previous hazard duty stipend was removed to the termination of the state of civil emergency due to the COVID-19 pandemic.

Sec. NN-2. Department of Health and Human Services hazard duty stipend. The Department of Health and Human Services, and any entity providing services on behalf of the department, shall compensate employees employed at the Dorothea Dix Psychiatric Center and the Riverview Psychiatric Center who are eligible for a hazard duty stipend related to the COVID-19 pandemic under a signed agreement between a labor union representing those employees and the Department of Health and Human Services. The stipend must be paid to those employees retroactively from the time the previous hazard duty stipend was removed to the termination of the state of civil emergency due to the COVID-19 pandemic.

Sec. NN-3. Appropriations and allocations. The following appropriations and allocations are made.

SUMMARY

This amendment requires the Department of Corrections and the Department of Health and Human Services to use federal funding to pay eligible employees a hazard duty stipend related to the COVID-19 pandemic.

It specifies that the Department of Corrections employees who are eligible for the hazard duty stipend are those employees who are eligible under a signed agreement between a labor union representing those employees and the Department of Corrections. It specifies that the Department of Health and Human Services employees who are eligible for the hazard duty stipend are those employees who are employed at the Dorothea Dix Psychiatric Center and the Riverview Psychiatric Center who are eligible under a signed agreement between a labor union representing those employees and the Department of Health and Human Services.

The stipend must be paid retroactively from when the previous hazard duty stipend ended to the termination of the state of civil emergency due to the COVID-19 pandemic.
