1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 32 MRSA §4204, as repealed and replaced by PL 2013, c. 264, §14, is amended to read:
4	§4204. Penalties
5 6 7 8 9	1. Penalty. A person who fails to be licensed as required by this chapter, violates the sterilization, sanitation or safety standards adopted by the Department of Health and Human Services Professional and Financial Regulation under section 4251 or performs tattooing on a minor commits a civil violation for which a fine of not less than \$500 nor more than \$1,000 may be adjudged for each violation.
10	2. Enforcement. A person who fails to pay a penalty imposed pursuant to this chapter:
11	A. May be referred to the Attorney General for appropriate enforcement action; and
12 13 14	B. In addition to all fines and penalties imposed pursuant to this chapter, is liable for any interest, costs and fees incurred by the Department of Health and Human Services Professional and Financial Regulation, including attorney's fees.

Such licenses are issued for a term of one year and may be renewed annually. The fee for an initial license or a renewal license may not exceed \$250. All fees collected by the department pursuant to this section must be deposited in a special revenue account dedicated to a health inspection program.

35 36 37	No person shall place a tattoo upon the body of another human being without first obtaining a license from the Department of Health and Human Services Professional and Financial Regulation.
