Resolved: That the Department of Health and Human Services shall amend its rules in Chapter 101: MaineCare Benefits Manual, Chapter III, Section 67, Principles of Reimbursement for Nursing Facilities, to allocate a supplemental payment of \$1,304,425 from the General Fund with matching funds from the Federal Expenditures Fund, in both fiscal years 2021-22 and 2022-23, to the Maine Veterans' Homes to offset budget shortfalls. The department, in its rulemaking, shall determine a methodology that allocates funding in a manner that addresses Maine Veterans' Homes shortfalls on a basis proportional to the shortfall of each Maine Veterans' Homes nursing facility. Rules adopted pursuant to this section are routine technical rules as defined in the Maine Revised Statutes, Title 5, chapter 375, subchapter 2-A.			

- **Sec. 2. Federal funding. Resolved:** That the Department of Health and Human Services may reduce the funds appropriated and allocated to Maine Veterans' Homes in this resolve by only the equivalent amount of funds derived from the federal American Rescue Plan Act of 2021 that are eligible for the purposes of this resolve.
- **Sec. 3. Appropriations and allocations. Resolved:** That the following appropriations and allocations are made.

SUMMARY

This amendment provides one-time appropriations to Maine Veterans' Homes for fiscal years 2021-22 and 2022-23. It allows the Department of Health and Human Services to reduce the funding only if federal funding is available for this purpose and only by that amount. The amendment replaces the appropriations and allocations section and adds an emergency preamble and emergency clause.
